



INTRODUCTION

I am employed by the State of Tennessee as an Assistant District Attorney in the 17th Judicial District. My primary office assignment is in the Marshall County office, but I am available to be assigned to any of the four counties in the 17th Judicial District. I prosecute criminal cases in both general sessions and circuit courts including jury trials.

In 1985, while in high school, I obtained my first employment experience at Red Foods in Columbia, Tennessee, as a courtesy clerk. Also in 1985, I worked at Pizza Hut in Columbia as a cook/busboy. After graduation from high school in 1986, I enlisted in the United States Marine Corps.

In 1990 I returned to Columbia after completing my military service. From 1990 through 1991, I worked part time for Goody's Family Clothing as a salesclerk and at Newspaper Printing Corporation as a deliverer of the Nashville Banner and Tennessean newspapers. From 1991 to 1993 I served at the Columbia Police Department where I served on the Honor Guard in addition to regular patrol duties.

I worked as a security officer at Williamson Medical Center in Franklin, Tennessee, in 1994.

I also joined the Williamson County Sheriff's Department in Franklin as a correctional officer in 1994. I worked at Foodmax Grocery Store in Columbia as an Assistant Produce Manager until early 1995.

From 1995 until 2001 I worked at the Spring Hill Police Department in Spring Hill, Tennessee, as a patrol officer, patrol sergeant, traffic crash reconstructionist, and detective. In 2001-2002 I served as a State Trooper with the Florida Highway Patrol. In 2003, I returned to Tennessee and worked as a police officer with the Vanderbilt University Police Department in Nashville, Tennessee. I returned to the Spring Hill Police Department later in 2003 and remained until 2005. I served as a patrol officer, patrol sergeant, training officer, firearms instructor, and was ultimately promoted to Assistant Chief of Police.

Upon completing my undergraduate degree in 2005, I gained employment as a full-time teacher at Zion Christian Academy in Columbia. I taught middle and high school math and science classes. I also served as the varsity baseball coach and assistant football coach for the middle and high school football teams. In addition, I was the faculty sponsor for the middle and high school Student Council. From 2016 until 2022 I officiated middle and high school baseball and football games as a TSSAA official.

In 2013 I opened my own law practice, Brooks Law & Mediation, in Spring Hill, Tennessee. I represented clients in criminal, civil, family and wills/estate matters. I became listed as a Rule 31 mediator in civil and family matters including special training in domestic violence issues. I provided mediation services to retained parties through my law practice as well as to parties through the Mediation Center (a non-profit organization) in Columbia at a reduced cost. In 2014 I was an adjunct instructor for Bethel University teaching Conflict in the K-12 System in the University's Master of Arts in Conflict Resolution program. In 2016 I established a partnership with another attorney, as managing partner, to form Miller & Brooks, PLLC, in Columbia. Our firm provided the same services to clients that I provided in my solo practitioner firm.

I was admitted to practice in the United States District Court of Middle Tennessee in 2016. I returned to my solo practice in 2017. Later in 2017 I joined the Public Defender's Office of the 22nd Judicial District as an Assistant District Public Defender. I joined the District Attorney's Office of the 17th Judicial District as an Assistant District Attorney in 2018 where I continue to be employed. I occasionally drive for Uber.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

My present law practice is 100% criminal prosecution.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

During my experience with the Public Defender's Office and the District Attorney's Office, my practice has been comprised entirely of criminal matters. During my private practice experience, I represented clients in criminal, civil, family, wills/estates, and mediation services in city, state, and federal courts. I have represented clients in all four of the counties of the 22nd

Judicial District as well as Davidson, Hickman, Marshall, Rutherford, and Williamson counties. I have also represented clients in the city courts of Lewisburg, Smyrna, and Fairview. I have prosecuted matters in Bedford, Marshall, Moore, Lincoln, and Lawrence counties.

I have represented over 650 indigent clients by appointment in state court ranging from class C misdemeanors to class A felonies. I have also represented clients in juvenile court in matters concerning parental rights, juvenile delinquency, guardian ad litem, and one matter concerning a transfer to adult court. I have represented clients in bench trials for both civil and criminal matters. I have represented clients as the lead defense attorney in six (6) jury trials. I have represented the State of Tennessee as lead or second chair prosecutor in thirteen (13) jury trials. I have represented clients before the Tennessee Court of Criminal Appeals and the Tennessee Supreme Court.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

I have represented many clients at the Tennessee Court of Criminal Appeals and one client on a matter that was before the Tennessee Supreme Court (on application for permission to appeal only). In that matter, I represented a client on a matter that began in the Maury County General Sessions Court, Part II (*State v. Thomas Braden*). After indictment, I filed a motion to suppress evidence based on a deficient search warrant. The trial court granted the motion to suppress and dismissed the matter. The State appealed the dismissal to the Tennessee Court of Criminal Appeals where the trial court decision was affirmed. The State filed for permission to appeal to the Tennessee Supreme Court where the matter was held pending until a decision by the Tennessee Supreme Court was released in *State v. Tuttle* which would ultimately change the standard by which search warrants were evaluated in court. After the *Tuttle* decision was released, Mr. Braden's matter was returned to the Tennessee Court of Criminal Appeals for evaluation under the new *Tuttle* standard of totality of the circumstances. The Tennessee Court of Criminal Appeals examined Mr. Braden's matter under the new standard and, again, affirmed the trial court's decision. The State sought a second review at the Tennessee Supreme Court but the application was denied.

9. Describe any other legal experience, not stated above, that you would like to bring to the attention of the Commission.

I have experience in the court system from every perspective except as a judge or clerk. I have prosecuted criminal matters in both bench and jury trials as an Assistant District Attorney. I have defended criminal matters in both bench and jury trials as an Assistant Public Defender and as a privately retained attorney. I have represented clients in civil matters and parties in family law and estate matters in the Chancery Courts of Maury and Williamson counties. I have appeared as a witness in both civil and criminal matters that were being tried in front of a jury.

I applied for appointment to Circuit Court Judge, Division III, of the 22nd Judicial District in 2018. I was one of the three candidates submitted to Governor Haslam by the interview board. I applied for appointment to Circuit Court Judge, Division V, of the 22nd Judicial District in 2023. I was one of the three candidates submitted to Governor Lee by the interview board.

I have currently lived continuously in Tennessee for twenty (21) years. I have been a lifelong resident of Tennessee other than four (4) years of military service and two (2) years I lived in Florida.

14. How long have you lived continuously in the county where you are now living?

I have currently lived continuously in Maury County for twenty (21) years. I have been a lifelong resident of Maury County except for two (2) years in Giles County, four (4) years of

military service, and two (2) years I lived in Florida.

I served on active duty in the United States Marine Corps from 1986 to 1990. During my service, I was promoted three (3) times. I received an Honorable Discharge in 1990 as a Corporal (E4). I received a Good Conduct medal and a Sea Service Deployment ribbon with one (1) star. I was a sixth (6th) award Rifle Expert and a fifth (5th) award Pistol Expert. My primary military occupation specialty was Amphibious Assault Vehicle Repair. I also held a secondary military occupation specialty as a Marksmanship Coach where I was responsible for instructing both enlisted and commissioned personnel in basic marksmanship skills.

I have had one (1) formal complaint filed against me. The complaint was investigated and

dismissed. I have had a total of four (4) Consumer Assistance Program inquiries made against me, three (3) as a private attorney and one (1) as an Assistant District Attorney. All of the inquiries were appropriately responded to, if required, and ultimately closed. The Board of Professional Responsibility does not consider these inquiries to be "formal complaints".

Maury Chancery Court No. 92-029: Lee Edward Brooks v. Alicia Gail Brooks. I was the plaintiff in a divorce action. The final decree of divorce was entered on March 20, 1992.

Maury Circuit Court No. 5715: Lockridge & Lockridge v. Getner, City of Columbia, Columbia Police Department, Lee Edward Brooks. I was sued for damages arising out of an automobile crash that I was involved in while on duty with the Columbia Police Department. Judgment was entered in favor of the defendants on October 30, 1996.

Maury Circuit Court No. 9242: Bernard Oden v. George, City of Spring Hill, Lee Brooks. I was sued for damages incurred when Bernard Oden Sr. was held in the Maury County Jail for 17 days in error. The Maury County Grand Jury issued an indictment for "Bernard Oden" and Bernard Oden Sr. was arrested on the indictment. The indictment should have been issued for Bernard Oden Jr. I was dismissed from the suit. The entire suit was voluntarily dismissed on December 15, 2000.

I ran for election for Circuit Court Judge, Division III, in the 22nd Judicial District in 2022.

ESSAYS/PERSONAL STATEMENTS

28. What are your reasons for seeking this position? *(150 words or less)*

I am seeking this appointment to be a circuit court judge for the 22nd Judicial District because it is an opportunity to continue service to my community and achieve the pinnacle of my career. I have spent virtually all of my adult life with the philosophy of service before self as evidenced by my service to our country in the United States Marine Corps and by my service to our community as a police officer, teacher, sports official, lawyer representing indigent clients, Assistant Public Defender and Assistant District Attorney. I believe my jury trial experience both as a defense attorney and a prosecutor would be an asset to our district.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. *(150 words or less)*

I am seeking appointment as a circuit court judge for the 22nd Judicial District covering Maury, Giles, Lawrence, and Wayne counties. The circuit court judges in this district preside over criminal, civil, and chancery matters. The position I am seeking is due to the upcoming retirement of Judge David Allen. Due to the ever-increasing population in the district, the pressure on the court system is linearly increasing. As a candidate that has jury trial experience as both a prosecutor and a defense attorney as well as experience in civil and family matters, I believe I am uniquely qualified to best serve the district in efficiently addressing the needs of the court system. I believe I would be able to quickly begin to assist the district with a seamless transition after Judge Allen's retirement.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports

your response to this question. (250 words or less)

I will uphold the law even if I disagree with the substance of the law. I represented a client by appointment who was charged with a class A felony for which she was originally held on over \$1 million bond. During my representation of her, she learned during her incarceration that she was expecting a child. My client informed me that she wanted to terminate her pregnancy. However, after multiple attempts to either reduce her bond to an amount she would be able to post or obtain the cooperation of the sheriff's department to transport her for the appropriate medical procedure failed, the statutory date eliminating the possibility of terminating her pregnancy passed while she was still incarcerated pre-trial. She was later released from custody straight to probation after entering a plea agreement to a much lower charge.

I filed a lawsuit in federal court on behalf of my client against the sheriff and county for failing to provide essential medical services to inmates in pre-trial incarceration. I filed the suit on a contingency agreement absorbing all of the costs associated with the suit. Ultimately, the suit was dismissed for violating the statute of limitations after argument before the court regarding the appropriate date to toll the statute of limitations.

I have always been and continue to be pro-life. My client's desires did not align with my personal beliefs. Despite my personal beliefs, I agreed to represent my client in this matter because under the law, as it was then, abortion was legal and my client's rights were being denied.
