6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

My present law practice is of a general nature but with a concentration on criminal law. I estimate that 75-80 percent of my practice is in criminal law and the remainder is diverse but generally involves "people" law. As an example I have recently handled cases involving real estate disputes, contracts, and inheritance, an administrative appeal to chancery court, detainer actions and uncontested divorces.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

I have tried over 60 jury trials in civil and criminal matters, the greater majority being criminal. I have perfected several administrative appeals to chancery court most recent being Burley v. Department of Safety, Chancery 17-0669-III, involving the issue of venue in criminal forfeitures. I have represented clients in hearings before the Department of Safety, Unemployment Security, Funeral Board, City Beer Board, and practiced domestic law for over 25 years but have tapered off my practice in that area. I have handled numerous juvenile cases and have recently argued a juvenile transfer matter involving homicide. I have been admitted to the Sixth Circuit U.S. Court of Appeals and the Fifth Circuit U.S. Court of Appeals. My practice is 99% retained clients. I have represented defendants in jury trials in Davidson, Cheatham, Humphreys, Rutherford, Sumner, Wayne, White, Williamson, Wilson counties and have learned from the many different judge's perspectives and preferences in the conduct of their jury trials. I have also represented defendants in several jury trials in the United States District Court for the Middle District Tennessee. My diverse practice has allowed me to experience and therefore learn from these many different perspectives of the law.

In the spring of 1976 I was an intern at the State Legislature representing Memphis State University and assisted in the preparation of legislation on behalf of the House representative to whom I was assigned and thereafter followed it through the legislative session. I also enrolled and attended classes at the University of Tennessee Nashville during this internship with the legislature. Later that same year I obtained employment with the Criminal Court Clerk of Davidson County Tennessee while I continued my education at the University of Tennessee Nashville. I was employed with the Clerk's office for several years during which I helped issue warrants, write appearance bonds, call dockets, assisted in the preparation of the minutes, clerked through numerous jury trials; administering oaths, logging evidence and keeping the record of events of the trial. Beginning in the spring 1980, while attending law school, I was employed full time by A.A. Birch Jr., Judge of Criminal Court of Davidson County, Division III as a law clerk/court officer and conducted research, prepared draft Orders and memorandums, transported prisoners, served subpoenas and provided security in the courtroom. I have sat as a special judge in the General Sessions Court of Davidson County on many occasions and also in the Circuit Court for Davidson County relative to involuntary committals for mental health purposes.

General Sessions Court through the application for permission to the Tennessee Supreme Court and in so doing have an understanding of the burdens, duties and perspectives of each level of our judicial system. I have been sole trial counsel in over 60 jury trials and as a court officer witnessed hundreds more.

This Court includes the felony Drug Court. I have been involved with the Davidson County Drug Court (DC4) since its inception. It is an excellent and much needed program and I want to continue its operation in its present form as it is considered the national "gold standard" of Drug Courts. Treatment and rehabilitation decreases recidivism and I want to be a part of this drug court.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

There are six Judges of the Davidson County Criminal Courts handling violations of criminal statutes and related matters such as probation violations, post convictions and general session appeals. I have practiced in front of all the present Judges except the Judge of Division IV. I have a good relationship with the present Judges of the Criminal Courts and I would strive to maintain that relationship and the case load to which I would be assigned. I would assist my fellow Judges as needed and requested. The Davidson County Drug Court (DC4), a part of this court, is recognized as one of the most successful long term residential addiction treatment courts and I will strive to maintain its national reputation of providing quality addiction treatment while developing the character of the participants during their confinement. I will put in the time necessary to fully conduct the business of the court.

I would maintain absolute allegiance to my Oath of office and in doing so would follow the law as written and has been interpreted by higher Courts regardless of my personal beliefs or feelings. Our system of justice is dependent upon the oaths of each participant; whether juror, witness, clerk, attorney or judge.

It has become evident during my practice that incarceration, even for minor infractions of the law, is sometimes not only necessary for society but can be useful for rehabilitative purposes. I have likewise represented defendants accused of sexual crimes against children and regardless of my personal feelings, I have attempted to provide them the best representation possible. I have been true to my oath as an attorney and I will be true to my oath as a judge.
