- (1) Whether the test for capacity to bring or maintain an action in Reid v. State, 197 S.W.3d 694, 699-702 (Tenn. 2006) and State v. Nix, 40 S.W.3d 459, 464 (Tenn. 2001) that requires a litigant to understand his or her legal rights and liabilities should include considering whether the petitioner possesses the present capacity to appreciate the petitioner's position and to make a rational choice with respect to initiating litigation or whether the petitioner is suffering from a mental disease, disorder, or defect which may substantially affect the petitioner's capacity. See Tenn. Sup. Ct. R. 28, § 11(B)(1).
- Whether the trial courts' consideration and use of the civil capacity standard in <u>In re Estate of Groves</u>, 109 S.W.3d 317 (Tenn. Ct. App. 2003) is consistent with <u>State v. Nix and effectively includes the capacity standard in Tenn. Sup. Ct. R. 28, § 11(B)(1).</u>
