²For oral argument, the Court is particularly interested in the following issue: Whether the Court of Criminal Appeals erred in affirming the trial court's refusal to grant post-conviction relief on the petitioner's claim that he was denied the effective assistance of counsel in connection with pretrial statements given to police. This statement of the issue for oral argument does not prevent the parties from raising additional issues pursuant to Rule 13(a), Tenn. R. App. P.
