Understanding Claim Types

Below is a description of the claim types available for ACAP. Please read each type so you will know which claim type to select to enter your activities and expenses. The different claim types populate different fields that are requested about the case or client information. Selecting an incorrect type will cause a delay in payment and be returned to you for correction.

Note: Claims are paid based on the guidelines established under Supreme Court Rule 13.

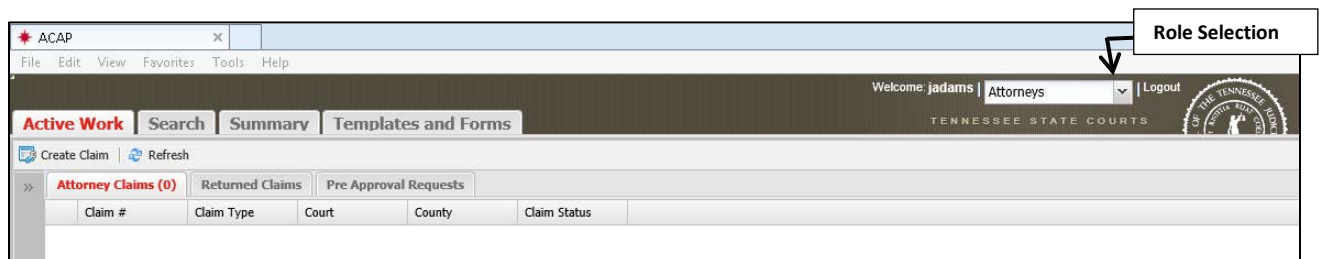
Claim Type	Description	Must Submit to Judge or AOC by? to be Paid
Attorney Fee Capital	Attorney will use this claim type for capital cases with First Degree Murder seeking the death penalty otherwise it is considered Non-Capital.	Interim claims shall be filed at least every 180 days, but no more frequently than every 30 days. Any portion of a claim requesting payment for services rendered more than 180 days prior to the date on which the claim is approved by the court in which the services were rendered shall be deemed waived and shall not be paid.
Attorney Fee Non-Capital	Attorney will use this claim type for indigent representation on non-capital cases (judicial by-pass, probation violation, post-conviction, Juvenile, child support contempt's, etc.)	Claim must be received within 180 days of final disposition of the case.
Judicial Hospitalization	Attorney will use this claim type for cases that involve limited guardianship/ conservatorship; emergency involuntary or indefinite involuntary commitment.	Claim must be received within 180 days of final disposition of the case.
Dependency & Neglect	Attorney or guardian ad litem will use this claim type for cases that involve dependency & neglect phase I/II, termination of parental rights, and intervening petition.	Claim must be received within 180 days of final disposition of the case.
Parole Revocation	Attorney will use this claim type for cases that involve revocation parole proceedings.	Claim must be received by the parole board for review and approval within 180 days of final disposition of the case.
Interpreter	Interpreter will use this claim type for cases or work where interpreter provided interpretation services.	Claim must be received within 180 days from date of service.
Interpreter Time Log Billing	Interpreter will use this claim type for cases where interpreter provided linguistic services for multiple clients within same court proceeding.	Claim must be received within 180 days from date of service

Claim Type	Description	Must Submit to Judge or AOC by? to be Paid
Expert Claims	Expert/Investigator will file claims for reimbursement of services provided in court. Must have prior approval by the AOC prior to service being provided.	Not Applicable
Judicial Hospitalization Docket Billing	Attorney will use this claim type for emergency involuntary commitment cases for General Sessions court where the county has contracted for this type of claim.	Claim must be received within 180 days of final disposition of the case.
Child Support Flat Rate Billing	Attorney will use this claim type for contempt of child support cases for Juvenile court where the county has contracted for this type of claim.	Claim must be received within 180 days of final disposition of the case.
Judicial Clerk Fees	Judicial Clerks will use this claim type to submit their judicial clerk fees and cost bills.	Not Applicable

Ready to Create Claim

Enter the following ACAP web address: <https://acap.tncourts.gov> into the browser's address bar. Log on to the application using your login credentials.

Verify your role displays by your name. If not, select the down arrow and choose the correct role (some claimants may have two roles, e.g. attorney and judge).



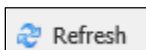
The Search, Summary and Templates and Forms tabs will be discussed separately in the manual. Please refer to those sections.

Understanding the Active Work Tab

Select the Active Work tab; notice the toolbar just below the tab. You have the Create Claim button and Refresh button.



Selecting Create Claim will start the process for you to enter your claim.



Selecting Refresh will refresh the application.

Look at the tabs below the buttons. The Attorney Claims tab displays (0) claims created, if you have any incomplete claims they will display here and the counter will display the number of new claims created. The Returned Claims tab is where you will find claims returned to you by the AOC or judge or any claims you removed then later reactivated. The Pre Approval Requests tab is for those pre approvals which were approved by the AOC and are ready for you to select the Expert so they can be notified to perform service requested.

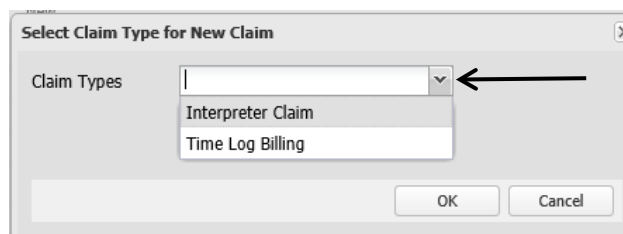
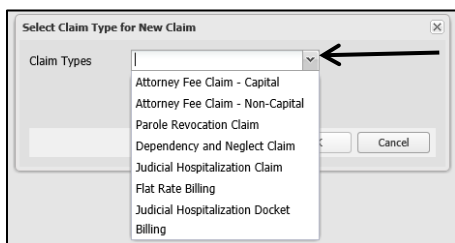


>> Clicking on the Panel Filter button will expand a window that will enable you to filter your claims. Claimant can filter by claim #, claim type, court or county to locate specific claims already in process but not submitted. After information is entered then select the Apply button at the bottom of the panel to find those claims by filtered criteria; or the Reset button to reset the fields to enter different data. To close the panel then click on the close panel button <<



Selecting the Create a Claim Button

After selecting the Active Work tab and clicking on the Create Claim button, ACAP will present a new window (Select Claim Type for New Claim) where you can select the down arrow to make your claim selection. ACAP will only present those claims available for your role. Select the claim type from the menu then select the OK button. Or you can select Cancel to return to the Active Work tab.



Understanding the Claim Entry Screen

After selecting your claim type ACAP presents the following screen. This screen displays the properties tab in red because we are viewing this tab. You will notice a toolbar above it with many buttons and more tabs next to the properties tab. I will first explain the toolbar then the following tabs: Properties, Claimant Activities, Activities, Documents and History/Comments will be discussed in their own sections in the manual. The properties tab will be discussed for each claim type because there will be different information required for each claim type. Please refer to these sections.

Tool Bar

Toolbar Buttons	Description
Continue Claim	This option is used for interim billing for Capital Claims and Dependency & Neglect when a D & N disposed case goes back into court again.
Check Duplicates	Once a claimant saves claim information on the properties tab, he/she can select this button to find out if he/she created a previous claim and this claim is a potential duplicate.
Convenience Copy	Select this button to print a copy of the claim.
Add Appointment Order	Select this button to upload the appointment order signed by the judge appointing you to this case. This is required for claim to be reimbursed.
Add Pre-Approval Order	Select this button once you complete the properties tab and want to send to the AOC your Pre-Approval Order requesting Expert/Investigator services. Or request for pre-approval for expense type (e.g. Travel Out of State).
Refresh	Select this button to refresh the application to clear out an error. Or after a Save when-you will want to know if you have an online or offline judge.
Save	Select this button to save the information on the properties tab.
Close	Select this button to close the claim and return to the Active Work tab. Not closing a claim will cause claim to be locked by you and not accessible until you log back in to open the claim and close claim properly (this will clear the lock).
Help	Select this button when you need to find help on a topic.
Action	Select this button to display menu when you want to submit or remove your claim. Please select the appropriate menu option.

Attorney Fee Claim – Capital Properties Tab

Capital claims are those claims related to a First Degree Murder case whereby a Notice of Intent to Seek the Death Penalty has been filed. If the District Attorney has NOT filed a Notice of Intent to Seek the Death Penalty, then you must enter the claim as a Non-Capital Claim type.

Attorney’s filing Capital claims will be filing interim claims since these claims can go on for years. Attorneys shall file a claim at least every 180 days, but no more frequently than every 30 days. Any portion of a claim requesting payment for services rendered more than 180 days prior to the date on which the claim is approved by the court in which the services were rendered shall be deemed waived and shall not be paid. ACAP provides a feature Continue Claim to facilitate filling an interim claim. Please refer to the section on Continue Claim.

When you first create this claim the system displays the Properties tab. The first field you see is the claim type you selected. The claim is assigned a unique claim number. This number is the best way to track your claim through the process. The claims status is ‘New’. The status of ‘New’ indicates a new claim which has not been submitted either to the judge or the AOC for review; it is considered in your in-basket or active work tab.

The court demographic information is next and must be entered in a specific order. Then client’s (defendant) name, TCA offenses (ACAP will pre-load the First Degree offense code) and case numbers are to be entered and saved before you can start entering your activities. You will notice a red asterisk or red outline by those required fields. The disposition date or last activity date is required before you can select the judge from the drop-down menu options. If no date is entered then the Judges drop down menu will be blank.

You can close your claim by selecting the Close button on toolbar to return to the Active Work tab to create another claim

Completing the Capital Properties tab for Submission

The claim is complete and ready to be submitted for reimbursement. Complete the following fields on the property tab and finish entering all your activities on the Claimant Activities tab. Upload your appointment order by selecting the Add Appointment Order button located in the toolbar above the Properties tab.

Field Name	Description
Disposition Date/Last Activity Date	Enter the last activity date of previous claim or if case has gone to disposition then enter the disposition date. You must enter this date in order for ACAP to display the judges in the Judges drop-down menu.
Claim Date	ACAP will display the date the claim is submitted to the Judge or AOC.
Sentence	Enter the sentence given at disposition. Or if this is an interim claim enter 'interim billing – case is pending'; if counsel is withdrawn, then no entry is required.
Disposition	Select the disposition type from the drop down menu options.
Conviction Offense	Please enter the conviction offenses at disposition; enter the highest offense first and its description, class and type (Felony, Misdemeanor).
Judge	Select the presiding judge from the drop-down menu options. If the judge is not listed leave blank. When you submit the claim, ACAP will prompt you enter a reason for leaving this field blank; enter the name of Judge and whether they sat special, by interchange or newly appointed. Note: The Disposition Date/Last Activity Date must be entered before you can see the judges in then drop-down menu.
Complex	Click in the check box to insert checkmark if this claim is complex. ACAP will prompt you to upload the complex order. If you do not upload the order, the system will remove check mark.
Seal	Click in the check box to insert checkmark if this claim is to be sealed. ACAP will prompt you to upload the seal order from the judge making the claim not for public record. If you do not upload the order the system will remove check mark.
Motions	Click in the check box to insert checkmark if you have a separate motion for complex. ACAP will prompt you to upload the complex motion. If you do not upload the motion, the system will remove check mark.
Co-Counsel	Click in the check box to insert checkmark if you are the co-counsel who is submitting this claim.
On-line	This check box is grayed out and will display as checked. Once you save claim information on the properties tab; select the Refresh button on toolbar, if the check mark disappears then the judge selected is an offline judge.
Indigent	This check box is defaulted as checked indicating client being represented is indigent.
Total	Total dollar amount of claim submitted to Judge or AOC.
Notes:	(Optional) Can enter notes about the claim or note to judge/AOC.

Attorney Fee Claim – Non-Capital Properties Tab

An attorney will use this claim type for indigent representation on non-capital cases (judicial by-pass, probation violation, post-conviction, Juvenile, child support contempt's, etc.).

Note: Claims are paid based on the guidelines established under Supreme Court Rule 13, Sections 2 and 4.

When you first create this claim the system displays the Properties tab. The first field you see is the claim type you selected. The claim is assigned a unique claim number. This number is the best way to track your claim through the process. The claims status is 'New'. The status of 'New' indicates a new claim which has not been submitted either to the judge or the AOC for review; it is considered in your in-basket or active work tab.

ACAP will allow entry of a partial claim for those claimants who like to enter their activities as the case progresses up through disposition. The court demographic information is next and must be entered in a specific order. Then client's (defendant) name, TCA offenses and case numbers are to be entered and saved before you can start entering your activities. You will notice a red asterisk or red outline by those required fields.


The disposition date and judge is not required until you are ready to submit your claim. If you want to enter the judge then the disposition date must be entered. If no date is entered then the Judges drop down menu will be blank.

Upload your appointment order by selecting the Add Appointment Order button located in the toolbar above the Properties tab.

Disposition	Select the disposition type from the drop down menu options.
Conviction Offense	Please enter the conviction offenses at disposition; enter the highest offense first and its description, class and type (Felony, Misdemeanor).

Co-Counsel	Click in the check box to insert checkmark if you are the co-counsel where the notice to seek the death penalty is withdrawn on a capital case. Co-counsel will be compensated non-capital rates for services rendered after the date the notice is withdrawn.
On-line	This check box is grayed out and will display as checked. Once you save claim information on the properties tab; select the Refresh button on toolbar, if the check mark disappears then the judge selected is an offline judge.
Indigent	This check box is defaulted as checked indicating client being represented is indigent.
Total	Total dollar amount of claim submitted to Judge or AOC.
Notes:	(Optional) Can enter notes about the claim or note to judge/AOC.

Judicial Hospitalization Claim Properties Tab

This claim type should be used for attorneys and/or guardians ad litem appointed in proceedings brought by a superintendent of a state mental health facility pursuant to Title 34, Guardianship Law. See T.C.A. 33-3-503.

Note: Supreme Court Rule 15 "prescribes the nature of costs for which reimbursement may be allowed in judicial proceedings relating to indigent persons under Title 33, Mental Health and Development Disabilities. This rule does not apply to those costs incurred in criminal proceedings, including hearings to determine competency to stand trial, which are regulated under other Supreme Court Rules and statutes."

When you first create this claim the system displays the Properties tab. The first field you see is the claim type you selected. The claim is assigned a unique claim number. This number is the best way to track your claim through the process. The claim's status is 'New'. The status of 'New' indicates a new claim which has not been submitted either to the judge or the AOC for review; it is considered in your in-basket or active work tab.

ACAP will allow entry of a partial claim for those claimants who like to enter their activities as the case progresses up through disposition. The court demographic information is next and must be entered in a specific order. Then client's (defendant) name and case numbers are to be entered and saved before you can start entering your activities. You will notice a red asterisk or red outline by those required fields.

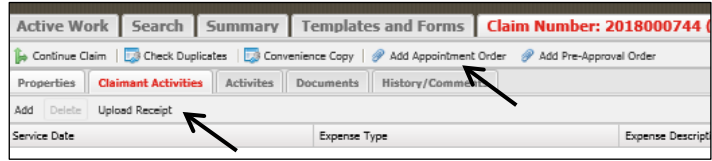

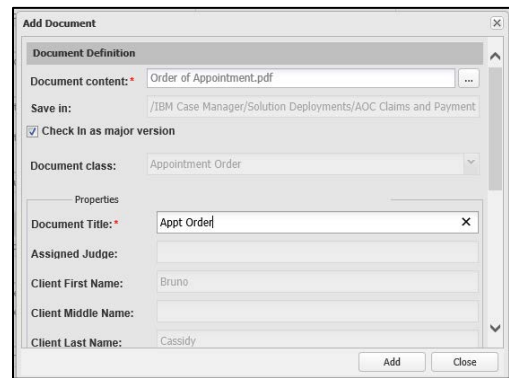
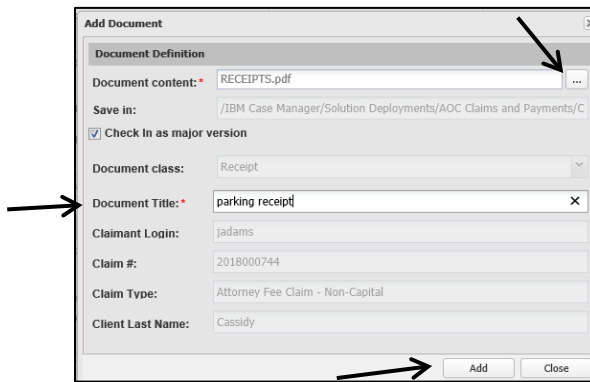
Upload Receipt and/or Add Appointment Order

Select the Upload Receipt and/or Add Appointment Order buttons. ACAP will populate the Add Document screen.



At the document content field select the browse button located at the end of the field . Locate the receipt or appointment order you saved as a PDF document on your computer. Select your PDF document then select the Open button or you can double click on selected PDF document. ACAP will return to the Add Document screen with the document file name showing in the 'Document content' field. Next enter the document title then click the Add button to upload your document. Or select the Close button to close out of the Add Document screen.

Note: Make sure to scan and save all your documents in PDF file format (.pdf) before uploading onto ACAP.



Delete Claimant Activity Record

Delete a record by clicking on the checkbox by the expense record which will insert checkmark. Once selected then click the Delete button on the Claimant Activities tool bar. The subtotal and claim totals will recalculate.

Submitting the Claim

The ACAP system provides a way for you to submit your claim based on whether the judge is online or offline. An online judge uses ACAP to review and approve claims electronically. An offline judge does not use ACAP. The claimant will have several additional steps and tasks to complete the claim for an offline judge to be able to send it to the AOC.

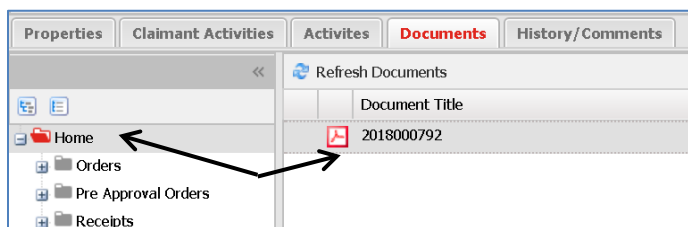
Also, ACAP will provide several validations up front so claimant can correct the claim prior to submission. The system may request a reason when claimant submits the claim without making some corrections. On the toolbar far right select the Action button then select one of following three actions listed below. Refer to Understanding Claim Statuses should you see different status after submission.

Submit for Judicial Review (Online Judge)

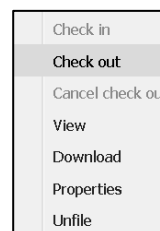
- If claim is **less than \$200** for online then claim will route to the AOC for Review.
- If claim is **greater than \$200** then claim will route electronically to the judge for review. He will be notified by email that there are pending claims awaiting judge approval.

Print for Judicial Review (Offline Judge)

- If claim is **less than \$200** then you will do the following. After selecting this option the system returns you to the Active Work tab. Click the Refresh button at least two times. This will retrieve any new claims that you will need to complete.
 1. The claim you just submitted will have a new status: Awaiting Judge Signature.
 2. Double-click on this claim to open.
 3. Claimant will select the Action button found on the tool bar then select 'Printed Claim Added'. This will route your claim to the AOC. Since the claim is under \$200 then you will not have to take it to the judge for review and signature.
- If claim is **greater than \$200** then you will do the following. After selecting this option the system returns you to the Active Work tab. Click the Refresh button at least two times. This will retrieve any new claims that you will need to complete.
 1. The claim you just submitted will have a new status: Awaiting Judge Signature.
 2. Double-click on this claim to open.
 3. Claimant will need to go to the claim's Document tab and click on the Home folder. System will display PDF with claim ID number (e.g. 2018000792).

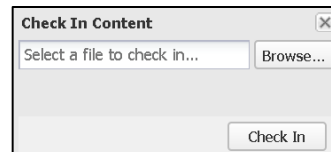


4. Claimant will mouse right click on the claim PDF document. Then select 'check out' from menu options. System will prompt you to open, save, or cancel the PDF document. Open the claim PDF document and save onto your desktop.
5. Print PDF document and take to judge for review and signature. Judge will need to return the claim back to you so you can then upload it to the ACAP claim.



Note: Parole Revocation Claim types will follow these instructions with the exception that they will print the PDF copy and take to the Parole Board for review and approval instead of a judge.

6. Claimant has signed claim, and it is scanned and saved on claimants desktop.
7. Claimant will log back into ACAP. Locate claim in your active work tab. Claim will have status: Awaiting Judges Signature.
8. Open the claim and select the Documents tab. Click on the Home folder. System will display PDF with claim ID.
9. Claimant will mouse right click on the PDF document and select the menu option of 'check in'. System will display the Check In Content screen.
10. Claimant will select the browse button to browse his/her computer for signed copy of PDF claim to upload. Select the signed PDF and select open or double click the pdf file will place PDF file in field. Lastly, select the 'Check In' button.
11. Claimant will select the Action button found on toolbar then from the menu select: Printed Claim Added. This will route claim to the AOC for Review with signed copy uploaded.



Remove Claim

- Claimant selects this action; the system will prompt you for a reason for removing the claim. Select OK to continue the process. Click Cancel to cancel the removal process. Clicking OK will remove claim from claimant's active work tab (similar to doing a delete claim). If claimant later decides he/she wants to bring back removed claim then refer to the Reactivate Claim section.

Reactivate Claim

Select the Search Claim tab. Search for claims with a Removed status. Use the filter panel on left side to filter claim by different criteria (e.g. Claim status is equal to and enter 'removed') or see all claims by selecting the Apply button.

Locate claim in the result list on the right side of the screen. Double click to open claim. Select the Reactivate button just above the properties tab. The system populates the Status message: Reactivate claim request has been submitted. Click the OK button. Select the Close button to close claim.



You cannot process claims in Search mode. Select the Active Work tab and select the Return Claims tab. This is where you will find the reactivated claim and you can continue to process the claim from here.

Continue Claim

Attorneys filling Dependency & Neglect claims as well as those attorneys filing Capital claims on the same case/defendant may use the Continue Claim feature. The first claim filed must have a status of 'Paid' before you can use this feature.

Log into ACAP then select the Search tab. Next using the Query panel locate your phase I or previous claim submitted. Select record by clicking the checkbox by the record to insert checkmark then double click record. This will open this record.

After you have selected the Add button then select the Close button. Remember you are in the Search tab and you will not be able to modify or work the claim from there.

Select the Active Work tab and your new claim will be listed there. Open your claim and verify the information on the Properties tab. You will need to modify the Disposition/Last Activity date and any information that was pre-loaded and is different for this claim. Then select the save button. Continue by selecting the Claimant Activities tab to enter your activities and expenses. Complete your claim as usual.

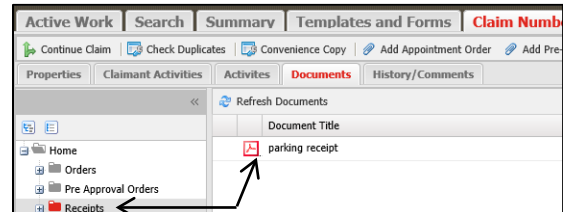
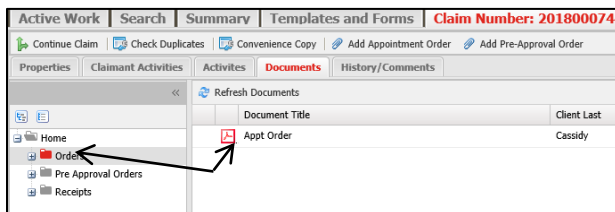
Understanding the Activities Tab

The activities tab will display the expenses and hourly activities entered by claimant showing the quantity, unit cost and total cost requested. After judges review, the claimant can view the quantity and/or hours adjustments made by the judge (e.g. reducing hourly total to cap amount for claim type). After AOC review you can view quantity and/or hours adjustments made by the AOC. Please refer to the History/Comments tab for details on changes.

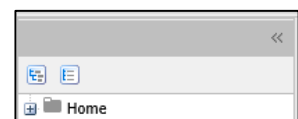

Understanding the Documents Tab

This tab will display the PDF documents uploaded by the claimant. Click on the orders folder located on the filter panel. ACAP will change the folder to red and display the appointment order PDF. Click on the receipts folder and ACAP will change folder to red and display receipt PDF document. . If claimant does not see a document listed under the Document Title header then document was not uploaded. Claimant can upload the appointment order by selecting the Add Appointment Order button. Claimant will need to go back to Claimant Activities to upload the receipt using the Add Receipt button.

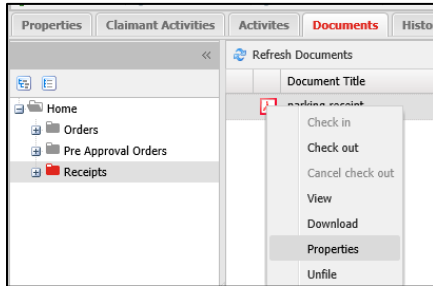


The claimant has two buttons above the Home folder. These are the collapse and expand buttons for the home folder. The expanded view is what you see in the examples above and you can see all folders found in the Home folder. The collapse view would be the home folder by itself and folder displays closed instead of open.

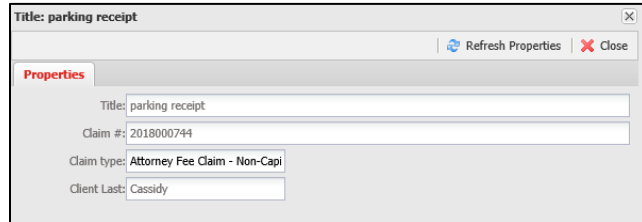


Mouse right click on the PDF document will display some menu options. Selecting 'Properties' will display the properties of the document such as the document title, claim #, claim type, and client last name associated with document.

Document Properties

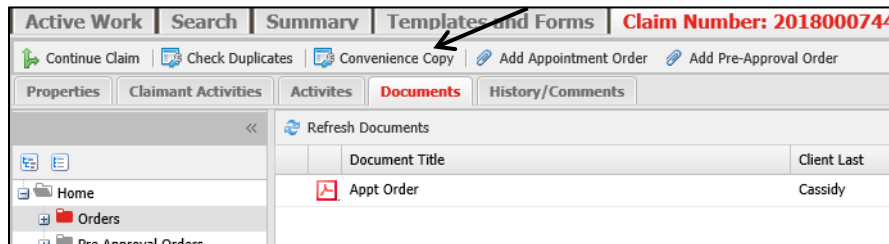


Selecting 'Download' will enable claimant to download the PDF document. The system will prompt you if you want to open, save or cancel the process of downloading. Make a selection.

Selecting 'Unfile' will remove the PDF document from the claim. The menu options 'Check out', 'Check in' and 'Cancel check out' will be discussed in the manual section Submitting Claim for an Offline Judge.

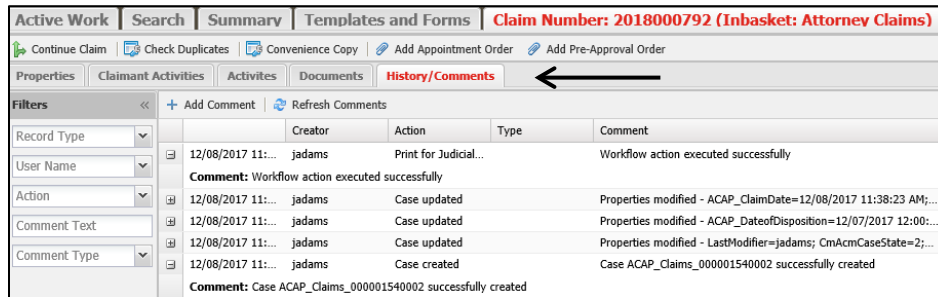
Printing a Copy of the Claim

ACAP allows you to print a copy of the claim. Open the claim then select the Convenience Copy button located on the toolbar. The system will prompt you to open, save or cancel PDF copy. Select open. Once the PDF copy is opened you can print by selecting File then Print. This document will be a copy of what you submitted to the AOC or judge and does not reflect what may be paid.



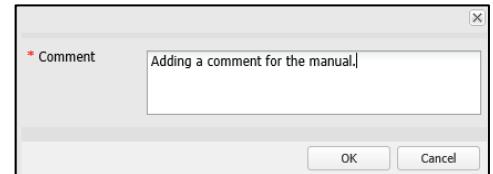
Reviewing and Using the History/Comments Tab




ACAP provides the history of the claim as it moves through the system until payment is received. This is also where you can add and view comments.



Select the History/Comments tab. ACAP display a list of historical actions, comments, creator of those comments or actions and date each occurred. ACAP provides a way to search for specific comments based on certain criteria such as record type, user name, action type, and comment text or type.

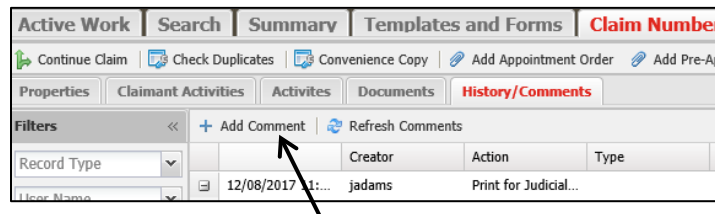
- Click on the filter panel buttons (>>) to expand the panel.
- Enter criteria.
- Select Apply to perform filter search or Cancel to cancel filter search.
- Click on the (<<) button again to collapse panel.



Each comment has a  by the comment. Clicking on the plus sign will expand the comment and display all information relating to comment/action. Click on the minus sign  will collapse the comment. Another way to expand the comment is to enlarge the column header. Go to the end of the column header until you see the two arrows  then click and drag to the right.

Adding Comments

Select the Add Comment button on the History/Comments toolbar.



The comments text box displays.

- Enter a comment in the text box provided.
- Then select the OK button to add the comment. Or select the Cancel button to cancel the comment.
- View comment added in the History/Comments screen.

If you do not see your comments then select the Refresh Comments button on toolbar. This will refresh the system and bring in any new comments that may have been added.
