She is also a TN Rule 31 listed mediator for general / civil and family disputes as well as an approved trainer for General Civil Mediation and Domestic Violence. She has worked with government, law enforcement, telecommunications, and financial organizations as well as General Sessions courts, the Equal Employment Opportunity Commission and the Department of Labor.

The facilitators will include: Fran Clemmons M.S., and University of Tennessee in Human Resource Development.
