PLEA FORMAT

Hon. Justin C. Angel Circuit Court Judge, TN-12th, III

- Swear in the defendant
- I will call you sir or mam, to show you respect, please call me sir/mam or your honor to show respect not to me, but to the court system.
- Waive 5th amendment right, so they can answer my questions
- Under the influence of any medication, alcohol or drugs?
- If at any time you have a question of your attorney or you're confused about something we're doing, please let me know and I will let you speak with your attorney.
- If you change your mind, and you don't want to enter this plea then please let us know, we will set a jury trial for you as quick as possible.

• GO OVER PLEA WAIVER FORM

- Name, case number, charge
 - o Is this your signature?
 - o Did you go over this form with your attorney?
 - o Can you read and write?
 - o Do you understand the content of this form?
 - o Do you have any questions of your attorney at this time?

Constitutional Rights

• Right to an attorney through all critical stages of your case, if you went to a jury trial you have the right to an attorney represent

- you. If you can't afford an attorney, the court will appoint you one.
- Right to have an attorney file and argue pre-trial motions
- Right to a public jury trial where 12 citizens would preside as jurors
- The state has to prove you are guilty beyond a reasonable doubt of every element of every crime
- Right to compel witnesses by subpoena
- Right to confront state witnesses in open court
- Right to testify on your own behalf or remain silent
- Right to appeal conviction and sentence and have an attorney for the appeal
- Right to have a jury set a fine over \$50.00
- IF PLEADING TO A FELONY: Felony implications, can't vote, can't own firearm or ammunition, can't run for public office.

 There are many other issues that come along with being a convicted felon. Also, a felony conviction like this can be used to up range a sentence against you in the future. Knowing all of this, do you have any questions of your attorney? Do you still want to go forward with your felony plea?
- Has anyone threatened you, forced you or coerced you to enter the plea?
- Has anyone made any promises other than the plea offer?
- (Information) Right to grand jury
- (Venue) Right to handle case in the proper county
