Presently, my practice is strictly criminal law with an emphasis on felonies.

I began my legal career clerking for the Mississippi Court of Appeals working for the Honorable Kenneth Griffis. This Court handles both criminal and civil matters including, but not limited to bidding disputes, property disputes, criminal procedure, custody matters to divorce matters. After passing the Tennessee bar in 2010, I practiced in Sullivan County general sessions court, criminal court, and juvenile court – handling termination of parental rights, being guardian ad litem and representing parents.

In February of 2011, I went to work alongside Mr. Richard Spivey in his criminal practice. There, I gained a wealth of knowledge as I was able to assist him in several trials including, but not limited to the *State of Tennessee v. William Casey* and *State of Tennessee v. Steve Duncan*. Mr. Spivey's practice is the biggest in Sullivan Co., and I gained real experience on trial tactics, criminal procedure, sentencing, case management, and negotiation.

After leaving Mr. Spivey's office, I went back to a solo-practice and shared office space with Gene Scott, Jr. There, my practice was criminal (criminal court and general sessions) and juvenile. I also sat 2nd chair with Mr, Scott in 1st degree murder of a child and in defense of someone charged with attempted first degree murder when the car that he was in hit a police officer.

In June of 2013, I went to work for Wheeler & Seeley in Jonesborough, Tennessee. My practice was drafting wills, assisting Mr. Wheeler in his estate and probate and with the representation of the town of Jonesborough. With Mr. Seeley, I assisted him in his divorce cases, his environmental court practice in which he represented Washington Co., and with his representation of Erwin.

I have tried at least 5 criminal jury trials myself and around 10 other jury trials alongside my mentors (Richard Spivey, Gene Scott, Jr., or Andy Kennedy) as second chair. I have argued in front of the Court of Criminal Appeals- Eastern District in the case of *State of Tennessee v. Travis Wilson*.

I believe that this position is one that requires someone who is willing to listen to all sides, research the law, and to follow the law whether it is popular or not. I believe that I can be impartial and fair and not make my decisions based on popular opinion.

I am seeking to be appointed to the 2^{nd} Judicial District Circuit Court which covers all of Sullivan County. This position hears criminal and civil matters.

Yes, even if I disagree with the substance of the law, I will uphold it. One example that I see a lot in my criminal defense practice is "sale of drugs within a school zone." When a defendant is found guilty of this crime, he must serve 100% of his jail sentence. To me, this is harsh as practically, all of the city of Kingsport is "within 1000 feet of a school." In effect, this makes nearly all drug deals in Kingsport within 1000 feet of a school zone. So many people are serving 100% sentences that sold some minute amount of drugs "within a school zone." I know that my opinion on the matter is probably not popular among everyone, but it is my honest assessment. Although I disagree with this law, I would be able to uphold it because it does not matter what my opinion is, as a judge I would follow the law.
