At present, I would estimate that 50-60% of my law practice involves representing lawyers, law firms, and business and individuals who deal with lawyers in matters involving the law of lawyering. That portion of my practice includes:

- Representation of lawyers and law firms in a wide variety of claims and lawsuits;
- Advising lawyers and law firms concerning both general and specific loss prevention issues;
- Representing lawyers in disciplinary proceedings (and some representation of others in the pursuit of disciplinary matters);
- Representation of lawyers licensed in other jurisdictions in proceedings before the Board of Law Examiners, and of law school graduates in connection with bar admission matters;
- Advising lawyers, law firms, and others concerning conflicts of interest;
- Appearances as special counsel in litigation for parties or their counsel of record regarding issues of disqualification, attorney-client privilege and attorney work-product, and judicial recusal;
- Representation of non-lawyers (both entities and individuals) in creating business models to market products or services to lawyers;
- Advising corporations and other organizations concerning issues involving in-house counsel, including deficient licensure and unauthorized practice of law issues;
- Representation of lawyers, law firms, judges, and judicial candidates concerning legal and campaign advertising issues;
- Assisting lawyers, law firms, and others with questions related to providing law-related services and the establishment and operation of ancillary or law-related businesses; and
- Engagement as an expert witness (including both consulting and testifying capacities) to counsel and parties involved in malpractice litigation and other litigation concerning ethics and professional responsibility issues.

In addition to representing lawyers and firms externally, a portion of my time is spent serving as counsel to my own law firm on an as-needed basis on such issues.

The remainder of my law practice is almost entirely focused on representing clients in litigation, including commercial/business litigation matters, appellate litigation (both federal and state matters), some healthcare liability (medical malpractice) matters, and other general litigation.

Around 5% of my practice involves non-litigation matters, not involving legal ethics or professional responsibility issues, and covers contract review, counseling, and public relations and crisis management services.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

I take great professional pride in the abilities I have demonstrated both inside, and outside, the courtroom during my entire career. I believe strongly that every judge before whom I have appeared (if they remembered me) would say that I represented my clients well. I have been fortunate at every firm I have practiced with to have been given opportunities to work on significant litigation matters even in areas I had never before practiced and entrusted to be able to quickly become competent and comfortable with the law involved.

The list of published (or electronically-reported) decisions I have identified in response to the very next question actually are fairly representative of the breadth of my experience in terms of types of litigation and areas of substantive law in which I have been involved over the course of my career.

Those cases run the gamut of both federal and state court litigation, reflect my involvement in traditional litigation and class action matters, and include matters where I was the client's sole lawyer at all times to matters where I worked on the client matter as part of a team of counsel. With respect to the substantive areas of law, those cases involve: administrative law, antitrust law, breach of contract matters, civil rights and constitutional law matters, computer fraud/electronic communications litigation, defamation matters, employment litigation, ERISA litigation, fiduciary duty matters, fraud claims, lawyer disciplinary proceedings, family law matters, health care liability actions (medical malpractice defense), legal malpractice matters, premises liability matters, products liability matters, public records and open meetings matters, Tennessee Consumer Protection Act litigation, and wrongful death litigation.

In addition to such matters, I have also been retained to monitor trials for potential appellate issues and worked behind the scenes on appeals of a broad variety of types. Further, over the years and as the size of my practice representing lawyers and law firms has grown, I have developed the kind of experience that I often refer to as being a "general practitioner by proxy." In order to successfully defend and advise lawyers I have to be able to quickly learn about the area of law they are handling and the type of law practice in which they are engaged. In addition to representing lawyers in matters touching on the same areas of law I have personally handled above, I have represented criminal defense attorneys, immigration lawyers, probate lawyers, prosecutors, real estate closing attorneys, tax lawyers, and lawyers navigating the workers' compensation system.

I have pursued an interest in being a judge on a few prior occasions, but previously always involving federal positions. Initially, in 2005, I put in an application for a vacant United States Magistrate Judge position in the United States District Court for the Middle District of Tennessee but was not selected. I also applied for a vacant United States Magistrate Judge position in the United States District Court for the Western District of Tennessee. I was interviewed in February 2009 but was not selected. It was the position for which Magistrate Judge Claxton was selected. In 2015, I submitted a letter of interest to Congressman Steve Cohen for the vacancy on the District Court in the Western District of Tennessee. I was interviewed by Congressman

Cohen and his screening committee in January 2015. Ultimately, upon Congressman Cohen's recommendation, President Obama nominated then U.S. Attorney Edward Stanton for the position. In 2016, two Magistrate Judge vacancies existed in the United States District Court for the Middle District of Tennessee, and I again submitted an application but was not selected.

I have never held public office. As to positions for which I have been a candidate or applicant, they were all identified in my response to Question 11 above.

<u>ESSAYS/PERSONAL STATEMENTS</u>

28. What are your reasons for seeking this position? (150 words or less)

I am very fortunate to have practiced law with some of the best law firms in Memphis during my legal career to date, but I believe I can make an important contribution to the bench, the bar, and our entire community by pursuing this position at this time.

Judge Childers has been an exceptional jurist and, although his retirement is well-deserved, this will be a great loss to the Circuit Court. I do not know if I would prove to be as good of a jurist as Judge Childers was, but I do believe that my background and reputation, combined with my recognition of the importance of demonstrating fairness to all lawyers and parties that come before the Court, make me well-positioned to be a successful judge if I am fortunate enough to be recommended by the Commission and appointed by Governor Haslam.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

There are nine Divisions of the Circuit Court for the 30th Judicial District. I seek the Division IX position that will become vacant upon Judge Childers' retirement. The Circuit Court hears exclusively civil proceedings but, like has been true with my own experience as an attorney, requires familiarity with, and facility for, a wide range of kinds of subject-matter law. According to statistics made available through the Circuit Court's own website, approximately 5,000 to 6,000 new cases are filed in Circuit Court each year. In addition to matters within its jurisdiction as a trial court, the Circuit has jurisdiction over appeals from certain lower courts of limited jurisdiction within Shelby County.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Yes. Absolutely. If appointed, I intend to take very seriously all of the ethical mandates imposed on judges by Tenn. Sup. Ct. R. 10.

In terms of giving an example, this is a difficult question to answer without writing something that runs the risk of publicly disclosing a sentiment or disagreement that might be traced to a particular client, or particular representation. Over the years, I have represented many clients whose positions were ones that I disagreed with, but in order to provide them with zealous advocacy, I have pursued their positions to the best of my ability because that is the job of a lawyer when you take on a client. The job of a judge is to decide cases and apply the law.

I personally do not view the position of a state court trial judge as a political position. As a trial-court-level judge, I would consider my job to be to follow the law established by the General Assembly and consistent with controlling appellate precedent. I was a Republican earlier in my life (was even President of College Republicans at Rhodes College), but admittedly I am not one today. If fortunate enough to become a judge, I would not inject politics into how I do my job – not only because I don't believe state court trial judges should do so but also because I personally know and understand that political beliefs are subject to change.
