- 29. My desire to be a lawyer began at age five. I have always been a helper, a giver, a leader, and an academic. I was a National Merit Scholar in High School, but declined my West Point appointment to pursue my passion for law. Prior to law school, I pursued jobs that would help me relate to clients, and broaden my understanding of people, community, and business relationships. At FedEx, I started taking packages over the counter and worked my way up to implementing corporate projects. These experiences helped me be a better lawyer by providing me not only with client-facing experience, but by honing a dynamic and perceptive approach to challenges. For the last 20+ years, I have counseled local constituents on monetary and legal issues, remaining active in a wide range of the Memphis population. I believe I am an integral part of both the legal and non-legal Memphis community, and have connected with the people who live here. My experience in law and managing people with grace and consideration will help me be a strong judge for our community.

- 30. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)
- 31. There are nine Circuit Courts in Shelby County. This is an application for Division Seven. These courts hear contests on auto accidents, breach of contract, divorce, medical malpractice, personal injury, worker's compensation, wrongful death, name changes and appeals from lower courts. Approximately 6,000 cases are filed annually in Shelby County and the flexibility of the court to mete out justice is impacted by the speed that the courts can hear and resolve the disputes. If chosen I would be taking the place of a white woman, which would maintain the current status quo of race and gender that helps us keep a balance of diversity in our courts. Why me? I love productivity and completing tasks. There is a balance between planning and organizing and getting the work done, and I have the skills, drive, desire and ability to hear cases and make appropriate rulings efficiently, effectively and fairly.
- 32. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)
- 33. The famous Aristotle quote comes to mind: "The law is reason free from passion". What this means is that laws are made and upheld to provide a standard of conduct for every one and allowing passion in to the process would lead to corruption of the uniform result. An example of how I have upheld the law even if I disagreed with the substance of the law has to do with delinquent tax collections. Regardless of circumstances, every property owner has to pay their property taxes or their property is sold at tax sale to satisfy the tax lien. Many times there were individuals who had nowhere else to go and they could not pay their taxes. On a personal level, I disagreed with putting people out of their homes, but it was my job to enforce the lien. Period.
- In 1996-1997 I created project schedules to enforce the tax lien uniformly across the delinquent tax rolls. These project schedules are still used by Shelby County today. In 2000 I devised a way to leverage internet applications for specific properties to drive overall collections by leveraging demand, by application, against the delinquent tax property list. What I learned is that when the free market pushed collections—i.e. when the lien was enforced without bias—that collections increased. My experience has taught me that removing passion from the process makes for a more uniform process and better results. In sum, tough mindedness in application results in a better overall product.
