1996 - 2001, The Gafford Group, Manufacturer Representative. I represented multiple manufacturers by promoting, displaying and conducting classes in regards to their products in Home Depot stores in Missouri, Arkansas and Northeast Tennessee.

1992 - 1996, Browning Hardware Sales Associate. After graduating high school, I worked as one of two employees in a small mom and pop hardware store in Boonville, Missouri.

In the interims of my employment, I was actively working to obtain my college degree or legal education.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

As an Assistant District Attorney, my entire practice focuses on criminal law and criminal prosecution. I am responsible for prosecuting cases that range from elder abuse to illegal drug distribution and manufacturing, as well as aggravated assault among other things.

One of my specific responsibilities in the 2nd Judicial District is as a member of the Vulnerable Adult Protective Investigative Team ("VAPIT"). I, along with another assistant district attorney, started VAPIT in Sullivan County. The VAPIT statute requires that we coordinate with Adult Protective Services, Law Enforcement, Public Housing and other governmental agencies to investigate potential vulnerable adult crimes and prosecute those cases in which we believe there is criminal responsibility.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

In my time as an Assistant District Attorney, I have prosecuted five jury trials in Sullivan County's Criminal Court, Division I and countless bench trials in General Sessions Court. I have been the only counsel on three of the jury trials and co-counsel on two. In any successful prosecution, preparation is key and I went home knowing I prepared to the best of my abilities. Because of this preparation, I was able to represent well, not only the citizens of Sullivan County but most importantly the victims in each case.

I am currently responsible for nearly 200 active cases split between Divisions I and II in Sullivan County Criminal Court. These include many felony drug cases, crimes against persons, such as elder abuse, and crimes against property such as burglary and theft. It is not uncommon for me to have cases in front of both judges on the same day, multiple times a week. On any given day, I could have motion hearings, sentencing hearings, violation of probation hearings as well as

negotiating and preparing plea agreements for the courts with defense attorneys.

In arguing motions, I always feel it is imperative to know the law, whether it be statutory or an interpretation from the Court of Criminal Appeals or Tennessee Supreme Court, and argue from that vantage point and not from personal belief or opinion. With those principles in mind, I try to be deliberate and calm, knowing that I know the facts of my case coupled with my knowledge the law.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

In the summer of 2013, while I was a law clerk with the Office of the District Attorney General, I co-counseled two jury trials. I had my 3rd year limited practice license from the Tennessee Supreme Court. The District Attorney General, Barry Staubus, believed in me and gave me those two opportunities. The first trial was an Aggravated Assault case with multiple witnesses in which the Defendant was found guilty. The second case was a complicated aggravated assault case with three co-defendants and multiple victims. It lasted three days and all three co-defendants testified. I was given the opportunity to cross-examine two of the co-defendants, as well as direct examination of the officer and several of the lay witnesses. At the time, this was an opportunity that many of my peers were not given and I seized on my opportunity, prepared for trial, and successfully prosecuted each case.

I believe this is a noteworthy marker in my legal career because I worked hard to distinguish myself the two summers I was an intern with the Office of the District Attorney General. As a result of my hard work, General Staubus awarded me with a full-time Assistant District Attorney position after passing the bar in 2014. I have rapidly assimilated and progressed in my legal career as I have gone from managing the daily docket in General Sessions Court to prosecuting felony cases and jury trials in Criminal Court with one of the 2nd District's largest caseloads.

9. Describe any other legal experience, not stated above, that you would like to bring to the attention of the Commission.

For half of the summer in 2013, I was an intern with East Tennessee State University's Office of University Counsel. The head legal counsel, Edward Kelly, put me immediately on a civil rights lawsuit against the University which involved the termination of a professor. I researched civil rights law for, what was, a complex First Amendment case. I also drafted the preliminary Motion for Summary Judgment for the State Attorney General's Office. At the same time, I was assisting, and learning the responsibilities of, the other attorneys in the office and the administrative assistant.

I was a Court Appointed Special Advocate (CASA) from 2012 to 2013 in Buchanan County, Virginia while in law school. Given that it is a poverty-stricken county and community, I was given several opportunities to investigate potential child neglect cases by going into homes, talking to neighbors and addressing concerns of multiple family members. This culminated in reports that were considered by the juvenile court judge. While difficult, this was a satisfying position that gave me the opportunity to truly speak for those who would otherwise not have a voice.

From a young age, I have felt a need to serve and held a strong belief in civic duty. While in law school, I knew I wanted to give back to my community. I did not expect a circuit court opening in Sullivan County but quickly realized this was an opportunity to serve in a greater capacity.

A judge should be the most honorable person in a community. A community expects a judge to always uphold the law even when unpopular. Judicial service includes not only following the law but also ensuring a defendant's rights are not infringed and if guilty, that he receive an appropriate and proscribed punishment, tempered with mercy, when suitable, and rehabilitation if applicable.

Being a judge is one of the highest callings in a community. It is a solemn responsibility, one that I would take seriously with skill and strength, balanced with temperance and soberness.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

I seek the judgeship in Division II of the Circuit Court of the 2nd Judicial District. The geographic jurisdiction of this court encompasses Sullivan County, Tennessee. The Circuit Court Judge in Division II is assigned one of every three criminal cases and one of every five cases filed in Law and Chancery Courts in Bristol and Kingsport but does not include civil jury cases.

Because time is sensitive in most criminal and civil cases, I will work hard to be efficient in my disposition of cases while instilling honor and respect in the court. I will not allow the court to operate as one in which money, title, or family association takes preference over the application of the law, but, like in Buchanan County, Virginia, make sure that everyone is heard. Finally, I will uphold the law and will expect everyone who enters the court to do the same.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Upholding the law is the most important responsibility of any judge and I do not support judicial activism or legislating from the bench. Following the law as proscribed by the General Assembly provides consistency throughout the state, without which neither defendants nor victims can have faith in the judicial system. Consistency also allows a judge to decide fairly and with integrity for either the defense or the state, depending on the applicable law and circumstances of each case.

I will always strive to uphold the law promulgated by the General Assembly and interpreted by our appellate court system as well as the Supreme Court of the United States. An honorable judge's rulings should come from statutes, their plain meaning, higher court interpretations and. any rules or regulations higher courts or regulatory bodies create.

I have tried to live up to the principles of a District Attorney set forth in <u>Berger v. United States</u>: "[The District Attorney's] interest, therefore, in a criminal prosecution is not that it shall win a case, but that justice shall be done. As such, he is in a peculiar and very definite sense the servant of the law, the twofold aim of which is that guilt shall not escape or innocence suffer."

I do not recall a specific example where I have disagreed with the substance of the law and still upheld the law. I have always upheld the law to the best of my knowledge and ability.
