PROFESSIONAL BACKGROUND AND WORK EXPERIENCE

1. State your present employment.

Since 2006, I have operated my own office as a sole practitioner. Teresa Murray Smith, a retired Assistant District Attorney, in Sullivan County, TN maintains a presence in my office, of counsel.

2. State the year you were licensed to practice law in Tennessee and give your Tennessee Board of Professional Responsibility number.

I was licensed by the Great State of Tennessee in 1999. My B.P.R. # is 019761.

I am licensed to practice only in Tennessee state courts, and my license is active. I am additionally licensed to practice in the United States District Court for the Eastern District of Tennessee and the United States Supreme Court, and my license is active in these Federal Courts.

5. List your professional or business employment/experience since the completion of your legal education. Also include here a description of any occupation, business, or profession other than the practice of law in which you have ever been engaged (excluding military service, which is covered by a separate question).

During law school at the University of Tennessee, I had the privilege of working as a law clerk for Toppenberg & Burke, P.C., one of the premier domestic relation firms in Knoxville. While clerking, I was offered the opportunity to join the firm as an associate, and did so upon graduation and passage of the bar. From 1999 until 2003, I served as an associate with Toppenberg and Burke, P.C., and am grateful for the experience I gained there. To this day, I make a point to visit Mr. Toppenberg's office on each occasion I travel to Knoxville. Ms. Burke now serves as a Social Security Judge, having obtained a Federal appointment.

In 2003, I became engaged. Both my fiancé and I were from the Tri-Cities, and she was both

graduating from the Masters in Accounting program at the University of Tennessee and accepting employment at Eastman Chemical Company in Kingsport, TN. Further, our parents and family resided in the Tri-Cities, such that we made the decision to return to Sullivan County from Knoxville. Because I had previously clerked for the Sullivan County District Attorney's office, I was offered a position as an Assistant District Attorney by H. Greeley Wells, Jr., then the District Attorney for Sullivan County, TN. I served as an Assistant District Attorney for Sullivan County from 2003 until 2006.

Gen. Wells had a long-standing office policy that any Assistant District Attorney seeking elective office must resign. Accordingly, upon my decision to seek election to Circuit Court Judge, Part 2, the position for which I am presently applying, I resigned from the District Attorney's office. Gen. Wells accepted my resignation by letter, commending me for the service I provided Sullivan County.

While I won the Republican nomination, the incumbent Judge, R. Jerry Beck, was re-elected in the general election. I opened my solo practice shortly thereafter, and continue to maintain the same.

As it relates to other businesses in which I have ever been employed, I mowed yards for ONA Properties during my high school years (1984-1989). ONA Properties was a rental property partnership in Sullivan County. Then, while attending E.T.S.U., I worked at Sears Telecatalog in Boones Creek, TN, a division of the Sears company (1989-1994). I was hired as an Associate answering catalog order calls. I was then promoted to "Specialist," wherein I resolved customer service issues. In 1992, I was promoted to "Supervisor," where my duties consisted primarily of managing a team of Associates and Specialists. Sears closed the Telecatalog division in 1994, shortly before my enrollment at the U.T. College of Law. As an aside, it is interesting to note that among my former colleagues from Sears Telecatalog include present Washington County Chancellor, John Rambo, and Mark Fulks, a former Tennessee Assistant Attorney General, now with Baker-Worthington. Sears must have had an eye for potential legal.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

Prior to opening my solo practice, I worked at a domestic relations firm, and then the District Attorney's office. Family and Criminal law continue to dominate my present practice. I estimate that forty (40%) of my practice involves domestic relations. Similarly, I estimate forty percent (40%) of my practice involves criminal defense. Just as these two areas constitute the vast majority of my practice, they also constitute the majority of Circuit Court, Part 2's, workload.

I also practice probate litigation, and estimate that probate practice constitutes ten percent (10%) of my practice.

The remaining ten percent of my practice involves general civil litigation, the remaining practice area over which Circuit Court, Part 2, exercises jurisdiction.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

During my entire career, I have steadily focused on domestic relations law and criminal law. I focus my practice on these two areas because they are each litigation extensive, and I have always enjoyed the opportunity to be a true trial attorney.

At Toppenberg and Burke, P.C., in Knoxville, I tried dozens of non-jury cases before the Knox County Fourth Circuit Court and the Knox County Chancery Courts. I appeared primarily before Judge Bill Swann and Chancellor John Weaver, but practiced in the entirety of East Tennessee. I continue to practice before many of these Courts. While in Knoxville, I was also primarily responsible for the firm's Appellate practice and had the opportunity to personally appear before the Court of Appeals on numerous occasions. I successfully argued appeals on various topics concerning family law, including the jurisdiction of Juvenile Courts as it relates to the Grandparent's Visitation statute (an issue of first impression at the time); the procedural irregularities associated with temporary custody hearings (a successful interlocutory appeal); the presumption of paternity for non-biological parents; and the definition of "reasonable purpose" and "approximately equal time" as it relates to Tennessee's Parental Relocation Act. One of my appellate cases during this time period (1999-2003) resulted in a published opinion dealing with the transmutation of marital property and equitable distribution of transmutated property in a short term marriage.

When I returned to Sullivan County and joined the District Attorney's office, I immediately began prosecuting cases in the Sullivan County Criminal Court, appearing before Judge Phyllis Miller and Judge Beck. During this time period (2003-2006), I prosecuted the majority of the County's D.U.I. cases, and handled the most active docket in Sullivan County's Criminal Court, including the County's serious vehicular offenses and several vehicular homicide cases.

According to statistics maintained by the Governor's Highway Safety Office, I prosecuted, as the lead prosecutor, more than 500 cases. I also had the opportunity to work closely with my immediate supervisor, now Court of Criminal Appeals Judge, Robert Montgomery, from whom I

learned a considerable amount concerning trial preparation and evidentiary issues. Because Judge Montgomery resigned for elective office shortly before I did, Gen. Wells initially promoted me within the District Attorney's office to handle Judge Montgomery's former case load and to lead Sullivan County' FIRST team, the team which investigates all traffic fatalities. I was also under the supervision of Barry P. Staubus, now the District Attorney for Sullivan County, Tennessee.

Upon leaving the District Attorney's office, my private practice continued to be litigation extensive. Judge Montgomery had been elected to succeed Judge Phyllis Miller, and he shortly appointed me to several serious felony cases. In 2008, I handled more appointed felony work in Judge Montgomery's court than any other attorney. I have been the attorney of record in three (3) murder cases as defense counsel. I have also defended other Class A felonies, recently representing a Defendant charged with Rape of a Child before Judge Beck in 2016. After jury trial, my client was completely acquitted.

I continue to maintain a steady family law practice, trying divorces, contested adoptions, and other matters, primarily in Chancery Court and in Circuit Court, Part 2. I also accept appointed child support contempt cases before Sullivan County's Child Support Magistrate, and regularly appear before Ref. Onkotz to assist the Court in that regard. (Because my office is in Blountville, it saves A.O.C. funding to appoint an attorney who does not have to travel from Kingsport or Bristol to appear before the Court on these cases.)

In short, I am routinely present before Judge Goodwin or Judge Beck on criminal matters on almost every Miscellaneous or Motion day, and appear before one of the three civil judges on a consistent basis on civil dates. I also appear before the General Sessions Courts in Sullivan County, and before the trial and sessions courts in all of our nearby counties.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

During my entire tenure as an attorney, I have been fortunate to have been practiced litigation cases before the Courts of record. As indicated, at Toppenberg and Burke, P.C., I handled both trial level and appellate work, even though I was a newly licensed attorney. Thus, within five years of graduation from law school, I had participated in a published appellate opinion; successfully argued numerous cases before the Court of Appeals; and had participated in a million dollar jury verdict for one of my probate clients in a Will contest.

Upon opening my private practice in Sullivan County, it became evident that many of my former clients in Knoxville wished to continue to utilize my services. I additionally expanded my Northeast Tennessee practice well beyond Sullivan County. I have now practiced in over thirty (30) Counties across Middle and East Tennessee, and in the last twelve (12) months alone, I have appeared in over a dozen counties, stretching from Nashville to Mountain City. I greatly value this diversity of practice, as it has allowed me the opportunity, literally, to appear personally before more than one hundred (100) separate Judges. This unique perspective allows me the opportunity to observe, and learn. By practicing before so many Judges, I see what works, and what needs work.

By way of example, when I was hired as an Assistant District Attorney, the specific purpose of assigning me to D.U.I. and traffic cases was to reduce the amount of time that these cases remained "open," clogging up the Criminal Court docket. Prior to my hiring, these cases often remained open for a year or longer.

As Sullivan County's D.U.I. Prosecutor, I drastically reduced that amount of time. According to statistics maintained by the Governor's Highway Safety Office, after one year, these cases were concluded two months faster than they were prior to me joining the office. By the time I left the District Attorney's office, the average had dropped almost in half. Additionally, conviction rates for D.U.I. increased, largely due to the extensive training that I, and others in the District Attorney's office, provided local law enforcement. I was Sullivan County's first D.U.I. prosecutor, and the office continues to maintain that position. I believe the effort and results I generated, with the support and guidance of Judge Montgomery, Gen. Staubus, and others, laid the groundwork for the continuation of this successful program.

While I was with the District Attorney's office, I tried more jury trials than any other lawyer in Sullivan County, either civil or criminal. I additionally led the District Attorney's office each year in the number of jury trials conducted (2003-2006). Sullivan County Criminal Court statistics available as of May, 2014 demonstrate that from 2004 through 2014, I tried more criminal court jury trials than any other practicing private attorney.

Because of my experience in trying serious felony offenses, including 1st degree murder, I obtained my Rule 13 death penalty certification. Upon information and belief, I am presently the only Death Penalty certified private attorney in Sullivan County. I am also the only Sullivan County attorney who has both prosecuted and defended homicide cases.

Finally, due to my trial experience, I have been trusted by various Courts to serve in a judicial capacity. I was appointed Special Master by Judge Bill Swann to preside over Order of Protection trials in Knox County Fourth Circuit Court. Likewise, I have been appointed to serve as a substitute Judge in each of Sullivan County's four General Sessions Courts.

9. Describe any other legal experience, not stated above, that you would like to bring to the attention of the Commission.

Because of my experience in domestic relations law and criminal law, I have often been asked to present for various legal organizations. I have taught family law CLE seminars for the National Business Institute and the Legal Aid Society of East Tennessee in Knoxville. In Sullivan County, I have taught classes for the Governor's Highway Safety Office, the Bristol, TN Police Dept., and the Sullivan County Sheriff's office. I have also presented on behalf of the TN District Attorney's General Office at numerous training events throughout the State.

I consistently fulfill my professional obligation to expand access to Justice. I participate in Sullivan County's *pro se* day, wherein private attorneys assist the local courts administer *pro se* divorces, Orders of Protection, and the like. I have also volunteered to accept *pro bono* work through Legal Aid Society of East Tennessee, and perform considerable Criminal and Appellate work on a *pro bono* basis.

10. List and describe all prior occasions on which you have submitted an application for any state or federal judicial position.

In 2003, I applied for a position with the District Attorney's office for the Second Judicial District in Sullivan County, Tennessee. District Attorney General H. Greeley Wells, Jr., accepted my application and hired me as an Assistant District Attorney. I have applied for no other State or Federal position.

I attended college at East Tennessee State University, commencing in the Fall of 1989, graduating in 1996. I received a B.S. in Political Science, with a minor in History. While in college, I was a member of the Sigma Chi fraternity, serving as historian, secretary, and President, and received the Balfour Award for Outstanding Senior for the East Tennessee Province, consisting of E.T.S.U., Tennessee Tech., U.T.C., and U.T.K. I was a member of numerous greek letter scholastic honor societies.

I was additionally active in student government, serving as a campus host for new students and as an academic advisor.

I was a Dean's List recipient, and taught several seminars through the sponsorship of the Student Government Association relating to student life and scholastic balance.

Thereafter, I enrolled at the University of Tennessee College of Law, graduating in 1998. While at U.T., I was selected to serve on the Moot Court Board. I was awarded an individual award for oral argument performance in U.T.'s annual Advocate's Prize Appellate Practice competition. I was invited to the U.T. College of Law Honors Banquet based upon my academic performance.

In November of 1994, I pled guilty to reckless driving in Bristol, TN. I was subsequently hired by the same District Attorney's office that prosecuted this offense, after full disclosure of

19. Please identify the number of formal complaints you have responded to that were filed against you with any supervisory authority, including but not limited to a court, a board of professional responsibility, or a board of judicial conduct, alleging any breach of ethics or unprofessional conduct by you. As an attorney who handles emotionally charged family law and criminal law matters, I have had complaints filed against me with the Board of Professional Responsibility (or the C.A.P.), both from former clients and opposing parties, all of which have been dismissed. In the ~ five (5) years I practiced in Knoxville, I had one B.P.R. complaint filed against me by a client who I refused to accept money from to file an unnecessary lawsuit on her behalf.

In Sullivan County, I had two criminal clients (both charged with murder) file B.P.R Complaints. Often, incarcerated clients are advised by "jailhouse lawyers" to file complaints in order to justify a post-conviction appeal. I have had two civil clients file formal Complaints, each of which has been dismissed. (One of these clients filed three complaints related to three different lawyers in a single divorce).

I have had two cases dismissed by the C.A.P. prior to reaching the formal complaint stage, one from an opposing party who wished to harass me to the point that I would refuse to represent his former spouse. (I continue to represent his former spouse, and advised the C.A.P. that I believe this complaint to be a "badge of honor.")

In a recent case before the Court of Criminal Appeals, I advised the Court of Criminal Appeals that a client who had instructed me to file an appeal on his behalf had ceased to communicate with me, or fulfill his financial obligation. Nonetheless, I did not file a Motion to Withdraw with the Court of Criminal Appeals, because the filing of the Motion would result in a revocation of my client's bond and his immediate incarceration. I did not feel, as my client's attorney, that I should participate in any action which would subject him to jeopardy or incarceration. Because I did not file a brief within the time prescribed by the Court of Criminal Appeals, though, the matter was referred to the Board, and I provided the Board with all relevant information and have fully cooperated with the Board's investigation. I believe with the waiver attached hereto, the Commission can review the information provided to the Board and the Court of Criminal Appeals, and readily discern that despite the fact that my client has failed and refused to communicate with me or fulfill his obligation that I have fulfilled my obligation by continuing my representation of him before the Court of Criminal Appeals.

20. Has a tax lien or other collection procedure been instituted against you by federal, state, or local authorities or creditors within the last five (5) years? If so, give details.

Until opening my private practice, I had no experience in the operation of an ongoing business. Until that point in time, I had always been employed as a W-2 wage earner. Thus, during the operation of my private practice, like many small business owners, there have been occasions when a tax lien has been instituted. On these occasions, I have openly communicated with the appropriate authorities to determine wherein the problem lied, and the best manner in which to rectify the same. No present state tax lien exists.

As it relates to Federal taxes, a tax lien was instituted in 2014 owing to issues surrounding the 2014 divorce. I have worked closely with IRS Revenue Agent Shane Murray(Johnson City office) and we recently entered into a settlement agreement concerning the same. As of the 1st quarter of 2017, all Federal reports and returns were current, with the lien to be lifted upon satisfaction of the settlement agreement.

No other collection proceedings have been implemented.

I was amicably divorced in 2014, in the matter of *Curtis v. Curtis*, Sullivan County Chancery Court, docket number C0017877. The divorce was based upon the grounds of irreconcilable differences, and my former spouse and I entered into an agreed Permanent Parent Plan and a Marital Dissolution Agreement. We have had no post-divorce litigation. For additional information, I was represented by Teresa Murray Smith and my former spouse was represented by Lisa Nidiffer Rice, presently serving as Criminal Court Judge for Washington County, TN. Despite the personal nature of this litigation, I would have no objection to members of this Committee contacting either my former spouse (now, Michelle Thomas Neshat) (423) 943-5266) or Judge Rice to verify the circumstances of this divorce.

In 2013, a former client and I engaged in a lawsuit centering around a fee dispute. The Complaint and Counter-Complaint were both voluntarily dismissed. *Curtis v. Johnston*, Sullivan County Circuit Court, No.: C 3607.

ESSAYS/PERSONAL STATEMENTS

28. What are your reasons for seeking this position? (150 words or less)

In high school, I took advanced history. A friend and I selected that class because there were several pretty girls, and no other boys. The class competed in a Constitutional Bicentennial contest, so we studied the Constitution in great depth.

I fell in love. Not with one of the pretty girls, but with the Constitution. That affection dictated my career course. Thus, it pains me to see that some Judges no longer feel bound by the law, as evidenced by Judge Richard Posner's recent commentary on the role of the Judiciary. I believe the will of the Legislature and Constitutional principles are worth defending and deserve a zealous Judicial advocate. I believe this advocate must have diverse experience and a proper understanding of the role of the judiciary. In Sullivan County, I believe I am uniquely qualified to serve as that advocate.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

Sullivan County is a county-wide judicial district, with courts in Blountville, Kingsport, and Bristol. Circuit Court, Part 2, is the *only* Court of record adjudicating civil and criminal cases. It handles one-third of the criminal docket, but criminal cases constitute two-thirds of Part 2's docket (985 of 1552 of cases in 2016).

The fact that Part 2 handles both Civil and Criminal cases limits the number of individuals who would be a successful Judge. I have prosecuted a busy criminal docket, and handle many civil cases on a weekly basis. I have appeared before the Court on behalf of the State, the Criminal Defendant, and the civil Plaintiff and Defendant. Thus, my selection would allow the continued presence of a lawyer who has considerable trial experience in both civil and criminal law and the ability to handle the present case load--effective as of day one.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

I firmly believe a Judge's role is to apply the law, as written. This conviction is so strong that I often take issue when we use the phrase, "interpret the law." Accordingly, a Judge's disagreement with the substance of the law does not constitute a valid reason to ignore, expand, or limit the law.

As an Assistant District Attorney, I prosecuted numerous cases even though I personally disagreed with the substance of the law. As a firm supporter of the Second Amendment, I disagree with the substance of Tennessee's "going armed" statute. I believe the statute interferes with our Constitutionally protected right to bear arms. The statute, however, was duly enacted and has been upheld many times by our Courts. Therefore, I prosecuted these cases when supported by the facts.

Similarly, in my civil practice, I argue the Sullivan County Local Rules as it relates to Domestic Relations cases are improper. I believe they contradict Tennessee's Parenting Plan statute, and place an undue burden on the citizens of Sullivan County *vis a vis* residents of neighboring counties. Suffice it to say, I disagree with the substance of these Rules. In one instance, I successfully appealed, by way of interlocutory appeal, the application of these Rules. To the extent, though, that the Local Rules remain in effect, I am compelled to comply with the same. Accordingly, I dutifully comply with the Local Rules, even though I disagree with the substance of the same.
