MOTION FOR LEAVE TO PROCEED IN FORMA PAUPERIS

Petitioner moves for leave to file the attached petition for a writ of certiorari without prepayment of costs and to proceed *in forma pauperis*. In support of this motion, Petitioner states:

1. Petitioner is an inmate in the custody of the Tennessee Department of Corrections under sentence of death. The death sentence was recently affirmed on direct appeal by the Tennessee Supreme Court. *State v. Holton*, 126 S.W.3d 845 (Tenn. 2004).

2. Petitioner has previously been declared to be indigent and permitted to proceed *in forma pauperis* in the Tennessee Supreme Court, the Tennessee Court of Criminal Appeals, and the Circuit Court for Bedford County, Tennessee.

3. A copy of a Uniform Affidavit of Indigency executed by Petitioner on December 16,1997 N. CEIVER STATE ATTORNEY CENERAL

is attached to this motion. Petitioner asserts that the affidavit substantially complies with the requirements of the Rules of the United States Supreme Court, Rule 39. Petitioner's financial status has not altered since December 16, 1997 due to his continuous incarceration since that time. As recently as January 5, 2004, Petitioner was found to be indigent. *State v. Holton*, 126 S.W.3d at 869. Respondent did not contest that finding.

4. Petitioner has refused to meet with representatives of undersigned counsel who have attempted to visit Petitioner to speak with him and secure a more recent affidavit.

5. Since Petitioner has not communicated with undersigned counsel regarding this matter, undersigned counsel is filing this motion, as well as the Petition for Writ of Certiorari, pursuant to *Martinez v. Court of Appeal of California, Fourth Appellate District*, 528 U.S. 152, 120 S.Ct. 684, 145 L.Ed.2d 597 (2000).

Wherefore, Petitioner respectfully requests that this Court grant him leave to proceed *in* forma pauperis and any other relief the Court deems just.
