2. Ever since the time of the name change, Mr. Hall has used the name "Lee Hall." Among other things, the name "Lee Hall" is used for filing State and Federal tax returns and Mr. Hall's Social Security card bears that name.

3. Mr. Hall has requested counsel to file this motion to amend the style of the case with his correct and legal name so that litigation regarding his demise will

accurately reflect his identity and so that his family can insure that his gravestone will bear his true name.

WHEREFORE, Mr. Hall respectfully asks that the case style be changed to "State of Tennessee v. Lee Hall."
