ORDER APPOINTMENT OF COUNSEL TO JASON AUTRY

This matter came before the Court on March 21, 2025, for a hearing on various motions filed by the parties, including several motions related to Petitioner's co-defendant, Jason Autry. Based upon the pleadings and information already in the record on Jason Autry's potential testimony in this proceeding, this Court finds there are certain issues related to Mr. Autry's constitutional rights and his attorney/client privilege,¹ as well as potential consequences should Mr. Autry choose to testify.

Therefore, this Court concludes it is necessary to appoint counsel to Mr. Autry for the limited purpose of advising Mr. Autry concerning these rights and potential consequences. Accordingly, this Court hereby APPOINTS attorney Ben Harmon as counsel for Jason Autry for this limited purpose.

Attorney Harmon shall contact Jason Autry and advise him in accordance with this order. Following this meeting, Attorney Harmon shall file a notice with this Court by April 11, 2025,


