## **Consecutive Exercise**

<u>JUDGE</u>: We have returned from our break. Everyone is present including the witness, attorneys, court reporter, and court interpreter. At this time, we will continue with the testimony of the defendant.

<u>PROS</u>: Thank you your honor. Mr. Davis, is it your testimony that you were out having drinks at the local bar around the time of your wife's murder?
