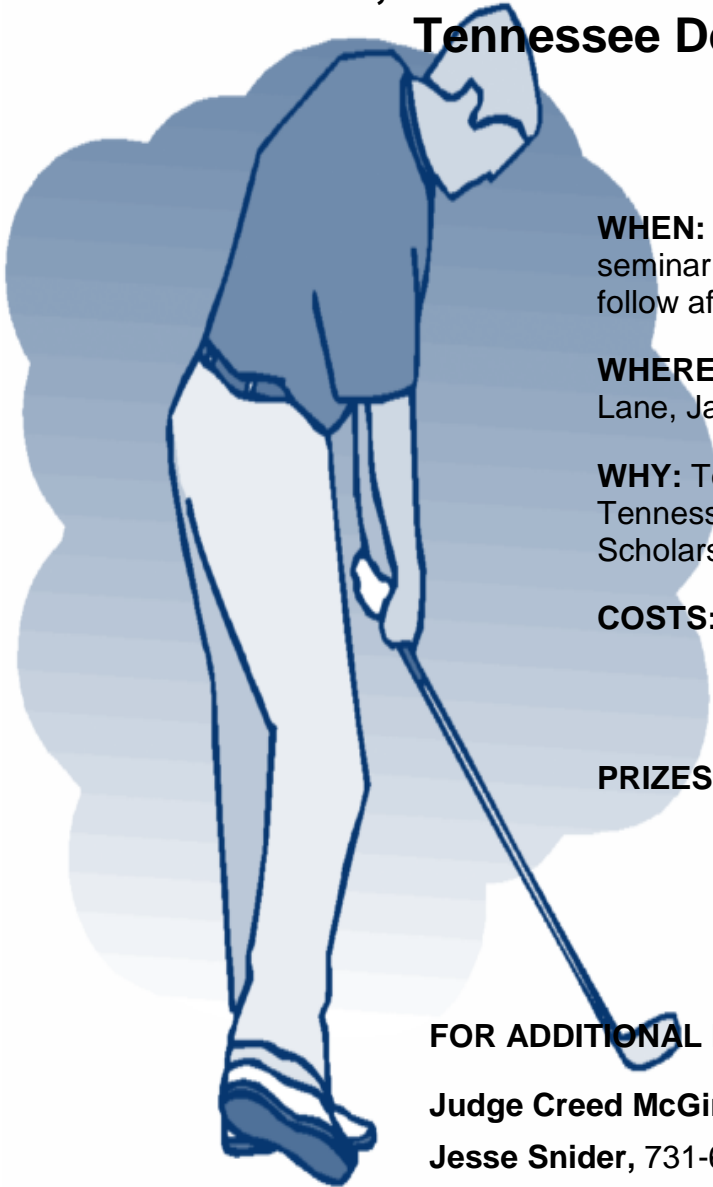


19th Annual Dick Jerman Memorial Golf Tournament
