## DL Suspensions for Non-Payment of Traffic Costs

TCA 55-50-502 (j)

√ Effective: 7/1/2019

√ Implemented: 7/1/2021

## DL Suspensions for Non-Payment of <u>Traffic</u> Costs Requirement...

#### Requires payment plan on any that do not pay in full.

The court shall require every licensee who is convicted of a driving offense and who does not pay the assessed fines and costs in full on the date of disposition to make payments pursuant to an installment payment plan.

# DL Suspensions for Non-Payment of <u>Traffic</u> Costs Requirement...

#### Amount of payment must be what the defendant can pay.

The clerk of any court that handles traffic citations shall offer a payment plan, which must be reasonable and based on a person's income and ability to pay, to any person convicted of a driving offense.

## DL Suspensions for Non-Payment of <u>Traffic</u> Costs Requirements...

If the defendant requests a lower payment amount, the clerk must reset the amount due.

A person may request, and the court clerk shall grant, modifications to a payment plan upon a change in the person's financial circumstances or upon good cause shown.




# DL Suspensions for Non-Payment of <u>Traffic</u> Costs Requirement...

Defendant can be re-reported over and over again.

#### DL Suspensions for Non-Payment of <u>Criminal</u> Costs Requirement...

#### Requires payment plan on any that do not pay in full.

Any person who is issued a license under title 55 and who has not paid all litigation taxes, court costs, and fines assessed as a result of disposition of any offense under the criminal laws of this state within one (1) year of the date of the completion of the sentence shall enter into an installment payment plan with the clerk of the court ordering disposition of the offense to make payments on the taxes, costs, and fines owed.



## DL Suspensions for Non-Payment of <u>Criminal</u> Costs Requirement...

DL cannot be suspended until 1 year after he/she has completed their sentence.

## DL Suspensions for Non-Payment of <u>Criminal</u> Costs Requirement...

#### DOS to send a 30 day notice

Once reported for non-payment, DOS will send notifications to the defendant and the defendant <u>MUST</u> comply within 30 days of letter being sent, by making a payment to the court and submitting withdrawal documentation to DOS.



#### DL Suspensions for Non-Payment of <u>Criminal</u> Costs Requirement...

Defendant may apply to the court and get an order for restricted license.

#### DL Suspensions for Non-Payment of <u>Criminal</u> Costs Requirement...

#### Law also provides for indigently affidavit being filed

Court to determine if taxes, fines and cost should be suspended. After reevaluation, if the court finds the person cannot pay, cost can be waived by the court.


