




- DNA Database with DNA profiles
- Arrestee and Convicted Offender samples
- DNA Casework samples
- Missing Persons samples

CODIS LAW IN TENNESSEE

- TCA 40-35-321
 - Collect DNA from every convicted offender for felonies
 - Collect DNA from anyone (felony or misd.) on the SOR
 - Collect DNA from people arrested for certain violent felonies

- TCA 40-35-321 puts responsibility on clerks to notify the TBI of final disposition of a case
 - The clerk of the court in which the charges against a person described in subdivision (e)(1) are disposed of shall notify the bureau of final disposition of the criminal proceedings. [section (e)(2)]
- TN is an "automatic" expungement state (according to the FBI)
 - This means the offender/arrestee does not have to apply to have their DNA expunged, it is done without their intervention



WHAT DOES CODIS NEED FROM YOU?

- Any final judgements from certain violent felonies
- Any post-conviction expungements (acquittals, appeals, etc)
- This can be in any form but the following is required:
 - Name
 - DOB
 - SSN or SID
 - Arrest Date
 - Offense
 - Final disposition
