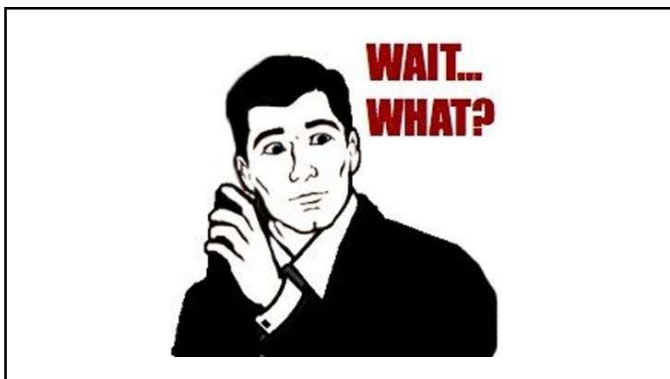

Congress **shall make no law** respecting an establishment of religion, or prohibiting the free exercise thereof; **or abridging the freedom of speech, or of the press**; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.

U.S. Const. amend. I.

**...No State shall make or enforce any law which shall abridge the privileges or immunities of citizens of the United States**; nor shall any State deprive any person of life, liberty, or property, without due process of law; nor **deny to any person within its jurisdiction the equal protection of the laws.**

**Freedom of speech and press; defamation**

That **the printing presses** shall be free to every person to examine the proceedings of the Legislature; or **of any branch or officer of the government, and no law shall ever be made to restrain the right thereof.** The free communication of thoughts and opinions, is one of the invaluable rights of man, and **every citizen may freely speak, write, and print on any subject**, being responsible for the abuse of that liberty. But in prosecutions for the publication of papers investigating the official conduct of officers, or men in public capacity, the truth thereof may be given in evidence; and in all indictments for libel, the jury shall have a right to determine the law and the facts, under the direction of the court, as in other criminal cases.



"This is a public building/place and I have a right to videotape and record!"

"Although the phenomenon emerged as a way to monitor police activity, First Amendment Auditors [ ] began exploring other possibilities, since the language of the federal cases found a First Amendment right to film "public officials" in "public places." **By slightly expanding the original meaning of those words**, First Amendment auditors **claimed the right to film public employees going about their business in public buildings.**"

What is a PUBLIC FORUM?

1. Traditional Public Forum - "namely, public streets or parks—speech restrictions must be ‘narrowly tailored to serve a compelling government interest.’ "

2. Designated public forum - "which exists 'if government property that has not traditionally been regarded as a public forum is intentionally opened up for that purpose.'" (same restriction standard as traditional public forum)

3. "a limited public forum (also called a nonpublic forum)—namely, 'a forum that is limited to use by certain groups or dedicated solely to the discussion of certain subjects'—then speech restrictions need only be 'reasonable and viewpoint neutral.'"

*Am. Freedom Def. Initiative v. King Cnty.*, 577 U.S. 1202, 136 S.Ct. 1022(Mem), 194 L.Ed.2d 376(Mem) (2016)

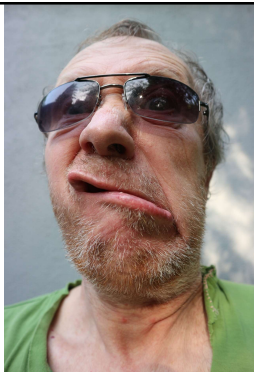

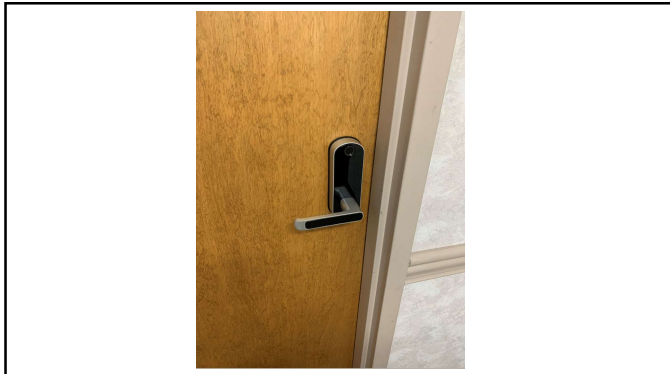
