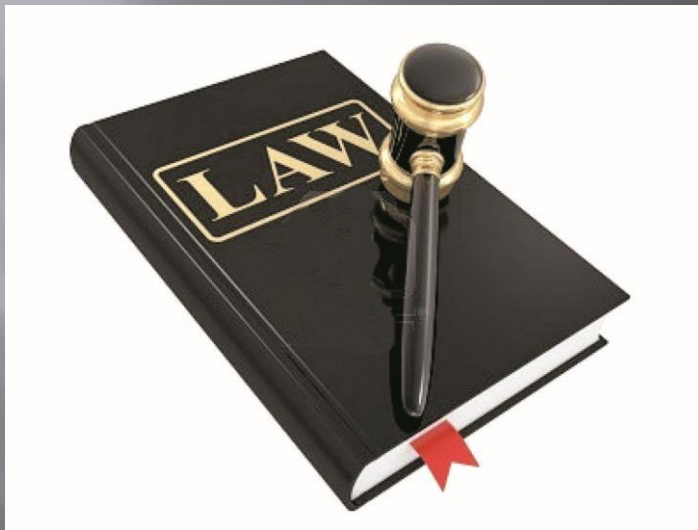

Why Do We Have FCRB?



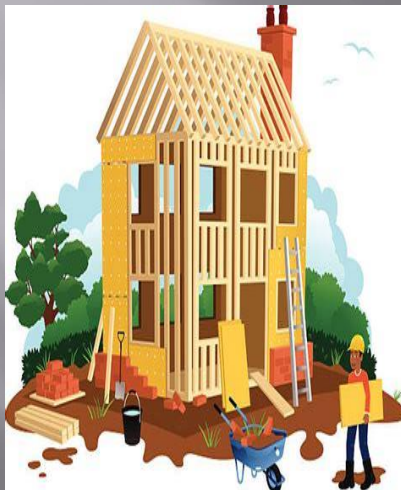

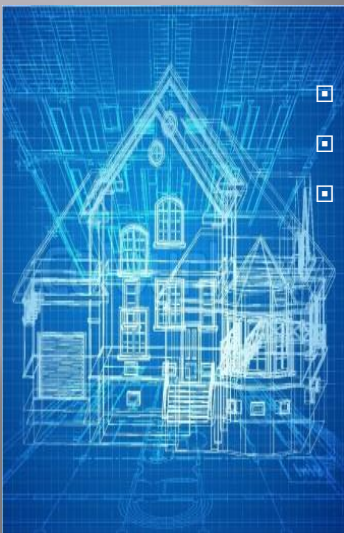


Construction Hazards

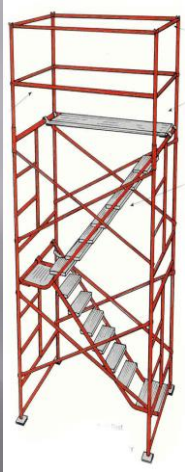
Scaffolding – Permanency



The path to permanency.

- ▣ Return to parent
- ▣ Exit Custody with relative
- ▣ Adoption
- ▣ Permanent Guardianship
- ▣ Planned Permanent Living Arrangement (PPLA)

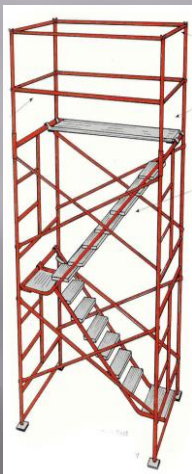
Scaffolding – Well-Being Health



Addressing health needs comprehensively

- ▣ Medical, dental, mental, vision, nutritional
 - Annual and follow-up appointments
 - Specialists
 - Aides/devices
- ▣ Medication
 - Protocol
- ▣ Cross sections with other well-being domains

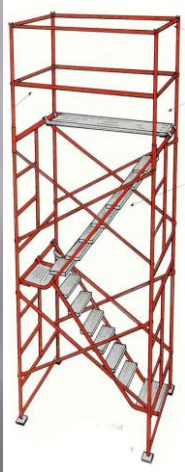
Scaffolding – Well-Being Education



Addressing education needs comprehensively

- ▣ Progressing with educational goals
 - Grades
 - Attendance
 - Credits
 - Additional Supports
- ▣ IEP/504
- ▣ Extracurricular
- ▣ Cross sections with other well-being domains

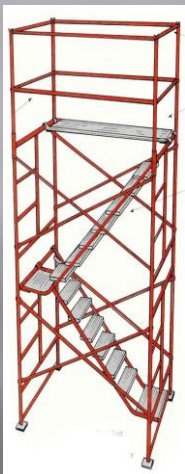
Scaffolding – Well-Being Visitation



Addressing visitation needs comprehensively

- ▣ Purpose of visitation
 - Maintain/strengthen relationship
 - Teach skills
 - Establish relationship
- ▣ Quality of visitation
 - Location
 - Frequency/duration
- ▣ Cross sections with other well-being domains

Scaffolding – Well-Being IL Skills/Transition Planning



Addressing independent living needs comprehensively

- ▣ Skill sets needed to transition from secondary education
- ▣ Planning for the future
- ▣ Funding for normalcy and extracurricular activities
- ▣ Cross sections with other well-being domains

Inspections

Monitoring Compliance
of the parties:

- Degree of weight assigned to the responsibility
