May 1985- began to practice as an Associate of Dicken E. Kidwell in the private practice of law in Murfreesboro, Tennessee, in the 16th Judicial District, which includes Rutherford and Cannon Counties. I have practiced in a continuing fashion and maintained my association with Dicken E. Kidwell in private practice through the current date. As of January 1, 2009, I became the Managing Counsel of our Association of Attorneys and currently maintain a private practice as associated with Dicken E. Kidwell, Gary D. Beasley, and David O. Haley. Immediately after graduation from law school, I worked and was employed by the Equitable Insurance Company for a period of several months prior to my move back home to Murfreesboro to begin my practice of law. I have not engaged in any profession or employment experience other than the practice of law since May 1985.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

My practice is concentrated in the area of domestic relations. I have handled and maintained a practice in all areas of civil practice to include business disputes, personal injury matters, federal civil rights action, and previously maintained a significant workers' compensation practice. During the last twenty years of my practice, up through the present, my practice has been concentrated in the area of divorce/domestic relations to include all aspects of divorce, post-divorce, parenting plan modifications, and appellate work associated with divorce matters. I would estimate that 85% of my practice is associated with domestic relations causes of action.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

Beginning in 1985, I maintained a general practice which largely encompassed domestic issues, workers' compensation issues, and personal injury matters. I handled criminal matters for approximately 12-14 years at the beginning of my practice but have not practiced in criminal court since approximately 2000. Beginning in approximately 1995, my practice shifted and I began a practice which largely concentrated in the area of domestic relations. I developed an extremely strong niche and referral business in the area of domestic relations and as a result have practiced regularly before the trial courts in Rutherford and Cannon Counties, and would respectfully suggest I have presented as many divorce/domestic matters at trial within this district as any practicing attorney within the last twenty years. My domestic practice has led to the trial of matters in surrounding counties, and further has led to the involvement of a significant number of appellate presentations to include briefs and oral arguments. I regularly mediate domestic disputes both as counsel and acting as mediator in pending domestic disputes.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

I was trial counsel in the reported case of Adelsperger vs. Adelsperger, 970S.W.2d.482, Court of Appeals, Middle Section at Nashville. This was a child relocation and modification issue. My client prevailed at the trial level and the Court of Appeals reversed. This matter is often cited regarding what constitutes a material change of circumstance in child relocation cases. It further describes the evidentiary necessities of a substantial change in circumstances necessary to deny relocation. It is respectfully submitted that the case has been frequently cited and provided a

platform for the Appellate Courts to clarify evidentiary issues and burdens of proof in relocation matters. The more recent Supreme Court ruling in Armbrister vs. Armbrister, 414S.W.3d.685, has provided further clarification.

I was trial counsel in the matter of John and Tammy Gibson vs. Shannon Gibson, Civil Action No. 58036 in the Rutherford County Circuit Court. This was an appeal of a dependency and neglect finding. I was able to utilize the extensive evaluation of a clinical psychologist to support a finding of substantial harm to the child if she were returned to the care of her mother. The matter was appealed and the Court of Appeals upheld the trial court's finding, specifically noting the extensive evaluation and professional findings of the child psychologist. This matter was not reported.

I have recently represented three juveniles and their parents in Federal Court alleging violation of their civil rights as a result of the arrest of elementary children in school, including the handcuffing of an elementary student without any notice to their parents. This case, 3:17-cv-00369, U.S. District Court, Middle District of Tennessee, was brought against the City of Murfreesboro and individual officers. As lead counsel, I was able to help secure a significant settlement on behalf of the plaintiffs. I respectfully submit that this lawsuit has helped further provide for the modification of the arrest policy concerning juveniles with the City of Murfreesboro.

My strong interest in government dates back to the pursuit of my Political Science degree. My highest professional goal is to provide an accessible legal system that gives each member of our community equal access to opportunity for justice. I believe this to be at the heart of an effective government with judicial leadership.

My professional and personal experiences, which have shaped my temperament and personality, have served me favorably while handling a vast array of domestic issues, most of which present extreme emotional issues on behalf of not only clients, but also attorneys. This combination of experiences and temperament provide a positive platform necessary to be a Circuit Court Judge. I consider an appointment to this position an unparalleled opportunity to provide a vital public service to our community, as well as satisfy my longstanding interest in providing access to a fair and just legal system.

- 29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)
 - I am seeking appointment as a Circuit Court Judge for the 16th Judicial District, Part III, Rutherford and Cannon County, Tennessee. The 16th Judicial District maintains a sitting Chancellor and four Circuit Court Judges. The judgeship, as vacated by the Honorable M. Keith Siskin, was hearing civil matters, comprised largely of domestic issues.
 - During last twenty years of my practice, I have concentrated heavily in the field of domestic relations and divorce. I have tried hundreds of cases before our sitting Judges and Chancellor. My background and knowledge concerning the preparation and trial of domestic relations matters would be extremely beneficial in handling the existing and continuing docket. I would be in a position to immediately accept and respond to issues which comprise the overwhelming portion of the existing docket, all to the benefit of the local Bar, community, and sitting Judges.
- 30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

I would uphold the law regardless of my personal beliefs. I take an oath to do so and plan to honor that oath if I were to be appointed to the existing judgeship. Practicing in the field of domestic relations, I am frequently presented with matters where emotional and personal real-life circumstances of my clients appear to present a conflict with the law. Such examples include: relocation matters under T.C.A.§ 36-6-108. Often, when considering the parent/child relationship, there is a very real emotional basis to deny the relocation. However, an application of the existing statutory and case law most often provides for the opportunity of relocation. Further, there have been times when a termination of parental rights would appear to present a very real positive life improvement on behalf of a child. However, the law requires an initial showing of very strict statutory grounds and evidentiary burdens for termination, which would obviously be a duty to both uphold and follow.

Lastly, I have on many occasions after explaining statutory provisions concerning grandparents' rights been required to advise potential clients that there is not an appropriate action to file on their behalf after consideration of the statutory constraints.

Each of these matters present specific factual examples wherein one might disagree with the substance of both statutory and case law. I have certainly taken great pride in advising my clients and pursuing such matters while following the statutory requirements of the law with the understanding of precedential case law.
