Since the completion of my legal education I have been an associate and, subsequently, a partner, with the law firm of Hudson, Reed & McCreary, PLLC, and its predecessor entities. Since 2004, I have also served as city attorney for the City of La Vergne. In addition to the practice of law, I own investment property. Prior to the completion of my legal education in 2001, I worked as a runner/law clerk for various lawyers. During my last year of law school, I served as law clerk to the Honorable Robert L. (Butch) Childers, Judge of Division IX of the Circuit Court for Shelby County, Tennessee.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

I have practiced law for sixteen (16) years, and over that time I have developed a diverse law practice. I generally litigate civil cases and provide legal counsel to individuals, local government and business entities. The percentage of the major areas of law in which I practice fluctuates at any given time, but I would estimate that approximately 30% is related to domestic relations matters, and the balance, or approximately 70%, would fall generally under the umbrella of general civil matters, which include, for example, tort/damages, eminent domain (condemnation), employment law, civil rights, contracts, business, real estate and local government matters.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

I have had the privilege of representing clients in a diverse array of matters over the course of my career. I have litigated cases in the General Sessions, Circuit and Chancery Courts of this state, the Tennessee Court of Appeals, the United States District Court for the Middle District of Tennessee, the United States District Court for the Eastern District of Tennessee, and the United States Court of Appeals for the Sixth Circuit. I have tried multiple bench and jury trials in state court, both as first and second chair. I have represented clients in a wide range and variety of matters, including, but not limited to, the following types of matters: divorce, child custody, parental relocation, child support adjustment, civil and criminal contempt of court, eminent domain, employment discrimination, civil rights violations, municipal zoning and planning, writs of certiorari from administrative bodies, breach of contract, personal injury, wrongful death, professional malpractice, fraudulent misrepresentation, various tort/damages actions, requests for injunctive relief; drafting of legal opinions ordinances and regulations, reviewing and drafting contracts, and providing general legal advice to individuals, local government and business entities.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

Two relatively recent examples which illustrate the range of my experience, the depth and breadth of my legal knowledge, and my work habits, involve cases I litigated in the Circuit Court for Rutherford County and subsequently in the Tennessee Court of Appeals.

The first matter involved alleged personal injury and damages in which the plaintiff sought \$350,000 in damages against Rutherford County government. I represented Rutherford County. The primary issue involved whether or not the facts supported the county's position that it had discretionary immunity, or in the alternative, whether the facts supported the plaintiff's claim that the county was negligent. Both issues of fact and law were hotly contested. Fifteen (15) depositions were taken, and four (4) of the depositions were of medical experts. I was involved in every aspect of the case, from beginning to end, including the preparation of pleadings, discovery, briefs, presentation at trial, post trial review, and appellate briefing and argument. A bench trial was conducted on August 5, 2015. At the conclusion of trial, based upon the evidence and the law that I worked very hard to collect and present, the court found that the county did have discretionary immunity, and also ruled that, even if it did not have discretionary immunity, the county was not negligent. Judgment was entered in favor of the county. The plaintiff appealed to the court of appeals, and the court of appeals affirmed the judgment on December 15, 2016, in *Linda K. Guthrie v. Rutherford County, Tennessee, et al.*, No. M2015-01718-COA-R3-CV.

The second matter involved alleged damages to real property in connection with the construction of a road project. I, along with Ed Wallis, Sr., of Jackson, Tennessee, represented Dement Construction Company ("Dement"). Dement was accused of being liable for the alleged damages. The case was litigated over the course of several years, and involved extensive expert proof from engineers, soil scientists and real estate appraisers. As was the case in the example above, I was involved in every aspect of the case, from beginning to end, including trying a five (5) day jury trial with my co-counsel. The jury returned a verdict in favor of my client, and judgment was entered accordingly. The judgment was appealed to the court of appeals, and the court of appeals affirmed the judgment on December 20, 2016, in *Dement Construction Company, LLC v. Lucas C. Nemeth, et al.*, No. M2015-02204-COA-R3-CV.

9. Describe any other legal experience, not stated above, that you would like to bring to the attention of the Commission.

While in law school I worked as a law clerk for the Circuit Court for Shelby County, Division IX, which was (and still is, to my knowledge) a court with jurisdiction over civil matters in Shelby County. I observed the practice of law from the perspective of a circuit court judge. I read and reviewed motions and other pleadings filed with the court and assisted the court in analyzing the law and the legal positions of the parties. I assisted the court with applying the law to the facts and assisted with drafting opinions and orders.

As chairman of the Tennessee Higher Education Commission, I am legally responsible, along with my fellow commissioners, for discharging the statutory duties and responsibilities bestowed upon us by the legislature and the governor. This involves a wide-variety of responsibility: from authorizing new postsecondary institutions to operate in Tennessee, to adopting rules and regulations governing higher education, to protecting the public from substandard, transient, deceptive or fraudulent institutions and practices.

I received my law degree from the University of Memphis in 2001 where I was a member of the Moot Court Board and received the Dean's Award for Academic Excellence in Trial Advocacy.

Yes. I was divorced from my first wife in 2006. (Bedford County Circuit Court, #10600.) In 2004 my automobile insurance company brought a subrogation action in my name against the person at fault for an automobile accident. (Davidson County General Sessions #04GC16635, and Davidson County Circuit Court #05C2489.) Because it was a subrogation action I do not recall actively participating in the case, and I do not know what the ultimate disposition was. In 2000, I decided to take-up duck hunting as a hobby. I purchased my hunting license, but I forgot to purchase a duck stamp to go with the hunting license, and on the first day I hunted that season I received a ticket in Lauderdale County, Tennessee for not having a duck stamp. I subsequently purchased the duck stamp and the ticket was dismissed. (Lauderdale County General Sessions #53833.)

I was elected to chair the commission on January 29, 2015, when Randy Boyd resigned to become commissioner of the Tennessee Department of Economic and Community Development. I was recently re-elected to chair the commission on July 27, 2017.

I was nominated and accepted as a member of the Tennessee Bar Association Leadership Law program, class of 2010, and the Leadership Middle Tennessee program, class of 2012. I was named a Fellow of the Young Lawyers Division of the Tennessee Bar Association in 2012. I received the Murfreesboro Young Professionals Award in 2015.

I was appointed to the Tennessee Higher Education Commission by Governor Haslam in July of 2012. I was elected to chair the commission by my fellow commissioners on January 29, 2015, and I was recently re-elected to chair the commission on July 27, 2017. I served as town attorney for the Town of Bell Buckle from 2006 to 2008. It was an appointed position. I was appointed city attorney for the City of La Vergne in 2004 and still presently serve in that capacity.

Serving on the Tennessee Higher Education Commission has ignited a passion in me for public service, I love the law, and I want to make a positive contribution to the administration of justice in my community. Judge Siskin served with kindness, humility, gentleness and patience, and I want to continue the legacy of compassionate and thoughtful jurisprudence.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

The 16th Judicial District is comprised of Rutherford County and Cannon County. There are four divisions of circuit court: two divisions assigned to preside over criminal matters, and two divisions to preside over civil matters. The division of circuit court for which I am applying is presently assigned civil matters. In this judicial district, state trial court judges presiding over civil matters hear both circuit and chancery court matters interchangeably. For fiscal year 2015-2016, there were 1,826 cases filed in circuit court and 3,051 cases filed in chancery court, for a total of 4,877 cases. The largest percentage of cases involve domestic relations related matters, damages/tort and miscellaneous general civil matters. I have litigated these type cases from beginning to end, and while I am sure I would come across matters with which I have little or no experience, I have the ability to get "up-to-speed" quickly.

Yes, I will uphold the law even if I disagree with the substance of the law at issue. As a lawyer, my job is to advocate for and advise my clients in the context of the law as it exists, whether I agree with it or not, and that is what I have done. As a judge, I will apply the law as it exists and render whatever decision the law requires.
