**PROFESSIONAL BACKGROUND AND WORK EXPERIENCE**

I am a self-employed attorney.

2. State the year you were licensed to practice law in Tennessee and give your Tennessee Board of Professional Responsibility number.

I was licensed to practice in Tennessee in 1995

I took and passed the bar exam in Missouri, and my bar number is 34591. My status is non-resident and I was admitted in May of 1986.

I also took and passed the bar in the state of Illinois, and my bar number is 6200755. I was admitted in May of 1989.

4. Have you ever been denied admission to, suspended or placed on inactive status by the Bar of any State? If so, explain. (This applies even if the denial was temporary).

I have been temporarily suspended for non-payment of enrollment fees in Missouri in the past. My license was activated once the bar dues were paid. I was retroactively reinstated after the fees were paid each time. Additionally, I was making payments on the dues until they were paid. When I was working in Missouri, my bar dues were always paid on time because I had a significant income stream. All bar dues have been paid throughout the more than 33 years that I have been practicing. There were no other suspensions. There were no issues with the Illinois bar, as that state's bar dues are significantly less than other states.

St. Louis County Public Defender’s Office – Assistant Public Defender, 1986 through 1989 Handled numerous felony and misdemeanor jury and bench trials, pleas, preliminary hearings, traffic and domestic violence cases. Wrote and argued appeals from felony jury trial guilty verdicts.

UAW – Chrysler Legal Services – Law Clerk. Summer 1986, drafted motions and conducted legal research for staff attorneys.

Law Offices of Forriss Elliott- pre-licensed observatory position -1986.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

Private practice – 1989 through present – St. Louis, Missouri (1989-1994) and Nashville (1994-present) The areas of practice include: State and federal criminal law (Represented a defendant in a six week federal, multiple defendant, jury trial – St. Louis), personal injury and worker’s compensation. I have only practiced in federal court in Missouri. While working in the St. Louis County, public defender’s office, I wrote and argued appeals for my cases that resulted in guilty verdicts.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

I practiced personal injury, traffic, worker’s compensation, juvenile and adult criminal law. I have also performed one adoption. The Tennessee law business as consisted mostly (99%) of criminal law cases. However, my Missouri practice was mostly (75%) personal injury and worker’s compensation law. Guilty verdicts were appealed and argued. Additionally, I worked as a mediator with the Iowa Civil Rights Commission while I was in law school.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative body.

When I worked in the St. Louis County Public Defenders, I wrote and argued appeals for cases that had resulted in a guilty verdict. Additionally, I have handled workers compensation cases in St. Louis and one case here in Nashville.

9. Describe any other legal experience, not stated above, that you would like to bring to the attention of the Commission.

When I lived in St. Louis, I dispensed monies from an injury claim to my client as he had severe mental and physical disabilities. After his settlement was dispensed, I gave an accounting to the court. He received money from his settlement on a monthly basis until his funds were exhausted. While I received a contingency fee from his settlement, I did not charge any additional fees for the administration of his funds.

**ESSAYS/PERSONAL STATEMENTS**

27. What are your reasons for seeking this position? *(150 words or less)*

I have been practicing law for many years. As a former public defender and indigent defense counsel, I believe that I have a full understanding of the judicial process. At this stage of my career, I also believe that I have a lot of experience to offer the courts in criminal and civil matters.

When I was a young lawyer, approaching 30 years old, I had the unique opportunity of trying a criminal case, for six and a half weeks, in the U.S. Federal Court system as an appointed counsel. This case involved multiple defendants with several excellent attorneys on the case. Having sat in a trial, for this extensive period of time, enhanced my legal skills. Additionally, I have tried many jury/bench trials in St. Louis and Davidson Counties. The vast majority of the cases were tried in St. Louis. I tried one case in Davidson County. Further, I tried a conflicts case in the city of St. Louis. My experience and background in law will enhance the judiciary in Rutherford County. My case load, as a public defender, consisted of about 200 open files.

Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. *(150 words or less)*

I have lived in Rutherford County for 26 years and I am very familiar with this area. Smyrna is a small town with lots of charm, character and initiative. In describing the judgeship that I am seeking, I believe that this particular venue may review and oversee criminal matters such as bound over/grand jury cases. I believe that there are four venerable judges on this panel. Nonetheless, I would bring a freshness and different perspective to the Rutherford County court system if I am chosen to embark on this legal expedition.

My offering would be presented from an extensive legal drawing board. Each case would be reviewed with sharp eyes, wisdom and common sense. The experience that I have to offer is unprecedented and comprehensive. Moreover, having practiced law in several different areas makes my offering a complete and well-rounded package. Ultimately, fairness and public trust would be my objective and hope

As a criminal defense lawyer, I have had many instances where I have disagreed with clients. Yet, I managed to continue representing my clients with vigor, in spite of apparent and obvious differences of opinion. This is a natural talent that I have been graced with and developed throughout the years. This sense of fairness was inherent, but was professionally undertaken when I began my career as a public defender. Without getting into specifics, I have often



disagreed with lifestyles and choices that my clients have made. However, I treat everyone with respect and dignity. These situations are best managed by reviewing the legal aspects and consequences of each case. Consequently, I try not to delve into the graphic details or the disturbing facts surrounding a case. Hence, I chose to focus on the law in its purest, unadulterated form, rather than the logistics or disparaging facts of a given scenario or fact pattern. For example, when handling search and seizure matters, I weigh the probable cause implications and justifications for the intrusion. The law should uphold a measured standard of review without implicit/explicit bias or prejudice. Further, the system fails when laws are not protected and revered. Upholding established, well-grounded law is essential to due process and public confidence in the judicial process. The legal system would go awry if vigilante thought prevailed in the courts. Public trust in the institution would dissipate, wane and vanish. Embracing these principles of fairness would be my goal as judicial officer of the court.
