6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

I am primarily a civil litigator and have handled cases in the majority of Tennessee State Courts. I have been lead counsel in several hundred jury trials. My practice involves all areas of civil litigation including, but not limited to, healthcare liability; personal injury; workman's compensation; breach of contract; domestic relations; property disputes; construction litigation; contested conservatorships; and contested probate matters. Additionally, I do some criminal defense work limited to State Criminal Court. I have also handled a limited amount of Federal cases and have argued between fifty and one hundred cases before the Tennessee Court of Appeals and the Tennessee Supreme Court.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

I have practiced almost exclusively in Tennessee State Circuit and Chancery Courts over my thirty year legal career. I have been lead counsel in hundreds of jury trials and in thousands of bench trials. I have also been lead counsel in approximately fifty to one hundred actions before the Tennessee Court of Appeals and the Tennessee Supreme Court. As an Administrative Law Judge I presided over cases involving the IDEA, and as a Referee for both the General Sessions Court and the Juvenile Court, I presided over both civil and criminal cases.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

I am frequently retained by other law firms to try lawsuits that actually make it to a jury. I have obtained million dollar verdicts in multiple courts in the State of Tennessee. The majority of my practice involves complex cases that often involve multiple parties. One of my primary strengths as a civil litigator is the fact that I have tried all manner of civil cases, and that I have handled criminal jury trials in multiple jurisdictions. Several of the Appellate cases that I have handled

resulted in published Opinions, and in an expansion of the law in certain areas.

I have had numerous legal articles published, including a text book that was used throughout the United States. I was also the subject of a documentary on *Court TV*. I am constantly interested in improving access to the courts and frequently lecture on ways to improve the litigation process which is somewhat antiquated in a generation that receives unlimited amounts of information digitally. Tennessee Courts have historically been unable to keep up with the ever-changing demographic of the jury pool, and are often resistant to change. I have spent the majority of my legal career coming up with new and innovative ways to simplify the litigation process.

I applied for an open seat on the Tennessee Court of Appeals. I was also considered for a United States Federal District Court position.

I attended the University of Tennessee from 1983 until 1991. I received a Bachelor of Arts Degree with majors in English, American Studies and Political Science, and minors in Chemistry and Physical Education. I took graduate classes in English prior to attending law school where I ultimately obtained my Doctorate of Jurisprudence in 1991. I did Post Doctorial work at Lincoln Memorial University working towards a Master of Science Degree in Education; however, I did not obtain a degree. After I completed my course work I was required to complete one semester of student teaching at the high school level in order to obtain the degree. Given that I had no desire to teach, I ended the program prior to receiving a degree. I also did Post Doctorial work in Theology at the Johnson Bible College; however, I did not obtain a degree. Prior to becoming an attorney, I worked for Campus Crusade, a non-denominational Christian organization associated with the Billy Graham Foundation. I was considering going into the ministry; however, when I realized that I was not called to the Ministry, I chose not to continue my Seminary training and ended the program prior to receiving a degree.

I was the founder of the Anderson County High School Mock Trial Association coaching high school students whereby our teams won five State Championships and finished second Nationally out of 14,000 teams.

I have had multiple legal articles published, including the Law on Opening Statements in Tennessee by the American Trial Lawyers Association.

I was selected as the first coach from Anderson County to the Boys & Girls Club Coaching Hall of Fame.

I was elected to the Anderson County Board of Education in 2004 and have been re-elected four times. I was appointed by the Governor to be an Administrative Law Judge and I was appointed by the Honorable Jennings Meredith to be a Special Referee in the Anderson County General Sessions Court and in the Anderson County Juvenile Court.

#### ESSAYS/PERSONAL STATEMENTS

28. What are your reasons for seeking this position? (150 words or less)

I have practiced law in the State of Tennessee for thirty years. During that time my work has been exclusively inside the courtroom. I have served the State of Tennessee as an Administrative Law Judge, and have served the citizens of Anderson County as a Special Referee hearing criminal, civil and juvenile matters. As a Professor at the University of Tennessee College of Law, I helped train a generation of civil litigators, and have dedicated my entire professional life to improving the legal system. I believe that I am at the point in my career where I can have the greatest impact by becoming a Trial Judge. We are at a crossroads in our State whereby there needs to be several changes made to how we litigate, and we need a Judiciary that is unafraid to enforce the laws promulgated by the General Assembly and by the Governor.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

I am seeking a Judicial Appointment to the Anderson County Circuit Court position. This Judgeship is the sole civil and criminal State Court position for the entire Seventh Judicial District, which is comprised of Anderson County. This is a tremendous work load for one Judge, and I feel that in our county, I have the greatest amount of litigation experience, and I feel that I am the only litigator in the county who also has Judicial experience. I feel that my combination of courtroom appearances, combined with my previous Judicial experience and my real-life experience in mentoring many young lawyers, makes me specifically qualified for this position. I am not afraid of hard work. I built the law firm which I currently manage from the ground up. I come from a family of farmers and teachers. My father was a machinist, and my mother worked at a church. We grew our own food, and I worked to put myself through college and grad school. I believe that this position takes someone with a strong work ethic, and someone who understands the day to day struggles that people suffer in the real world, and someone who can fairly administer justice.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

I believe it is essential for a Trial Judge to uphold the law, regardless of his personal beliefs. The social contract that exists between government and its people only works if the citizenry have confidence that the laws enacted by their General Assembly, as approved by their Governor, are going to be enforced by the Judiciary. The system does not work if one branch of Government attempts to set itself above the other two.

As the father of a special needs son who is afflicted with cerebral palsy and developmental delays, I am extremely active in the special needs community. I also am a strong supporter of vocational education and believe that over the last several years public education has focused too much attention on forcing its students down a college track as opposed to a vocational tract. Personally, I have represented multiple Boards of Education throughout the State of Tennessee, and currently serve on the School Board for Anderson County. As the father of a special needs son, and as a strong supporter of developing real world vocational programs, there have been times where I have had to enforce the federal requirements of the IDEA, and federally mandated testing, even though I have a genuine heart-felt sympathy for the children and their parents who are affected by these rules and regulations. As an Officer of the Court, it is my job to ensure that everyone receives fair and equal treatment under the law.
