For twenty-five years, I have practiced law in Lawrenceburg, Tennessee and the surrounding areas, including all counties of the Twenty-Second Judicial District. I joined what is now Boston, Holt, Sockwell & Durham, PLLC ("bhsd") as an associate in 1993. I became a member of our firm in 1998 and have enjoyed a general litigation oriented practice since.

Additionally, I taught a business law course to night students as an adjunct professor at Columbia State Community College for several years.

During law school I clerked with the Knoxville firm Hodges, Doughty & Carson, PLLC and conducted legal research for bhsd. I also was a student representative in the Office of Student Conduct at the University of Tennessee ("UT"), where I prosecuted and defended fellow UT students in varying stages of student conduct hearings.

Prior to law school, I briefly worked for a temporary employment agency before accepting a tenure-track position with Metropolitan Nashville Public Schools. I taught mathematics courses, including general mathematics, algebra, and calculus at Pearl-Cohn High School for four (4) years. While there, I was head baseball coach and an assistant football coach. During summer recesses I also worked baseball camps for David Lipscomb College's head baseball coach, Ken Dugan, as well as several basketball camps at the college.

While an undergraduate student at David Lipscomb College I was a resident assistant and intermural sports official. I also umpired softball games for the Metropolitan Nashville Parks and Recreation Department.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

While varied and almost always in a state of fluctuation based on trends in the legal market, my practice has narrowed somewhat in the last five years. Most significantly, I manage our firm's Social Security disability practice both at the administrative level and on appeal. That area of the law comprises approximately fifty percent (50%) of my current practice, with general civil litigation being second at thirty percent (30%). Estate planning and probating, domestic work, and minor criminal matters constitute the remaining twenty percent (20%) of my practice.

Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

My legal experience has been quite broad thanks to the general nature of our firm, the varying and divergent needs of small communities, and the legacy our firm's founders established. I have extensive experience in Tennessee trial and appellate courts, state and federal administrative bodies, regulatory boards, and transactional matters.

It is incumbent upon small town lawyers to handle a wide range of cases, and I have enjoyed delving into many practice areas to meet the needs of our clients. I have handled the ubiquitous dog bite case, the tumultuous boundary line dispute, the emotional custody battle, and the argument over a grandparent's prized possession. I have litigated cases involving serious personal injury and even death. I have guided clients through disputes with insurance companies over failure to pay fire, property, and disability claims. I have represented individual clients, government municipalities, corporations, limited liability companies, partnerships, and joint

ventures. My Alabama license even has afforded me the privilege of representing clients in Limestone, Lauderdale, Colbert, Winston, Jefferson, and Mobile Counties in that state.

My trial experience includes hundreds of bench trials primarily in the Twenty-Second Judicial District, and taken numerous jury trials to verdict. Those jury trials include automobile accidents, other personal injury matters, products liability cases, and will contests. I have also been involved in multiple mediations over the years regarding all types of cases.

I have represented clients in numerous general sessions courts across the State in landlord tenant disputes, detainer actions, collection cases, criminal charges, contract disputes, and bailment issues.

From the early stages of my legal experience, I have engaged in significant appellate work. I have represented clients in the briefing and oral argument stages of approximately thirty (30) cases before the Tennessee Supreme Court, the Tennessee Supreme Court's Worker's Compensation Panel, and the Tennessee Court of Appeals. Six of those cases resulted in published opinions, including: *Ezell v. Cockrell*, 902 S.W.2d 394 (Tenn. 1995); *Erwin v. Rose*, 980 S.W.2d 203 (Tenn. Ct. App. 1998).

Over the last few years I have reduced somewhat the breadth of my practice by referring domestic and criminal matters to other lawyers in our firm so that I can focus on social security disability work and complex personal injury matters. In that regard, I have litigated hundreds of cases before the federal Office of Disability Adjudication and Review.

Finally, though a relatively small aspect of my legal experience, I have assisted in representing numerous corporate and other business entities in transactional work ranging from real estate transfers to mergers and acquisitions of mostly small- to medium-sized local businesses.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

Our firm litigated one of the first cases for which I had real responsibility early in my practice all the way to the Tennessee Supreme Court. See *Ezell v. Cockrell 902 S.W.2d 394*. It was the first case involving the TN Public Duty rule since the adoption of the Governmental Tort Liability Act. Through the appeals, I was fortunate to argue what we believed to be a good faith extension of the law and/or need to change the law to better articulate a governmental entity's duty to the public under the new scheme of fault assessment pursuant to the then newly-instituted comparative fault doctrine of *McIntyre v. Balentine*, 833 S.W.2d 52 (Tenn. 1992). While the Court saw the issue differently than we had hoped, the experience was a crucible early in my career that reinforced the weight of our profession and the impact we as lawyers can have on all Tennesseans. I have tried to carry that lesson with me throughout my practice to continually grow my legal knowledge and ability honed by the legal experience I have been so fortunate to garner to the benefit of my clients and the judicial system.

That very notion perhaps is what made social security work so appealing to me initially. It is a very frontline practice offering tangible, potentially life-changing benefits to some of our most needy citizens. That administrative practice, while certainly different than traditional litigation, illustrates that justice can be a linear process if those responsible for it, and in particular judges, apply integrity, impartiality, temperament, and legal expertise to public service.

Practically, my representation of hundreds of social security applicants with mental health issues has opened my eyes to the unique struggles of that population and its particular access to justice barriers. Those struggles so often interrelate with addiction that the judicial system's attempt to remove those roadblocks must be intertwined. Through my ongoing relationship with Centerstone Mental Health Center, which provides treatment to almost all of my clients with mental health issues, this practice has given me a unique perspective of the conditions, treatment, and counseling needed by people with mental disabilities. It also has given me a beneficial insight to how our legal system can improve the way it deals with mental illness and addiction, such a via the Twenty-Second Judicial District's newly reinitiated drug court that I believe has and will continue to have an unmatched positive effect on citizens in need.

For approximately 17 years, I have served as municipal judge and city attorney for Ethridge, Tennessee. As judge, I hold court monthly dealing usually with minor traffic offenses and violation of ordinances. In my role as city attorney, I have represented Ethridge in zoning matters and other cases of potential litigation involving the city.

I am thankful, mostly for four things:

- 1. Experiences as a person of faith, husband, father of three (25, 22, and 17), school teacher, coach, official, and community leader that give me a calm temperament.
- 2. Integrity and industry instilled in me by my parents that benefit me in all aspects of life.
- 3. Legal experiences that challenge personal growth, develop solid legal knowledge and ability, and value impartiality.
- 4. A diverse practice that affords my family wonderful opportunities.

Being thankful, though, is not enough. I am ready to show that thanks by public service. I understand the gravity of legal issues. I trust that the judiciary matters. I know that people deserve respect and to be treated with dignity and fairness. I believe that justice must be administered fairly and impartially. I apply for this position to manifest my thanks, live these values, and do good by public service.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

I seek a judgeship in the Twenty-Second Judicial District that includes Maury, Lawrence, Giles, and Wayne counties and currently is served by four circuit judges. These judges hear cases, as arbiters of the law and sometimes trier-of-fact, in almost all aspects of state law. Maury County has the largest population by far, but when combining Lawrence, Giles, and Wayne counties, the populations are comparable. My impact on the court, in addition to the qualifications otherwise discussed, would be geographic. My residence in Lawrence County is close and easily accessible to Wayne and Giles counties giving me excellent access to all courthouses in the circuit and gives all citizens of the circuit easier access to justice.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

As judge, I will strive to uphold and apply the law to the facts at hand, regardless of what my personal opinions or beliefs on a given issue might be. Litigants expect and are entitled to a fair and impartial disposition of their cases, and a judge's opposing views should not cloud the administration of justice. I have dealt with this as an attorney in the context of custody disputes—particularly grandparent visitation. In one such case, my client vehemently opposed regular visitation with her child's grandparents, resulting in very emotionally driven litigation. In

my personal life, my extended family are very close on both sides and have been heavily involved throughout our children's lives, which I feel has had a positive influence on their upbringing. Thus, I disagreed with my client's staunch position and was sympathetic with the grandparents' desire to spend time with their grandchild. However, while the legislature has carved out an avenue for grandparents seeking visitation, I advised my client of the burden on grandparents under the statute and how to strategically defeat their petition by not completely "severing" the grandparent/grandchild relationship (although the statute has since changed to be slightly more lenient). I advocated for my client while using the law as written to her benefit, despite my personal beliefs to the contrary.
