In 1985, while in high school, I obtained my first employment experience at Red Foods, in Columbia, Tennessee, as a courtesy clerk. Also in 1985 I worked at Pizza Hut in Columbia, as a cook/busboy. After graduation from high school in 1986, I enlisted in the United States Marine Corps.

In 1990 I returned to Columbia after completing my military service. From 1990 through 1991 I worked part time for Goody's Family Clothing as a sales clerk and Newspaper Printing Corporation as a deliverer of the Nashville Banner and Tennessean. From 1991 to 1993 I worked as a police officer for the Columbia Police Department where I served on the Honor Guard in addition to regular patrol duties.

From 1993 to 1994 I worked as a security officer for Williamson Medical Center in Franklin, Tennessee. Also in 1994 I worked at the Williamson County Sheriff's Department as a

corrections officer and I also worked at Foodmax Grocery as an Assistant Produce Manager.

From 1995 to 2001 I worked at the Spring Hill Police Department as a police officer, patrol sergeant, traffic crash reconstructionist, and detective. In 2001-2002 I worked as a state trooper for the Florida Highway Patrol. In 2003 I returned to Tennessee and worked as a police officer for Vanderbilt University Police Department. Also in 2003 I returned to the Spring Hill Police Department where I remained until 2005. I held the positions of police officer, patrol sergeant, training officer, firearms instructor and was ultimately promoted to assistant chief of police.

From 2005 through 2013 I was employed as a full time teacher at Zion Christian Academy. I taught middle and high school math and science classes. I was also the varsity baseball coach and assistant coach for the middle and high school football teams. In addition, I was the student council sponsor for the high school. In 2015 to 2016 I officiated middle and high school baseball games as a TSSAA umpire. From 2016 to present I have officiated middle and high school football games as a TSSAA official.

In 2013 I opened my own law practice, Brooks Law & Mediation, in Spring Hill, Tennessee. I represented clients in criminal, civil, family, and wills/estate matters. I became listed as a Rule 31 listed mediator in civil and family matters and was specially trained in domestic violence issues. I provided mediation services to retained parties as well as to the Mediation Center in Columbia, a non-profit organization. From 2012 through 2014 I was an adjunct instructor for Bethel University in the Master of Arts in Conflict Resolution program. In 2016 I entered into a partnership with another attorney, as a managing partner, to form Miller & Brooks, PLLC., in Columbia, Tennessee. Our firm provided the same services to clients as I provided in my solo practice. I was admitted to the United States District Court for the Middle District of Tennessee in 2016 where I represented clients in federal court. In 2017 I returned to my own firm of Brooks Law & Mediation continuing to offer similar services to clients. In 2017 I joined the 22nd Judicial District Public Defender's office as an Assistant District Public Defender. In 2018 I joined the District Attorney's office of the 17th Judicial District as an Assistant District Attorney General where I am currently employed.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

My present law practice is 100% criminal prosecution.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

During my experience with the public defender's office and the district attorney's office, my practice has been comprised entirely of criminal matters. During my private practice experience, I represented clients in criminal, civil, family, wills/estates, and mediation services in city, state, and federal courts. I have represented clients in all four counties of the 22nd judicial district as well as Davidson, Hickman, Marshall, Rutherford, and Williamson Counties. I have also represented clients in the city courts of Lewisburg and Fairview.

I have represented indigent clients by appointment in over 650 criminal matters in state court ranging from class C misdemeanors to class A felonies. I have also represented clients by appointment in juvenile court in matters related to parental rights, juvenile delinquency, guardian ad litem, and one case before the court for transfer to adult court. I have represented clients, both privately retained and by appointment, in six jury trials as the lead defense attorney and I have represented the State of Tennessee in two jury trials as a prosecutor. I have represented clients in bench trials in both civil and criminal matters.

I have also represented clients on appellate matters before the Tennessee Court of Criminal Appeals (by both pleadings and oral argument) and the Tennessee Supreme Court.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

I have represented many clients at the Tennessee Court of Criminal Appeals and one client on a matter that was before the Tennessee Supreme Court (on application for permission to appeal only). In that matter, I represented a client, by appointment, on a matter that began in the General Sessions Court in Mount Pleasant (State v. Thomas Braden). After indictment, I filed a motion to suppress based on a deficient search warrant. The trial court granted the motion to suppress and dismissed the matter. The State appealed to the Tennessee Court of Criminal Appeals where the trial court was affirmed. The State filed for permission to appeal to the Tennessee Supreme Court where it was held pending until the decision in *State v. Tuttle* was released. After the *Tuttle* decision was released, the matter was remanded to the Court of Criminal Appeals for analysis under *Tuttle*. The Court of Criminal Appeals affirmed the trial court a second time. The State's application to appeal to the Supreme Court a second time was denied.

I have experience in the court system from every perspective except as a judge or clerk. I have prosecuted criminal matters in both jury and bench trials as an Assistant District Attorney. I have defended criminal matters in both jury and bench trials as a private attorney and as an Assistant Public Defender. I have represented plaintiffs in civil matters and parties in family law and estate matters. I have appeared as a witness in both civil and criminal matters that were being tried in front of juries.

I had a secondary assignment as a marksmanship coach where I was responsible for teaching both enlisted and commissioned personnel basic marksmanship skills.

I have had three Consumer Assistance Program inquiries made against me. One client filed two of the inquiries. The first was for not "doing enough" to get offers from the State on his matter and the second was for "trying to force" the client into accepting a plea agreement. The third inquiry was for not getting "better" offers from the State. All of the inquiries were appropriately responded to and ultimately closed.

Maury Chancery Court No. 92-029: Lee Edward Brooks v. Alicia Gail Brooks. I was the plaintiff in a divorce action. The final decree of divorce was entered on March 20, 1992.

Maury Circuit Court No. 5715: Lockridge & Lockridge v. Getner, City of Columbia, Columbia Police Department, Lee Edward Brooks. I was sued for damages arising out of a automobile crash that I was involved in while on duty with the Columbia Police Department. Judgment was entered in favor of the defendants on October 30, 1996.

Maury Circuit Court No. 9242: Bernard Oden v. George, City of Spring Hill, Lee Brooks. I was sued for damages incurred when Bernard Oden, Sr. was held in the Maury County Jail for 17 days in error. The Maury County Grand Jury issued an indictment for "Bernard Oden" and Bernard Oden, Sr., was arrested on the indictment. The indictment should have been issued for Bernard Oden, Jr. I was dismissed from the suit. The entire suit was voluntarily dismissed on December 15, 2000.

While not since I graduated from law school, I received the Executive Director's Award for graduating first in my class at the Florida Highway Patrol Academy with the highest grade average in the history of the academy.

I have never been a candidate or applicant for public office.

ESSAYS/PERSONAL STATEMENTS

28. What are your reasons for seeking this position? (150 words or less)

I am seeking this appointment to be a circuit court judge for the 22nd Judicial District because it is an opportunity to continue service to my community. I have spent virtually all of my adult life in service to my country and community from my military service, law enforcement, teaching, and sports officiating. Even during my years of private law practice, I made myself readily available for appointments for indigent representation throughout the 22nd Judicial District representing clients in over 650 criminal matters as well as juvenile court matters. I participated in Wills for Heroes in Maury and Wilson Counties. I also provided mediation services at greatly reduced rates at the Mediation Center, a local non-profit organization.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

I am seeking appointment as a circuit court judge for the 22nd Judicial District covering Giles, Lawrence, Maury, and Wayne Counties. As such, I would be one of four circuit judges in this district. The circuit court judges in this district preside over criminal, civil, and chancery matters. My appointment to this position will positively impact the district due to my dedication to working hard, even through adversity, to accomplish the tasks at hand. An example of my proven track record is the fact that I worked full-time and had the responsibility for providing for my family while earning each one of my degrees. Other candidates may have a more attractive pedigree but I will not be outworked.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

I would uphold the law even if I disagreed with the substance of the law. I represented an indigent client by appointment on a class A felony for which she was originally held on over \$1 million bond. During my representation of my client, she learned after her incarceration that she was expecting a child. My client informed me that she wanted to terminate her pregnancy. However, after multiple attempts to either reduce her bond to an amount she would be able to post or obtain the cooperation of the sheriff to transport her for the appropriate medical procedure failed, the statutory date eliminating the possibility of terminating the pregnancy passed while she was still incarcerated pre-trial. She was ultimately released after a plea agreement for a much lower charge.

I filed a lawsuit in federal court on behalf of my client against the sheriff and county for failing to provide essential medical services to inmates in pre-trial incarceration. I filed the suit on a contingency agreement absorbing all of the costs associated with the suit. Ultimately, the suit was dismissed for violating the statute of limitations after argument before the court regarding the appropriate date to toll the statute of limitations. I am personally pro-life but despite my personal beliefs, I agreed to represent my client in this matter because under current
