Municipal law practice, defending Shelby County in the civil courts and prosecuting cases on its behalf, primarily in the areas of tort defense (15%), land use (20%), First Amendment regulation (signs, billboards, and adult businesses, 25%), property tax issues (25%), and advising various county officers and employees generally on matters of law, particularly school and school finance issues (15%)

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

Local administrative and regulatory agencies. I have represented and appeared before a number of local administrative and regulatory bodies including the Memphis Alcohol Commission, Shelby County Board of Equalization, Shelby County School Board (interim), Shelby County Adult Oriented Establishment Board, Shelby County Beer Board, Memphis and Shelby County Board of Adjustment (zoning appeals), Memphis and Shelby County Land Use Control Board, Memphis and Shelby County Community Redevelopment Agency Board.

State administrative and regulatory agencies. I have conducted numerous hearings and appeals before local and state administrative bodies including state administrative judges, the Assessment Appeals Commission, the State Board of Equalization, and the Water Quality Control Board (now the Tennessee Board of Water Quality, Oil & Gas).

<u>Trial and appellate courts.</u> I have conducted numerous trials and motions in all local civil trial courts: General Sessions, Probate, Circuit, Chancery, and U.S. District Court in Memphis and Nashville; have conducted several motions in Criminal Court and Juvenile Court, which are separate courts in Shelby County; have briefed and argued numerous appeals before the Tennessee Court of Appeals and the Sixth U.S. Circuit Court of Appeals; have briefed appeals before the Tennessee Supreme Court; and have submitted several petitions for writs of certiorari and responses before the United States Supreme Court.

<u>Legislative</u>. I have appeared before Tennessee Senate and Tennessee House of Representatives committees in support of legislation urged by Shelby County; and before the Memphis City Council and Shelby County Board of Commissioners on numerous occasions.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

An appeal before the Water Quality Control Board resulted in a post-victory settlement by which local government engineers largely moved from stabilizing ditches through "channel-lining" (concrete sides and bottom) to using rip-rap (large rocks) instead. The latter allows aquatic wildlife to remain intact; it slows water flow; and it thereby allows pooling which is essential for aquatic life to grow and flourish. Channel-lining inhibited all of those.

Lengthy litigation before the State Board of Equalization, Tennessee Court of Appeals, and Tennessee Supreme Court, done in conjunction with Davidson and Williamson Counties, clarified the state constitutional requirement that all property assessments be "equal and uniform," Tennessee Constitution art. II § 28, in regard to "public utility property" – the tangible personal property of utilities, airlines, and interstate carriers. *In Re All Assessments*, 58 S.W.3d (Tenn. 2000); 67 S.W.3d 805 (Tenn.Ct.App. 2001), *perm. app. den.* (2002); 62 S.W.3d 165 (Tenn.Ct.App. 2001), *perm. app. den.* (2001); *Williamson Co., et al. v. Tenn. St. Bd. of Equalization*, 86 S.W.3d 216 (Tenn.Ct.App. 2001), *perm. app. den.* (2002).

A federal trial and appeal, in co-counsel with the state Attorney General, resolved virtually all outstanding constitutionality issues of the Tennessee Adult Oriented Establishment Registration Act, Tenn. Code Ann. §§ 7-51-1101, et seq., in favor of the statute. *Entertainment Productions, Inc. v. Shelby County*, 721 F.3d 728 (6th Cir. 2013), *cert. den.* (2014); 588 F.3d 372 (6th Cir. 2009), *cert. den.* (2010), *aff* 'g 545 F.Supp.2d 734 (W.D.Tenn. 2008)(Donald, J.).

I am one of an apparent handful of lawyers in Tennessee to have filed a motion before the federal Judicial Panel on Multi-District Litigation (successfully). See In Re Tennessee Indecency Statute, 172 F.3d 873 (Table) (1999), per curiam.

ESSAYS/PERSONAL STATEMENTS

28. What are your reasons for seeking this position? (150 words or less)

Shelby County has always been remarkably fortunate in the quality of its local judiciary. I took notice of this when I first began working in the Shelby County bar, and study of local history shows that it has been a consistent feature of the local judiciary. When this vacancy occurred, I was encouraged, unbidden and unexpectedly, to apply for it. I was honored by the suggestion and the idea that I might join in so distinguished a history and assist in its continuance. For this reason, and in continuation of service to the public, I seek this position.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

The nine judges of the Circuit Court of Tennessee for the Thirtieth Judicial District serve the one-county "circuit" of Shelby County. The Court hears general civil matters including personal

injury suits, other tort cases with unliquidated damages, certain administrative appeals, divorces and other family-law matters. My law practice has covered widely different areas of the law – some unknown to most attorneys – and I believe that that experience can be an asset to the Court.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Yes. My work with local legislative bodies has involved innumerable situations in which I must advise them of a statute or other authority that governs a situation even though I disagree with the substance of that law. I recently wrote an opinion to a Shelby County Commissioner regarding an aspect of school funding that governs the school budget. Personally, I would have written the governing statute differently, but of course the Shelby County Commission must know and follow Tennessee state law, not my personal opinion of what the law should be.

In my work with regulatory boards, I have again described the governing law to board members, and enforced it in court, even though I personally disagree with the law. When I was interim school board attorney, I learned that an attorney may appear on behalf of a student at a school disciplinary hearing. This, of course, is a due-process consideration, but I had never considered it in the school disciplinary context. My preference would be not to involve attorneys making arguments at an elementary school student's disciplinary hearing, but the law allows it and so governs the situation. Because a student's parents elected to have their attorney present, I was present for the school board and I cross-examined the student's mother as I would at any other hearing.

These situations arise with regularity in my legislative and regulatory work.
