I have only been licensed to practice law in the State of Tennessee. I was licensed in 2005. My BPR# is 024081 and is currently active.

I have never been suspended or placed on inactive status, however my first attempt in taking the bar exam was unsuccessful. The Tennessee Supreme Court did grant me the privilege to practice with a limited license.

Subsequent to completing law school, and receiving my degree I began work with the law firm of Harwell & Plant in Lawrenceburg TN. My responsibilities included working on all types of legal issues such as Domestic/Divorce, Custody Issues, Wills and Estate Matters, Civil Debt Collections, Eminent Domain, Social Security and Disability claims, Juvenile Court cases and a

limited criminal case load.

My father, Mike Bottoms, was the District Attorney for the 22nd Judicial District, therefore, ethical guidelines limited my criminal practice. Moreover, state nepotism laws precluded me from working on my father's staff. After approximately one year in private practice, General Mike McCowan offered me an opportunity to join his staff as an Assistant District Attorney in the neighboring 17th Judicial District, which encompasses Bedford, Lincoln, Marshall, and Moore Counties. I applied for this position to gain more trial court experience.

Since August 2005 I have been an Assistant District Attorney for Mike McCowan, Charles Crawford, and Robert Carter. As part of my assigned duties, I manage cases throughout the entire 17th Judicial District in Juvenile Court, General Sessions Court, and Circuit Court. I have been the Child Investigative Protective Team (CIPT) leader for Marshall County from 2008-2014 and 2016-2017. I was assigned to the Child Fatality Review Team in 2016-2017 and represented the District Attorney's office in that capacity.

In short order, I was assigned to circuit court cases and trials throughout the 17th judicial district. I have successfully prosecuted all types of criminal cases that include cases in Circuit and General Sessions court, such as Homicide, Rape of a Child, A and B Felony Child Abuse and Neglect cases, Aggravated Assault, Burglary, Theft, and multiple Drug sale and possession cases, along with less significant misdemeanor crimes such as public intoxication and disorderly conduct charges.

Only after completion of my duties as an assistant District Attorney, from 2005 to today I have been employed in a janitorial service. Twice a week I assist in cleaning the USDA office buildings in Lawrenceburg, TN. Duties include emptying office trash cans, cleaning the restrooms, vacuuming the carpet and various other cleaning obligations.

From 2008-2010 my wife and I extended this business to include an Edward Jones office building, conducting the same type duties.

In addition, during my undergraduate years I became a certified mixologist/bartender and continued doing banquet and catered functions after obtaining my law school degree.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

At this time, my practice is 100% Criminal Law which involves cases in Circuit Court, General Sessions Court and Juvenile Court in all counties of the 17th Judicial District.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

I have been practicing law for 14 years however I have been involved in the legal community almost nonstop since 1998. I was employed as a clerk in the District Attorney General's Office for the 16th Judicial District while obtaining my undergraduate degree from 1998-2000. I assisted various ADA's in weekly court preparations for General Sessions Court. I also assisted with and observed criminal jury trials.

While Attending law School I interned after my first year with Neal and Harwell law firm in Nashville Tennessee working on various types of civil litigation. I was also granted a clerkship working for the Federal District Court Judge Tom Wiseman while he was sitting in Sr. Status for the second half of the summer in 2002.

The summer of 2003, I worked for the State Attorney General's Office in the Bankruptcy division and the Real Property division. I assisted State's Attorneys with the purchase and acquisitions of real property through eminent domain procedures for highway construction projects including the expansion of highway 43 in Lawrence County.

After Graduation, I spent a little over a year in private practice. These months were filled with multiple types of litigation such as Domestic/Divorce, Custody Issues, Wills and Estate Matters, Civil Debt Collections, Eminent Domain, Social Security and Disability claims and Juvenile Court cases.

From August 2005 to this point in my legal career, I solely handle criminal prosecutions for the District Attorney General's Office in the 17th Judicial District. I have prosecuted a wide array of criminal cases in each of the four counties from public intoxication to A and B Felony crimes such as murder, rape of a child, child abuse and neglect, robbery, burglary, theft, kidnapping, along with drug sale and possession cases.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

While prosecuting an aggravated child abuse and neglect case, pursuant to Haley's law, TCA 39-15-402, the defense attorney filed a motion to challenge the constitutionality of the statute claiming the definition of severe bruising was vague, and defense counsel argued that this rendered the statute unconstitutional. The case involved a nine month old victim who entered the ER with multiple bruises on her head and face and a noted linear mark across the face. The defendant first reported that these injuries were from a chemical burn that occurred when the defendant had been washing and waxing his vehicle. From the ER the child was referred to Vanderbilt Children's Hospital where doctors determined that her injuries were not consistent with a chemical burn and did not occur the way the father had alleged. Defense counsel's motion sought a dismissal because, as counsel argued, the applicable portion of the definition of severe bruising had not been defined by statute or case law. After much research and preparation, I successfully argued that the terms severe bruising, while not defined like other types of serious bodily injury, were terms of common usage and did not necessitate a legal definition. As a result of the outcome of this motion hearing, the defendant entered a negotiated plea.

9. Describe any other legal experience, not stated above, that you would like to bring to the attention of the Commission.

I grew up in a family surrounded by attorneys and educators. Both have taught me a great deal about life. Family dinners were always spirited with legal and ethical conversations which fostered core family values that have helped to shape me. Whether it was my grandfather, uncle, father or sister who are all attorneys, or my mother and her three sisters who were all teachers, they all made a great impression on me. They instilled in me many life lessons both inside and outside the classroom. They taught me hard work, dedication, selfless service, how to deal with adversity and the importance for discussion and compassion. These are traits I believe to be essential in serving as an effective and impartial judge.

Within the legal community, I have been fortunate to have practiced with and against several talented attorneys from the 22^{nd} Judicial District and the surrounding area. One such mentor is now the retired assistant district attorney Eddie Barnard. While he had a reputation for being a hard-nosed prosecutor, he impressed upon me to find my own style in the courtroom and just be myself. He also taught me there is no shortcut for preparation. These lessons have continuously guided me during my career which has consisted of approximately 35 jury trials.

This is my first time applying for a state or federal judicial position.

Working as an assistant district attorney in a four county district of rural southern middle Tennessee has given me a unique perspective. Each county is different but all face many of the same problems. I have observed how to be a jurist from some of the best on the bench. I have learned how to administer justice while being fair and treating others with respect and compassion. This is my home. I want to make a difference.

about 43% civil to 57% criminal. Currently there are four judges. Each is designated for one year to a county, in addition, each are working one week a month in their non-designated.

I'm no stranger to hard work. Currently, I manage multiple dockets in multiple counties in a given week. I have extensive criminal and domestic experience including custody cases. Living in Lawrence County makes me accessible to all counties quickly for emergency custody issues or late night search warrants. On occasion, I have assisted law enforcement in drafting search warrants. I believe this will be beneficial. I bring a strong work ethic to the table, but most importantly, I am a good listener with a calm demeanor and desire to be fair.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

As a member of the legal community my obligation and my oath are to uphold the law even when personal beliefs or feelings may conflict with those laws. As a Judge this will be even more important as the courts should remain as free from prejudice and bias as possible.

One such example I have dealt with involves prosecution of child sex abuse cases. In my career as a prosecutor I have on several occasions been asked to look at an officer's case. In some of these situations, I have had to tell an officer the evidence collected was not sufficient enough to bring formal charges. My job as an assistant district attorney is to pursue the guilty but also protect the innocent. I know the hard work our law enforcement community faces, and as a parent of 3 young children I empathize with these cases. Even so, my first obligation is to pursue truth and justice and I have a duty to make sure the officers follow the law even when I might have personal feelings to the contrary.

I firmly understand that we are a state and nation of laws. I give you my pledge that I will always follow the law.
