My practice focuses on litigation with a concentration on Domestic Relations. I estimate Domestic Relations comprises 90% of my current practice. The remainder consists of a mixture of business, personal injury and estate litigation as well as litigation involving real estate.

Over my thirty year career I have tried numerous jury and bench trials, both civil and criminal, in Rutherford and the surrounding counties. I have argued before the Court of Appeals and Court of Criminal Appeals more than forty times and have tried cases before the State Assessment Appeals Commission and the Tennessee Board of Nursing. I also tried a jury trial Pro Hac Vice in Alabama. Additionally, I have tried cases in Federal Court in the Middle District of Tennessee.

I successfully argued a case of first impression before the Court of Appeals. The case involved former step-parent visitation awarded pursuant to a Marital Dissolution Agreement.

I have served as a special judge in General Sessions and Juvenile Courts in both Rutherford and Cannon Counties. I have had a successful civil and criminal trial practice for thirty years in Middle Tennessee, having tried numerous jury and bench trials before an array of varying judicial styles. Some of the best trial court judges I appeared before were lawyers who had lengthy, successful and varied practices who chose to leave those to serve on the Bench. Their sacrifice, and their service, strengthened the Judiciary and benefitted all citizens of the State of Tennessee. They gave back to the profession and to the State. I have reached the point in my career where, now, it is my turn to give back to my profession and bring my years of experience to the Bench. I have the qualifications, knowledge, experience and temperament to allow me to proudly and successfully follow in the footsteps of these Judges and continue the tradition of a strong judiciary in the State of Tennessee.

I am seeking to be appointed Judge for the 16th Judicial District Circuit Court serving Rutherford and Cannon Counties. If selected, based upon my experience in both civil and criminal matters, I would immediately be prepared to hear cases involving a wide variety of issues, thus allowing cases to progress quickly and efficiently.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Yes. When I began practicing law if a divorced parent wished to relocate out of state with the minor children, the Court was obligated to determine whether the best interest of the children was to stay in Tennessee or relocate with the moving parent. I believe that is the appropriate standard. Then the Tennessee Supreme Court decided <u>Aaby v. Strange</u> in 1996 and substantially modified that standard. Subsequently, the Tennessee General Assembly codified the holding in

Aaby v. Strange and created the Tennessee Relocation statute, T.C.A. 36-6-108. Although I personally believe the best interest of the children analysis is the appropriate standard, I have followed the law and applied the standards enunciated by the Supreme Court and Tennessee General Assembly.
