First Amendment rights of free speech and association and their Fourteenth Amendment rights of equal protection and due process, seeking both declaratory and injunctive relief. The district court, relying on established abstention doctrines, stayed the case pending the outcome of state administrative proceedings. The district court was reversed and remanded by the Sixth Circuit on a subsequent motion to amend (see Jones v. Coleman et al., 844 F.3d 744 (2017). Subsequent to the remand, the district court lifted stay and dismissed action for lack of subject-matter jurisdiction. (See Jones v. Coleman, 2017 WL 1397212 (M.D. Tenn. Filed Apr. 19, 2017). The Court of Appeals upheld the dismissal, on the grounds that that repeal of provision of act rendered parents' action moot. (See Jones v. Haynes, 736 Fed. Appx. 585 (6th Cir. 2018)

I believe this position is very compatible with the model I have established for my practice, which is one based on solving problems, rather than creating them. The caseload of the Chancery Court matches my experience in civil and commercial litigation matters.

In addition, and perhaps more importantly, the position requires a citizen with broad perspective and a desire to promote the public good in the Davidson County community. I have those qualities, and my record of civic and community service speaks well of my desire to serve the citizens of Davidson County and the State of Tennessee.

While in essence a court of equity, the Chancery Court processes and adjudicates a wide variety of civil, commercial, and constitutional matters. The Chancery Court for the Twentieth Judicial District is the venue for judicial review of appeals from state administrative and regulatory bodies, and receiverships initiated by the Commissioner of Commerce and Insurance.

If selected, I would bring a broad and deep experience in all such matters to the Court. The diversity and richness of my professional career and personal background will be assets to the Court and the community it serves.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Our system of justice requires us to apply the facts to the law (statutory, regulatory, or case precedent) to determine the outcome of any given matter. I believe in this outcome-based approach to litigation, and would adhere to it as a Chancellor. I have had experience in this regard.

As an Administrative Law Judge for the Nashville Electric Service, I issued decisions in discharge cases involving workers that had experienced unfortunate circumstances in their lives. One such case involved a worker who had been seriously injured and faced serious physical and emotional struggles as a result. He was "preferred" for termination by NES for certain policy violations that were, in my view, a direct result of the pain he was experiencing.

In my Report and Recommendation, I noted all the mitigating factors for the employee that was admitted into the record. Ultimately, however, applicable NES codes and case precedent mandated that I uphold NES' preferred charge. While I did not personally believe the applicable law failed to account for these mitigating circumstances, I upheld the law, and termination of a career employee, all the same. I understand that such cases would be part of my calling as Chancellor, and I am prepared to undertake them.
