Upon application of expungement, District Attorney will not object to child's record being expunged one year after successful completions of probation, provided no new charges incurred.

Pursuant to T.C.A. 37-1-107, an order signed by a Magistrate becomes the final order of the Juvenile Court if an appeal is not filed within five (5) days, excluding Saturdays, Sundays and legal holidays, from the date the order is entered. An order signed by a Magistrate may be appealed to the Juvenile Court Judge by filing a request for rehearing with the Juvenile Court Clerk. A Magistrate's order must be obeyed until the Judge rules otherwise. ANY FAILURE TO COMPLY WITH ANY COURT ORDER IS PUNISHABLE BY CONTEMPT, FOR WHICH THE PENALTIES MAY INCLUDE A FINE AND/OR IMPRISONMENT.
