- Obey all laws and all Court Orders. Report all arrests, citations, and traffic tickets to your Youth Services Officer (YSO) immediately
- Obey the reasonable and lawful commands of your YSO, other officer of this court, and your parent(s)/ guardian(s) either verbal or written.
- Notify your YSO immediately of any change made in where you live, work, attend school, or your phone number.
- Not use or possess alcoholic beverages, illegal drugs, or drug paraphernalia; **nor** shall you be in the company of anyone doing so. You will submit to random drug screens at the request of your YSO or other designated officer of the court. It will be considered a violation of this rule if you use, or possess with the intent to use, any substance or device to falsify the results of a drug test. Any failed drug screen will result in a \$42 fee being assessed and may result in further court intervention.
- Attend school every day, on time, and attend every class unless you have an excused absence for that day. (All tardies and/or early dismissals should also be excused).
- Obey all school rules & regulations and notify your YSO immediately if you are suspended from school for any reason (this includes ISS).
- Cooperate fully with any court assigned program or agency. This includes keeping all scheduled appointments in a timely manner.
