6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

<u>General Practice</u>. 40% criminal law; 40% family law/juvenile; 15% appeals (primarily criminal and family law), 5% other. I also act as an appellate justice on 6 tribal appellate courts of appeals and the U.S. Department of the Interiors' Court of Indian Appeals. I teach Federal Indian Law once a year for the Lincoln Memorial School of Law.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

I am A/V rated by Martindale-Hubbell and have been included in Mid-South Super Lawyers the last five years. {4 = Family Law. 1 = Appeals}. I received a blind survey client satisfaction award from <u>Lawyers.com</u> in 2018. I have been consistently in <u>Who's Who in</u> <u>American Law</u> since the early 1990s and was awarded a Lifetime Achievement Award from Who's Who in 2021. I was recently named the 2023 Tennessee Criminal Defense Attorney of the Year by Legal Elite.

<u>Criminal Law</u> = approximately 100 jury trials over 35 years, ranging from First Degree Murder, to drugs, to sex offenses, to misdemeanors. My normal caseload includes approximately 20 active criminal cases at any one point. I regularly get appointments for post-conviction matters and criminal appeals. I regularly appear in the Circuit Court in Montgomery and Robertson Counties. I regularly appear in the Montgomery County General Sessions Court and occasionally in the Robertson County General Sessions Court. I also have experience in multiple federal criminal jury trials as I was on the federal appointment panel for 25 years. I also have extensive experience in the U.S. Magistrate Court at Ft. Campbell.

<u>Civil Law</u> = thousands of cases, primarily in family law, most in either Montgomery or Robertson Counties. These cases are usually in the Circuit or Chancery courts, but sometimes in General Sessions Court.

<u>Juvenile Law</u> = thousands of cases, most heard in Montgomery County. I currently handle juvenile traffic matters as a municipal judge in Pleasant View, TN, (Cheatham County), through an agreement with the Cheatham County Juvenile Court. I served as a part-time Juvenile Court Referee for Montgomery County Juvenile Court from 1990-1995+/-, but only appeared when the regular judges both had a conflict. In 2021+/- I was appointed as Special Master by the Montgomery County Juvenile Court to handle the procedural matters of an especially contentious case.

<u>Appeals</u> = between 500-1,000 appeals in multiple state and federal appeals courts. Most of the appeals were in the Tennessee appellate system with approximately 70% being criminal or

family/juvenile matters. I have approximately 75 published opinions in state or federal reporters. As a tribal appellate judge, I have authored over 100 appellate opinions, about half on criminal cases.

<u>Military Cases</u> = I have handled courts-marital jury trials, military boards, and appeals (both active duty and VA issues).

 $\underline{\mathbf{Tribal}} = \mathbf{I}$ serve on six (6) Native American tribal supreme courts (in six different states) and the U.S. Department of the Interior's Court of Indian Appeals (Miami Agency), which handles appeals for tribes in multiple states. I currently serve as Chief Justice for two (2) tribes and Chief Judge for the Court of Indian Appeals. I was Chief Justice of the Pawnee Nation Supreme Court during COVID and had to set rules for continuing court and how to conduct Zoom hearings during COVID. I have sat as a tribal trial judge in Florida and as a special public defender for several cases in the Rocky Mountains.

<u>Administrative</u> = I was a member of the old Tennessee Court of the Judiciary from 2005-2009, appointed by Chief Justice Drowota. I was a hearing officer for the Tennessee Board of Professional Responsibility from 1996-2002+/-. I serve as the attorney for the Clarksville-Montgomery Country Regional Airport Authority (for over 25 years). I have also served a couple times as special County Attorney for conflict situations at the appointment of the two most recent Montgomery County Mayors. One interesting administrative case I won was an extremely rare Montgomery County Coroner's Inquest jury trials under Tenn. Code Ann. § 38-5-101 <u>et seq</u>. (A Coroner's Inquest jury consists of seven jurors and is presided over by a General Sessions Court judge).

<u>Municipal</u> = 25+ years as a municipal judge. During those years, I have served as state president for the Tennessee Municipal Judges Conference twice, (2002-2004 and 2018-2020). In approximately 2014, I drafted the petition to the Tennessee Supreme Court on behalf of the Tennessee Municipal Judges Conference that allowed part-time municipal judges to seek Rule 31 mediator status. Justice Koch was the Supreme Court contact for that rule change. I was state president of the Tennessee Municipal Judges Conference during COVID and had to help establish rules for hearing cases during the pandemic.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

Expert Testimony: I have been hired to testify in circuit courts as an expert in criminal procedure in several cases over the years. The two best known attorneys to hire me as an expert on separate criminal cases are David L. Raybin (a couple of times) and Jerry Scott (former Chief Judge of the Tennessee Court of Criminal Appeals), after he retired from the bench. I am currently under subpoena from the Montgomery County District Attorney's Office to testify as an expert on Native American tribal courts and criminal procedure regarding alleged Native Americans facing DUI in a pending General Sessions criminal case where tribal sovereignty over crimes charged against Native Americans is at issue. I also testified as an expert for the Tennessee Legislature on municipal courts in 2003 as the Legislature considered the Tennessee

Municipal Court Reform Act of 2004.

Tennessee Municipal Judges Conference Judge of the Year, (Chief Justice Sharon G. Lee Award), 2017.

Drafted a position paper on establishing due process courts for the Ukraine Parliament at the request of the National Judicial College and <u>USAid.com</u> in March 2023.

<u>State v. Howington</u>, 907 S.W.3d 403 (Tenn. 1995), established the rule that district attorneys must honor contracted promises with a defendant if the state gets the benefit of their bargain in a plea agreement.

Hopkins v. Hopkins, 152 S.W.3d 447 (Tenn. 2004), established the rule that only a primary residential parent should receive child support and eventually led to today's permanent parenting plan concept.

National Judicial College (NJC) Faculty, 2015-date, teaching Judicial Ethics and Hearsay mainly. The faculty for the NJC, approximately 400 judges from across the United States per year, are hand-picked for this honor and student evaluations determine which presenters continue in this pro bono service. In 2023, I was one of nine (9) judges from across the United State requested by the NJC and USAid.com to write advisory papers to the Parliament of Ukraine on setting up a new court system for the Ukraine judiciary. The nine judges addressed three areas - appellate, general jurisdiction, and small claims, I was on the of the three judges that wrote on small claims, using the Tennessee General Sessions Courts as my blueprint. That paper, prepared in March 2023, was accepted for publication in the Lincoln Memorial University Law Review in late May 2023. This accomplishment was/is featured on the Tennessee Administrative Office of Courts website under the area of Municipal Courts. In 2020, I presented an international webcast at the request of the NJC entitled "Ethics for Judges During a Pandemic." Approximately 500 judges from all parts of the world (4 different continents) tuned into that presentation. In 2022, I presented another international webcast at the request of the NJC entitled "Hearsay Exceptions," which was attended by over 300 judges from 4 different continents. The normal classes I teach are online and generally include approximately 20 judges. Judges from all over the U.S., (and often from island judiciaries), attend those classes, which occur several times a year.

Mid-South Super Lawyers. I've been listed in Mid-South Super Lawyers for the past five (5) years. Four (4) times in the category of Family Law and once in the category of Appeals.

The first edition was authored in 2013 and the second in 2022. The first edition of my book was cited by the Harvard Law Review in 2021 (134 Harv. L. Rev. 964, 1054 n.565).

<u>Tennessee Judicial Ethics Opinions Handbook</u> compiler. In 2012+/-, Chief Justice Connie Clark appointed me as a member of a Blue-Ribbon committee of judges to review the (then Proposed) Code of Judicial Conduct. As part of this process, I compiled and indexed all Tennessee Judicial Ethics opinions from 1984 through 2012. The book was available to all Tennessee judges through the AOC.

Law School Presentation Invitations. I have presented to law classes at Vanderbilt (2022), William & Mary (2018), Tulsa (2016) and Tennessee (1993). I am set to present at the University of Nebraska School of Law in Mid-June, 2023.

9. Describe any other legal experience, not stated above, that you would like to bring to the attention of the Commission.

Three (3) points apply here. First, I have learned through my tribal work what it feels like to be the minority in a room. Second, I was recently asked to give the funeral service for a criminal court former client that had overdosed on poison-laced heroin. The deceased's parents had been in a Sunday School class I've taught for years. It reminded me that there are no "small" cases and people on all sides of a lawsuit have hurting and concerned families. The trust of conducting that funeral, years after representing the deceased during his life, was one of the biggest honors of my life. If I had not shown respect to the deceased, the parents would not have asked me to officiate the funeral. The need to treat all litigants with dignity is paramount! A judge needs to know this fact. As stated by one of my judicial mentors, "The job doesn't pay enough to be a jerk." The third point is that through extensive appellate work, I have learned how to attack a trial court record. That same experience has hopefully taught me how, as a judge, to produce a clean and defendable appellate record.

Over 35 years, I have had disciplinary complaints. I do not know a specific number, approximately 10. I have never been publicly disciplined as a lawyer. I have never had a judicial complaint. The two highest areas of attorney disciplinary complaints are domestic/family and criminal. These two high stress/high emotion areas are the chief cases of my practice. I have never had any public discipline, but I have had two private admonitions. One around 1993 for giving improper advice regarding a General Sessions Court case that a client may consider transferring property out of his joint name into his wife's name solely shortly prior to a judgment being taken. The bad advice was given pursuant to pervious directions from older attorneys. This mistake was quickly corrected, and similar advice has not been offered since. The second was losing track of a transient client who didn't provide updated contact information when he moved away from Clarksville, and a judgment was taken against him when I could not produce

a client for court. I do not think I've had a disciplinary complaint in over five years. During that time, I have an AV Martindale-Hubbell rating, am included in Mid-South Super Lawyers, and received a client satisfaction award from *Lawyers.com*.

In 2019 to 2020, I was sued in my official capacity as Chief Justice of the Nottawaseppi Huron Band of the Potawatomi Supreme Court, by a litigant in a <u>de facto habeas corpus</u> capacity. All of the NHBP Supreme Court and the Tribal Court were included in the lawsuit, but only the Chief Judge of the Tribal Court was actually named by the Plaintiff. I was never personally served or participated in the case. The matter was dismissed by both the U.S. District Court for the Western District of Michigan and the Sixth Circuit, who praised the NHBP Supreme Court's ruling and work ethic in a published opinion. <u>See Spurr v. Pope</u>, 936 F.3d 478, 487 (6th Cir. 2019), <u>cert</u>. denied 140 S. Ct. 850 (2020).

I host a "cost only" two-day (15 hour) CLE seminar on behalf of Radical Missions/Warm Souls. This religious-based organization feeds and clothes the homeless and needy at Christmas. The CLE costs \$40.00 and includes four (4) meals (breakfast/lunch) for attendees and a chance to donate to the Christmas Eve event. We usually have about 150 attorneys attend and generally raise between \$5,000 to \$10,000 for the needy after expenses and CLE reporting fees are paid. Other than costs, all money raised is immediately donated for the needy. We have done this project for over 10 years. It happens the week before Christmas. This project is strictly and completely <u>pro bono</u>, including the courthouse donating the meeting space and local caters/restaurants donating most of the food. I also work the actual dinner/event on Christmas Eve and we average 1,000-1,500 guests per year. The event is free to the needy and homeless. I also provide <u>pro bono</u> legal representation and advice to charities such as Hope Pregnancy Center and Manna Café. I also work <u>pro bono</u> with a small group of high school students seeking guidance for college scholarships. These students, referred to as "My Kids," are around six students per year. In 2022, I attended the West Point graduation of one of "My Kids" as an all-expense-paid guest of the young man's parents. Between 2012 – 2016, I hosted a middle school baseball "Pink Game" raising funds and awareness for Breast Cancer research. As with the Warm Souls event, all funds after expenses were completely given to charity.

No. Native American tribal nations, due to their political status, may exercise "Indian preference" in hiring. <u>See</u>, <u>Morton v. Mancari</u>, 417 U.S. 535, 553-555 (1974). Since I am not a member of any federally recognized Indian tribe, this point actually works against me in hiring.

28. What are your reasons for seeking this position? (150 words or less)

I believe I can serve my community with a fair and just judicial demeanor and an abundance of judicial experience. Instead of facing a significant learning curve for either Tennessee family or criminal law or how to act on the bench, I offer those traits from day one. I believe a judge must have considerable experience and provide all litigations, be they millionaire, pauper, or the state, with a fair and impartial hearing. I am ready to do just that. My appellate experience lends an eye to producing a clean trial record because I have focused on appellate technical records for three decades. The experience of finding appellate errors as an attorney should tend to help avoiding appellate errors as a judge.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

Circuit Court, Montgomery/Robertson County, TN (19th Judicial Circuit). The new judgeship is being created to address the population explosion the Clarksville/Springfield area has seen over the past decade. My experience will allow me to address issues quickly and efficiently as soon as the appointment occurs. I can move a docket along and know the importance of starting court on time. In over 25 years of being a municipal judge in a courthouse 20 miles from my office, with a single exception, I have not started court over two (2) minutes late. I am usually ready an hour before court, signing outstanding orders while I wait for court to start.
