I am presently employed as a partner at the Law Office of Walker & Garner, Attorneys, 122 6th Avenue W., Springfield, Robertson County, Tennessee 37172

I was licensed to practice law in Tennessee in 1986. My BPR Number is 012287.

In 1986 after graduating from law school and passing the bar exam, I began practicing law in Springfield, Tennessee, with William R. "Bill" Goodman and the firm was known as Goodman & Walker, Attorneys. We had a general practice that provided legal services in the areas of criminal law, family law, general civil cases, personal injury, workers' compensation, wills and estates, business formation and contracts, and real estate. The firm represented Tennessee Farmers Mutual Insurance Company and most of the industries located in Robertson County, including Electrolux Home Products, Inc., which is the largest employer in the county. We had a successful law practice and worked together for twenty-seven (27) years until Bill was elected to the Circuit Court bench in 2014.

In 2014, I formed a partnership with Jonathan Garner, who was an associate attorney with Goodman & Walker, and the firm is now known as Walker & Garner, Attorneys. The law firm has continued to grow and be successful and is a general practice, much like its predecessor. While some staff members have changed, I have had the same legal assistant for twenty-three (23) years. I still handle a variety of cases, including criminal, wills and estates, personal injury and family law.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

The areas of law in which I presently practice are as follows:

Criminal law (65%)

Wills and Estates (10%)

Personal Injury (10%)

Family Law (10%)

Miscellaneous Civil Cases (5%)

I am in court on the average of three (3) days per week.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

I have practiced law before the Circuit Courts of Robertson, Montgomery, Cheatham, Sumner, Dickson, Rutherford, Hickman, and Davidson Counties. I have also had cases in the Chancery Courts of Robertson, Cheatham and Davidson Counties. Further, I have practiced law before the United States District Court for the Middle District of Tennessee. In addition, I have had cases in the Supreme Court of Tennessee, the Special Workers' Compensation Appeals Panel of the Supreme Court, Tennessee Court of Appeals, and the Tennessee Court of Criminal Appeals. Finally, I have practiced law before the Tennessee Court of Judiciary, Social Security Administration, Tennessee Board of Claims, the Tennessee Department of Safety and Homeland Security, and the State of Tennessee Bureau of Workers' Compensation.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

I have litigated many interesting and challenging cases in my thirty-six (36) years of practicing law. At the trial court level, I have handled several murder cases and other serious crimes. I have also represented both plaintiffs and defendants in various civil cases, including wrongful death and a case in which I represented a three-year-old child who was assaulted by an intruder at a daycare that resulted in a civil settlement and the daycare being permanently closed.

At the appellate level, I was the attorney on three (3) cases that resulted in opinions from the appellate courts that were designated for publication. Those cases were as follows:

- State vs Carla Coleman, 791 S.W.2d 504 (Tenn.Cr.App.1989)
 I was the attorney for Ms. Coleman. The case against her was dismissed and set forth the standard to be applied when the police stop a vehicle based on an anonymous tip.
- State vs David Morelock, 851 S.W.2d 838 (Tenn.Cr.App.1992)
 I was the attorney for Mr. Morelock and the charges against him were dismissed. His case sets forth the law as to the right of a person not to be unreasonably detained after a legal traffic stop, but without probable cause to search or make an arrest.
- Martha Benton, Administratrix of The Estate of Davis Ray Benton v. City of Springfield, 973 S.W.2d 936 (Tenn.1998)
 I was the attorney for Martha Benton. The Supreme Court granted review of her workers' compensation case related to her deceased husband's heart attack who was a police officer. This case interpreted the law as to the statutory presumption afforded to law enforcement officers in workers' compensation cases.

I have been certified as a Rule 31 General Civil Mediator since 2002.

I have served four (4) terms as a Hearing Committee Member for the Tennessee Board of Professional Responsibility.

In 1994 a former client, Edward D. Fuqua, filed a lawsuit against me bearing docket number 74CC4-1994-CV-671 in the Circuit Court for Robertson County, Tennessee. The lawsuit arose out of a divorce action wherein the Court of Appeals vacated the judgment of the trial court and dismissed the case due to the wife's attorney failing to attach the oath to the complaint for divorce bearing his client's signature. Since Mr. Fuqua obtained from the Court of Appeals the relief he was seeking and in consideration of my agreement to waive the balance owed for attorney fees the case was dismissed.

I have been an attorney for over 36 years. I have handled cases in most areas of the law where the circuit court has jurisdiction, including criminal law and domestic relations, which, from my understanding, will mainly be heard in this court. I am prepared to assume this role.

Finally, as an attorney, I have always dealt with the public. The position of circuit judge will allow me to continue to be involved with the citizens of my community.

I am ready to assume the position of circuit judge. If given the opportunity, I will do so with dedication, honesty, and integrity.

I am seeking the Circuit Court, Part VI Judge position in the 19th Judicial District, which is comprised of Montgomery and Robertson Counties. There are presently five Circuit Court Judges and one Chancellor. The Circuit Court has general jurisdiction, including jurisdiction over criminal cases.

In the event I am appointed, I will strive to have a positive impact. I have a good relationship with all the current judges and will work with them well. I will use my experience to make sound judgments, promote an environment of honesty and fairness, and be dedicated to upholding the integrity of the legal system. I will be prepared and consider all the evidence before making decisions in any given case. I will treat those appearing before the court with respect.

As a judge I will uphold the law even if I disagree with its substance. As an attorney and officer of the court, it has always been my practice to do so as well.

I have encountered many situations in my career as an attorney where I explain the law that applies, and the client expresses their dissatisfaction with it. The client wants to make decisions based on what he or she thinks the law should be and what they think is fair, instead of following the law that exists. In that situation, my role as their attorney is to get my client to acknowledge the law as written and to deal with their situation within the confines of it, not as they subjectively believe the law should have been drafted.

As a judge I will follow and respect the law irrespective of my personal views. I will defend the constitution, seek justice, and do so with impartiality.
