During my twelve- and one-half years of employment at Maury Regional Medical Center, I was employed as a nurse in various departments of the hospital, including the recovery room, emergency department, and orthopedics. However, during the majority of my nursing career, I worked in labor and delivery and women's services.
- 6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

Because of my nursing background and medical knowledge, a large portion of my practice involves medical related litigation. At this time, approximately 50% of my practice is dedicated to personal injury defense, representing insureds of Tennessee Farmers Mutual Insurance Company.

Approximately 30% of my practice is related to domestic relations, including divorce and post-divorce matters.

I have three (3) children that are adopted – two (2) internationally adopted and one (1) domestically adopted. Consequently, adoption is near and dear to my heart, and roughly 10% of my practice is devoted to adoption.

Wills/Estates/Probate comprise approximately 8% of my practice.

Lastly, the remaining portion of my practice, averaging 2%, involves personal injury litigation representing plaintiffs.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

I have had the privilege of representing many clients in legal matters in Chancery Court, Circuit Court, Juvenile Court, and General Sessions. Over the course of my career, I have conducted countless bench trials in Chancery Court covering a broad range of legal matters, including divorce, child custody, modification of child support and alimony, contested conservatorships, and termination of parental rights.

In Circuit Court, I have had the opportunity to file and argue numerous motions for summary

judgment, which I find to be a particularly enjoyable part of my practice. Additionally, I have had the opportunity to represent clients in a jury trial involving personal injuries.

In Juvenile Court, I have participated in various bench trials while representing prospective adoptive parents in termination of parental rights actions, and other clients in custody related matters. Additionally, I have participated in bench trials in General Sessions Court involving landlord/tenant disputes, property damage claims, and other general matters.

I have had the opportunity to argue cases before the Tennessee Court of Appeals, including *In Re: Gunner F.*, M2016-01650-COA-R3-JV; and *Barrera, et al.* v. *Bob Parks*, et al., M2020-01027-COA-R3-JV. In both matters, I was able to obtain a positive resolution for my clients.

Due to the nature of my practice, mediation is a large aspect of case resolution. A significant percentage of my cases, particularly personal injury matters, are successfully resolved in mediation.

Since March 2015, I have served as the Trustee for a trust account arising from an estate in Cheatham County. The nature of my involvement has varied widely based on the needs of the beneficiaries of the trust. For instance, I have assisted with everything from negotiating health insurance coverage to payment of veterinarian bills.

The comment is often made that being a nurse and being a lawyer must be drastically different; however, the two professions are remarkably similar. As a nurse, I cared for people as they faced daunting medical challenges. Likewise, as an attorney, I have the opportunity to represent individuals who find themselves in the unknown and frightening world of litigation. Each scenario may be different, but the opportunity to assist individuals in crisis is the same.

My history, both professional and personal, demonstrates a servant's mentality and exceptional work ethic. For these reasons, it is my desire to join the judiciary and continue to serve my community.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

I seek appointment to the recently created fifth judicial seat in the 22nd Judicial District, which is comprised of Maury, Lawrence, Giles, and Wayne Counties. Although each county has recently grown in population, predominantly rural areas still exist; therefore, an understanding of the diversity of the population within the district is critical to affording its citizens access to justice. I had the honor of growing up on my family's farm in Summertown, in northern Lawrence County, where my family still resides. My upbringing instilled a love of this community and a true understanding of its citizens, which I believe would serve me well as a judge.

Currently, four judges hear civil and criminal cases in circuit court, and all chancery court matters. Should I be appointed, I would bring invaluable medical knowledge and understanding to the bench, as well as diverse experience in civil matters. Having had the privilege of practicing in front of the four sitting judges, I believe my temperament and character would complement our existing judiciary.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Yes, I would uphold the law even if I disagreed with the substance of a certain statute or rule. The integrity of our entire judicial system is built upon judges upholding the law in an impartial and consistent manner. Additionally, the citizens of the United States and, closer to home, the citizens of the 22nd Judicial District, are entitled to a fair ruling based on established law, rather than the personal ideals or opinions of the judge before which they stand.

As an attorney, there are rare moments I find my personal views in controversy with the law. One such time is, when representing prospective adoptive parents, I observe the multiple chances given to a birth parent before their parental rights are terminated. My frustration does not arise from the heartache and fear of my clients. I have been in their shoes before, and know it to be part of the uncertainty of being an adoptive parent. Conversely, my frustration stems from the extended turmoil and instability the child must endure during the process. Nevertheless, while my personal views are sometimes in controversy, I understand and respect the monumental weight of severing an individual's fundamental right to parent their child.

If every judge did what was right in their own eyes, the foundation of our judicial system would erode, and citizens would lose all trust and confidence in the legal process. Should I be appointed to serve the 22nd Judicial District, deciding matters in a fair and impartial manner would be my duty - a duty which I would assume with reverence and respect.
