I have only been licensed in Tennessee, 026213, since 2007 - active.

I graduated from law school in 2007 and immediately entered private practice as a solo practitioner. My practice consisted primarily of criminal defense, domestic relations, and representation of parents and children in dependency and neglect actions in Juvenile Court.

In 2013, I accepted a job as Assistant General Counsel with the Department of Children's Services and stayed in that position through 2021.

In January of 2022, I accepted my current position as Assistant District Attorney.

Prior to attending law school, I was an elementary school teacher.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

My current position is in the Child Support Enforcement Division of the District Attorney's office. I represent the State's interest in Child Support being set correctly and collected for the benefit of Tennessee's children. I file Petitions to set support, modify support, and determine arrearages. I file and prosecute Petitions for Criminal Contempt on obligor parents who are not paying their support. I am typically in Court 2-4 days per week negotiating cases with parents and attorneys and having hearings regarding support Petitions and Motions.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

During my time in private practice, I handled all phases of criminal defense including pleas in General Sessions and Criminal Court, preliminary hearings, bond hearings, motions to suppress and jury trials. In domestic relations cases, I tried divorce and custody cases on a regular basis in Chancery, Circuit, General Sessions, and Juvenile Court. I also acted as the Guardian ad Litem in several private custody/divorce matters including an appeal to the Court of Appeals. As part of my Juvenile Court practice, I participated in hearings regarding all phases of dependency and neglect cases including preliminary hearings, adjudicatory hearings, permanency hearings, guardianship hearings, appeals to Circuit Court, and trials for termination of parental rights. I also handled administrative appeals regarding unemployment and abuse indications by the Department of Children's Services. Most of my practice was in the counties of the Thirteenth Judicial District, but I also handled a few cases in the Fifteenth and Thirty-First Districts.

While working as Assistant General Counsel for the Department of Children's Services, I handled all phases of cases for the removal of children by DCS in Juvenile Court from preliminary hearings to termination hearings and everything in between. I handled hearings in Juvenile and Circuit court on a regular basis. I also covered appeals to Circuit Court and Termination of Parental Rights trials in Juvenile and Circuit Court and administrative hearings regarding indicated perpetrators. It was my responsibility to advocate for the best interests of our State's most vulnerable citizens in a region with a higher-than-average rate of alcohol and drug use, a high percentage of children living in poverty, and access to resources which were scant if not nonexistent. The Upper Cumberland office handled cases in fourteen counties including all of the Thirteenth District and seven other surrounding counties.

In my current role, I participate in hearings in Juvenile, Circuit, and Chancery Courts in all seven counties of the Thirteenth Judicial District regularly, including civil and criminal contempt matters.

While in private practice, I represented four convicted murderers in their post-conviction cases including trials in the Criminal Court and appeals to the Criminal Court of Appeals.

In 2017, I applied for a position as a United States Magistrate in the Eastern District of Tennessee.

#### ESSAYS/PERSONAL STATEMENTS

28. What are your reasons for seeking this position? (150 words or less)

It has always been my desire to be a judge, but I spent most of my life believing that I was meant to be a teacher. It was only after becoming disillusioned with the education system that a path

to law school opened for me. I have spent my entire legal career preparing for this position by studying the excellent judges of this District and others. I believe that judges hold the most important role in the legal system and must be held to the highest standards of morality, temperament, and professionalism.

I am seeking this position because I believe that I can be an excellent judge and because women are grossly underrepresented in the judiciary of our state. I have been in public service for ten years now and spent considerable time during my years in private practice serving the indigent and volunteering for legal causes. Becoming a judge would be a continuation of my service to the citizens of our District.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

I am seeking appointment as the third Criminal Court Judge for the Thirteenth Judicial District in a new position created by the most recent session of the State Legislature. The Thirteenth District is a large region including Clay, Cumberland, DeKalb, Overton, Pickett, Putnam, and White Counties. I believe that my experiences handling cases in a variety of specialties and courts makes me uniquely suited to this appointment. I have experienced our judicial system from many different angles and believe that this diversity of skills has made me more knowledgeable and adaptable in my legal practice. Moreover, women are underrepresented in the judiciary at almost every level in our District and our State. Of the now 14 judgeships in our District, only two are currently held by women. Furthermore, I have worked continuously during my lifetime to overcome an exceptionally disadvantaged childhood. It would be a great honor to be an example to the youth of our community facing adversity of the rewards of resilience, perseverance and hard work.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Litigants and Defendants are entitled to expect their judge to leave their own beliefs and opinions at the door and decide a case based only on the information presented at trial and the laws as they were written, not as they might wish they were. Judges can never allow their own values to affect the outcome of a case. There has never been a point in my legal career where I agreed with all of the statutes controlling a case, but my opinions regarding the rightness of any law are irrelevant. I am only tasked with abiding by and enforcing the laws as written by others. This ability to set aside personal judgment and consider only that which is within the boundaries of the law is even more important as a Judge.

In my position as a DCS attorney, I was often called upon to return children to parents who had abused them. This was always difficult for me. But the parents' right to rehabilitate themselves and parent their children as they see fit is a fiercely protected right under the law. Despite my own misgivings, the reunification of families was the primary goal of my job and I

pursued it zealously. I also often struggled when terminating the parental rights of parents with intellectual disabilities. While the law tasked me with doing so for the best interests of the children, it was heartbreaking to strip a parent of their rights when their inability to properly care for their children – who they clearly adored – was a circumstance beyond their control.
