I am employed as an administrative law judge (hearing officer) with the Tennessee Department of Labor and Workforce Development. I adjudicate unemployment appeals cases daily and have done so since October 1, 2007. Since then, I have adjudicated approximately 20,000 cases for Tennesseans from every part of Tennessee and continue to do so on a daily basis.

After I graduated from law school, I worked in private practice with Attorneys Mike Kress and

Gary Dodson in Sparta, Tennessee. I handled criminal matters (misdemeanors and felonies), juvenile court cases, civil matters, and completed real estate title searches for clients. I handled a variety of cases to assist clients in a small town practice. On October 1, 2007, I began work for the Tennessee Department of Labor and Workforce Development as an administrative law judge (hearing officer). I adjudicate unemployment appeals cases daily and have done so since October 1, 2007. Since then, I have adjudicated approximately 20,000 cases for Tennesseans from every part of Tennessee and continue to do so on a daily basis. I served as the Chief Hearing Officer from 2021 through 2022.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

I am an administrative law judge (hearing officer). I adjudicate unemployment appeals cases daily and have done so since October 1, 2007. Since then, I have adjudicated approximately 20,000 cases for Tennesseans from every part of Tennessee and continue to do so on a daily basis.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

From 2004 to 2007, I handled criminal matters (misdemeanors and felonies) in the general sessions courts and criminal courts of White County, Van Buren County, and Putnam County, Tennessee. Many of these cases were court appointments wherein I represented the indigent. I also represented clients in the White County, Van Buren County, and Putnam County juvenile courts. These consisted, mostly, of dependency/neglect cases, termination of parental rights cases, and juvenile criminal cases. I also represented clients in civil courts involving motor vehicle accidents, divorces, boundary disputes, child support cases, and requests for temporary restraining orders. I also conducted real estate title searches and drafted wills for clients. I did not practice before appellate courts when I worked in private practice.

From 2007 to the present, I have worked as an administrative law judge (hearing officer). I adjudicate unemployment appeals cases daily and have done so since October 1, 2007. In the hearings, I take testimony under oath, listen to and evaluate the arguments of the parties attorneys, consider motions submitted by the parties and/or their attorneys, admit or deny motions for admission of evidence pursuant to the Tennessee Rules of Evidence, and issue written decisions in each case. Since 2007, I have adjudicated approximately 20,000 cases for Tennesseans from every part of Tennessee and continue to do so on a daily basis.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

I have adjudicated unemployment compensation appeals hearings for the citizens of Tennessee for almost 15 years now. As a result, I have interacted with Tennesseans from every corner of Tennessee, from every socio-economic background, from every educational level, and from multiple ethnicities. I am keenly aware of the variety and greatness of Tennessee's citizens and take seriously the responsibility to provide them with a fair and impartial hearing every day. I interact with them during a particularly stressful time in their lives when they are unemployed or when the recently elected to terminate the employment of an employee. I consider this position as one of a neighbor helping another neighbor because we are all Tennesseans. It has been a special privilege and blessing to serve my neighbors in this way.

While in law school, during the summer of 2003, I clerked in the United States Attorney's Office for the Western District of Tennessee in Memphis, Tennessee. During that time, I conducted research on a variety of matters for assistant United States attorneys and observed a variety of federal criminal trials be adjudicated. I also helped the assistant United States attorney with legal research for their forthcoming briefs to the United States Court of Appeals for the Sixth Circuit in a variety of cases.

In 2021, I submitted an application to the Governor's Council for Judicial Appointments to be an Associate Justice on the Tennessee Supreme Court. The body considered my application on December 8, 2021. The body did not submit my name to the Governor as a nominee.

My grandfather had a third grade education and, unfortunately, he passed away before I was born. The idea that his grandson has graduated from college, graduate school, and law school and is now being considered for a criminal court judge position would be unbelievable to him. It is the epitome of the American Dream. I have been blessed in my life to be educated and serve the citizens of Tennessee. Legal professionals in our small town are viewed as learned friends who are there to help their neighbors with legal matters. I have a servant's heart and public service is the highest calling for anyone. I want to continue to serve the people of Tennessee.

I am seeking the Criminal Court judgeship for the Thirteenth Judicial District. The cases involve felony criminal cases and misdemeanor appeals from general sessions courts. There are currently two criminal court judges in our judicial district and the General Assembly has elected to add a third. My selection would impact the court by adding a third judge to reduce the number of cases on the dockets of the other two criminal court judges. I would be fair and impartial and seek to adjudicate all matters in a timely manner.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Yes. Tennessee law requires that unemployment compensation applicants must be able and available for suitable work in order to receive unemployment compensation benefits. There are occasions wherein employees are injured at the jobsite performing their assigned job duties precisely in the manner they have previously been instructed to perform them by their employer. They are injured through no fault of their own. However, their injuries render them physically unable to work and they are, therefore, ineligible for unemployment compensation benefits pursuant to state statute. I disagree with this outcome but I, nonetheless, apply the law as written without passion or prejudice.
