I am the primary attorney at the small firm I founded with my wife and law partner, who now also works for the Social Security Administration. I maintain a caseload of around 50-60 cases. The vast majority (95%+) are family law. I also have a few general civil cases, have done numerous juvenile criminal cases, and am presently litigating in federal court on a VAWA claim.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

As a student, I began my career as a trial court clerk for Judge Bill Swann of the Knox County Fourth Circuit Court, followed by a semester as a student attorney in the UT Law Domestic Violence Clinic. Prior to graduation, I took a job as a provisionally licensed law clerk under Margaret Held; after becoming fully licensed, I continued at the Held Law Firm as associate attorney for 6 years. During this time, I also sat as Special Master for the Knox County Fourth Circuit Court from 2014-2016, hearing and trying represented and pro se Order of Protection cases. LaFevor and Slaughter hired me as their first Senior Associate attorney in June 2017. In July 2018, I founded Shipley & Swain PLLC.

During my career I have argued in Circuit, Chancery, General Sessions, and Juvenile courts in Knox, Blount, Anderson, London, Roxane, Monroe, McMinn, Union, Campbell, Claiborne, Sevier, Jefferson, Grainger, Cocker, Greene, Washington, and Sullivan counties. I have briefed and argued cases before the Court of Appeals and assisted with research and writing for cases before the Court of Criminal Appeals and Tennessee Supreme Court. I have also litigated in the U.S. District Court for the Eastern District of Tennessee and argued cases at the Social Security Administration.

In August 2018, I conducted a civil jury trial in Knox County Circuit Court. I have argued and won at the Court of Appeals. I have decided cases numerous times as Special Master for Knox County Fourth Circuit Court.

28. What are your reasons for seeking this position? (150 words or less)

I feel called to help the community, specifically the underserved and unrepresented. I want to help solve problems for individuals and families. I have been able to do this in the past in a limited capacity by working for a court and sitting as special master. I believe that my background/disability allow me to connect with those who feel invisible and unheard. I see firsthand in my practice how difficult it can be for people in rural communities to access the legal system in a timely and efficient manner if they can access it at all. With my 12 years of professional experience and my unique perspective, I believe that I can assist in opening the courthouse doors to the citizens of my District.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court.)

I am seeking a Circuit Judgeship in the Fourth Judicial District. If possible, I would like my chambers to be based in Sevierville or Dandridge. I hope to set up a special family law court to hear juvenile appeals, all family law matters, and orders of protection. I am also interested in creating a "domestic drug court" component to provide those citizens struggling with addiction an avenue to reunification with their children. I believe this additional support would better protect the best of the children in our community while also helping those parents get their lives back on track in a non-punitive environment. I want to open my courtroom to local law school legal clinics, encourage pro bono services in the local bar, and introduce educational programs to familiarize the public with basic family law legal issues and how to identify and break the cycle of domestic violence.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

It is not the job of judges to create new law or policies based on their own preferences; it is their duty to apply the law fairly and evenly in all situations, regardless of the participants and the issues. The General Assembly makes laws, judges must simply apply them.

When I sat as a Special Master, I often had to hear criminal contempt cases. One matter involved a father who had an order of protection taken out against him and who was suing for custody of his children in juvenile court. There were no exceptions to the order of protection to contact his wife about the children. He was concerned about their safety and made multiple attempts to contact them. I did not want to find him guilty. I found him sympathetic, and his reasons made sense. But the law was clear. I sentenced him to a minimal amount of jail time with the rest suspended and urged him to utilize the Juvenile Court to protect his children.

As an attorney, I sometimes lose business after informing clients regarding black letter law. The most common example is that an agreement for no child support, which is not enforceable under Tennessee law. While I personally think that there should be some situations where a zero-dollar child support award is found appropriate, I am an officer of the court, and my obligation is to follow the law regardless of my personal feelings.
