PRELIMINARY HEARING


COMES NOW the Defendant, [REDACTED] by and through counsel of record, [REDACTED] and moves this Honorable Court to allow [REDACTED] Court Reporter to transcribe Defendant's Preliminary Hearing that was heard on [REDACTED] 2022, in the [REDACTED] Court of [REDACTED] County, Tennessee. In support of his Motion, the Defendant would submit the following:

1. A warrant was issued against Defendant in the [REDACTED] Court, [REDACTED] County, Tennessee, for [REDACTED] and [REDACTED] were issued against Defendant. The warrant number from [REDACTED] Court is [REDACTED] and the hearing occurred on [REDACTED] 2022.
2. This transcription of the hearing is vital for purposes trial preparation, and potentially appeal, should Defendant be found guilty of the charges for which he presently stands accused.
3. T.C.A. Section 40-14-309, as interpreted in State v. Elliott, 524 S.W.2d 473, provides that "the courts of this state have recognized that a trial judge has the authority to require a transcript of prior proceedings in the indigent defendant's own case be furnished him if it appears that it is necessary in the interest of justice."

4. Defendant has been declared indigent and is unable to pay the cost of transcription.
5. Finally, preparation of such transcript is necessary for protection of the constitutional rights of the accused, including, but not limited to, the Equal Protection and Confrontation Clauses of the United States and Tennessee Constitution.
6. It is estimated that the cost will range between and \$500.00.

WHEREFORE, PREMISES CONSIDERED the Defendant requests that the Court Reporter,  be allowed to transcribe Defendant's Preliminary Hearing, and the Administrative Office of the Courts pay  for transcribing Defendant's Preliminary Hearing.
