- 5. If the State's Motion to Dismiss the Petition for Writ of Error Corum Nobis is granted, the Court will conduct the hearing on the Amended Petition for Post-Conviction Relief beginning December 2, 2024. This hearing is anticipated to last five (5) days.
- All hearings will be held in the Circuit Court of Hardin County. Court sessions shall begin at 8:30 a.m., unless otherwise specified herein, and continue each day until their conclusion.
