This publication is the statistical portion of the Annual Report of the Tennessee Judiciary for fiscal year 2000-01. Included in this report is information gathered from the offices of the Appellate Court Clerk in Nashville, Knoxville and Jackson and the state clerks of court of Tennessee. The collection of this information is mandated by the Tennessee General Assembly and is used primarily as a tool to measure the effectiveness of the court system in Tennessee. The report is divided into three major sections: appellate (Supreme, Court of Appeals and Court of Criminal Appeals)

caseload data; state trial court (chancery, circuit and criminal) filings and dispositions data; and jury and non-jury damages and torts data. The state trial court information is being reported by judicial district. All information disseminated in this report has been distributed to and verified by the judges and the clerks of court of their respective judicial districts. 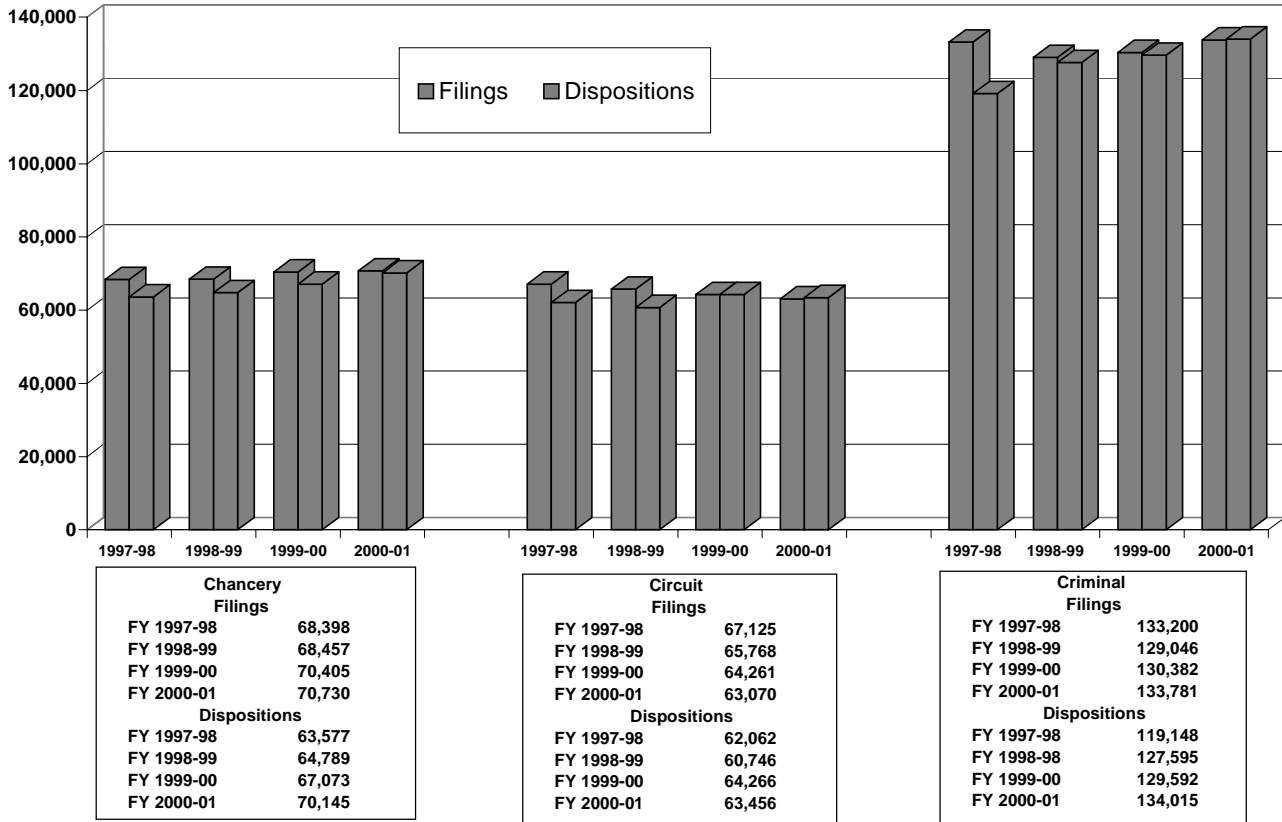

Damages and Torts Cases

Fiscal Year 2000-01



Effective July 1, 1989, Tennessee Code Annotated, §16-21-111, requires the clerk of each Circuit Court and the clerk and master of each Chancery Court to report the following information on a monthly basis: the number of cases filed claiming monetary damages for personal injury or death, and the number of such cases actually proceeding to trial. For those cases proceeding to trial, clerks must also report:

- the number of cases in which the plaintiff was awarded monetary damages for personal injury or death;
- the amount of judgment in a jury case;
- the amount of judgment in a case without a jury;
- any additur or remittitur awarded in the case by the trial judge.

The staff of the Administrative Office of the Courts (AOC) must compile this information and report the findings of the previous fiscal year to the chairpersons of the Senate and House Judiciary Committees and to the Attorney General.

Pursuant to this code section, the AOC, acting as staff for the Judicial Council, prepared this report. In fiscal year 1995-96, it was decided that this report would be incorporated into the *Annual Report of the Judiciary*, so that statistical information on the court system could be easily located.

The clerk of each Circuit Court and clerk and master of each Chancery Court send monthly reports on all case filings and dispositions to the AOC. Case filings are classified by case type categories, one of which is damages and torts. The damage and torts category consists of personal injury and wrongful death cases only. Property damage cases are reported under the

Miscellaneous General Civil category. Dispositions are classified according to the manner in which the case is disposed. For the purpose of this report, the disposition categories used were jury and non-jury trials. Also reported is whether or not monetary damages were awarded, and the amount awarded, if any, and the amount of any additurs and remittiturs to the original awards. This data is contained on the Tennessee Judicial Information System (TJIS) database.

Information gathered from the TJIS database provides the basis for the analyses included in this report. The following charts and graphs include cases that meet the following criteria:

- the case involved a claim for monetary damages for personal injury or death;
- the case was disposed of during the July 1, 2000 – June 30, 2001, time period;
- the case went to trial;
- the case was not settled or dismissed.

Prior to the publication of this report the AOC staff mailed preliminary data sheets to each Circuit Court clerk and to each clerk and master. Each was asked to review the sheets for accuracy and considering the reporting criteria described above, to submit corrections, if necessary. Copies of the data sheets also were sent to each judge in their respective districts.

Overall, for fiscal year 2000-01, data reported as to damages and torts cases showed an increase in the number of filings and a small decrease in the number of dispositions reported over last fiscal year. There were 12,523 filings and 12,321 dispositions for fiscal year 2000-01. Damages and torts cases represented over 9 percent of civil filings and dispositions for

the fiscal year. Of the 12,321 damages and torts cases disposed of during the year, 967 (almost 8 percent) proceeded to trial. Jury trials accounted for 554 cases (57 percent) and non-jury trials for 413 cases (43 percent) of the cases that proceeded to trial. There was a significant decrease in the number of cases going to trial over those reported last year. The four metropolitan areas (Davidson, Hamilton, Knox and Shelby Counties) had 486 damages and torts cases (50 percent) going to trial. The four metropolitan counties accounted for 39 percent of all civil filings and dispositions for the year. The chart on page 152 has a comparison breakdown of damages and torts cases disposed of and cases going to trial from fiscal years 1990-91 through 2000-01.

Cases disposed by jury and non-jury trials both showed decreases in the number of dispositions compared to last year's report. The four metropolitan areas were evenly divided on the number of damages and torts dispositions. Hamilton and Shelby counties reported a slight increase; Davidson and Knox counties showed a slight decrease in the number of damages and torts dispositions. Of the 967 cases going to trial, 452 were awarded damages. The statewide total for damages awarded is \$94,596,255, which is over \$51 million more than the previous year. The large increase in damages

awarded is due in part to the increase in the number of awards over \$500,000. The number of awards over \$500,000 doubled from last year's report.

In fiscal year 2000-01, the four metropolitan areas reported \$47,679,281 in damages awarded, which is almost \$18 million over last fiscal year's report. The four metropolitan areas' total damages awarded represents 50 percent of all damages awarded. The chart on page 153 shows total monetary damages for fiscal years 1990-91 through 2000-01.

The average award for fiscal year 2000-01 was \$209,284. This represents an increase of \$95,064 from the previous year. The average award for three of the four metropolitan areas was up from last year. Davidson County, however, showed a decrease. The chart on page 153 gives the average monetary award for fiscal years 1990-91 through 2000-01.

Greene County had the largest award for fiscal year 2000-01 with \$15,000,000. There were 29 awards of \$500,000 or more for a total of \$76,682,943. This represents 81 percent of all damages awarded. Twenty-one of the 29 cases were for \$1 million or more for a total of \$70,930,983. A brief synopsis of the case with the largest award follows.

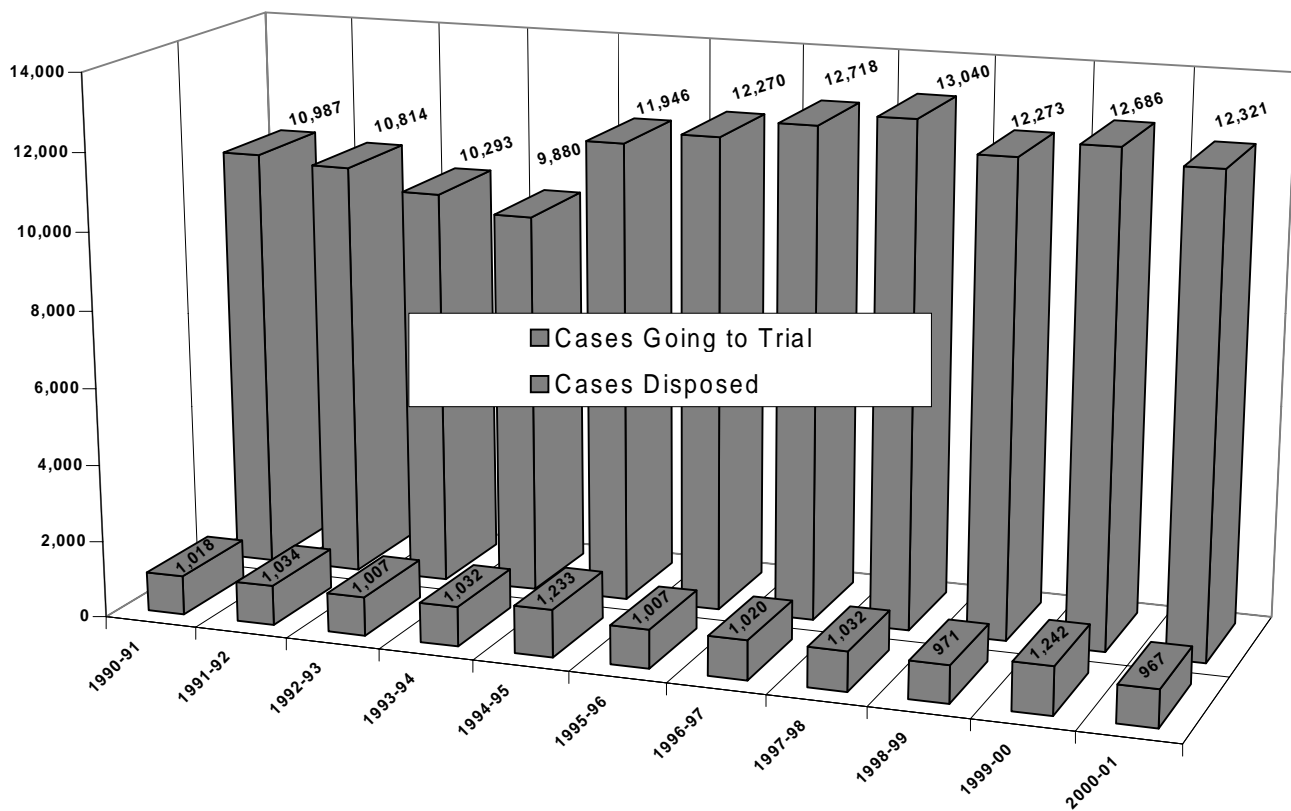
Largest Award

The largest award for fiscal year 2000-01, \$15,000,000, was a personal injury suit filed in Greene County Circuit Court. The case was filed May 18, 1995. The following information was obtained from the Greene County Circuit Court Clerk's Office. The plaintiffs, Brian A. Looney, Elaine Looney and Roger Looney, filed a complaint stating that on August 27, 1994, Brian Looney was traveling in a southerly direction on East Andrew Johnson Highway driving his father's (Roger Looney) 1990 Mazda B2200 pickup truck. The plaintiff alleges that co-defendant, Bobby M. Patton, was riding a horse on 11E, going towards Greeneville. The defendant failed to keep proper control of his horse when he dismounted the horse, at which time the horse darted in front of the vehicle driven by the plaintiff, Brian Looney. The plaintiff states that at the time of the incident he was wearing a three-point seatbelt while operating his vehicle within speed limits and observing and obeying all traffic rules when an animal suddenly appeared in front of his vehicle. The plaintiff further states that he did not have an opportunity to take any evasive action to avoid the animal before his vehicle struck the animal. The force and impact of the collision caused the animal to be thrown up into the air and on top of the Mazda pickup truck crushing the roof in upon the plaintiff. The plaintiff alleges that the other co-defendant in the case, Mazda Motor Corporation (Mazda), designed, manufactured, assembled and sold a vehicle that was defective and not crashworthy. The plaintiff further alleges that Mazda failed to adequately warn owners and occupiers of said vehicle's defective roof structure. The plaintiff also alleges that Mazda knew of the dangerous and defective conditions in the design and/or manufacture of said vehicle's roof and that Mazda deliberately failed to take adequate steps to eliminate or reduce the hazards of enhanced injuries caused to the defendant by the roof the pickup "caving in" upon the plaintiff. As a result of the accident and subsequent collapse of the vehicle's roof, the defendant sustained permanent injuries which resulted in quadriplegia, as well as other internal injuries to his muscles, nervous system, and internal organs. The plaintiff states that his injuries are permanent and effect his capacity to earn a living and enjoy life. The co-plaintiffs, Elaine and Roger Looney, brought suit for reimbursement of medical bills and expenses which they have incurred and will continue to incur on behalf of their son. A jury trial on this matter was held April 23 - May 3, 2001. After due deliberation the jury assessed total damages in the amount of fourteen million dollars (\$14,000,000) for plaintiff, Brian A. Looney; and one million dollars (\$1,000,000) for plaintiffs, Elaine and Roger Looney. The jury further assessed the fault of the defendant, Mazda Motor Corporation, at ten percent (10%) and assessed the fault of the defendant, Bobby M. Patton, at ninety percent (90%). (Brian A. Looney, Elaine Looney, and Roger Looney v. Mazda Motor Corporation; Mazda Motor of America, Inc., Mazda Motors of America (East); Mazda Motors of America (Central), Inc.)

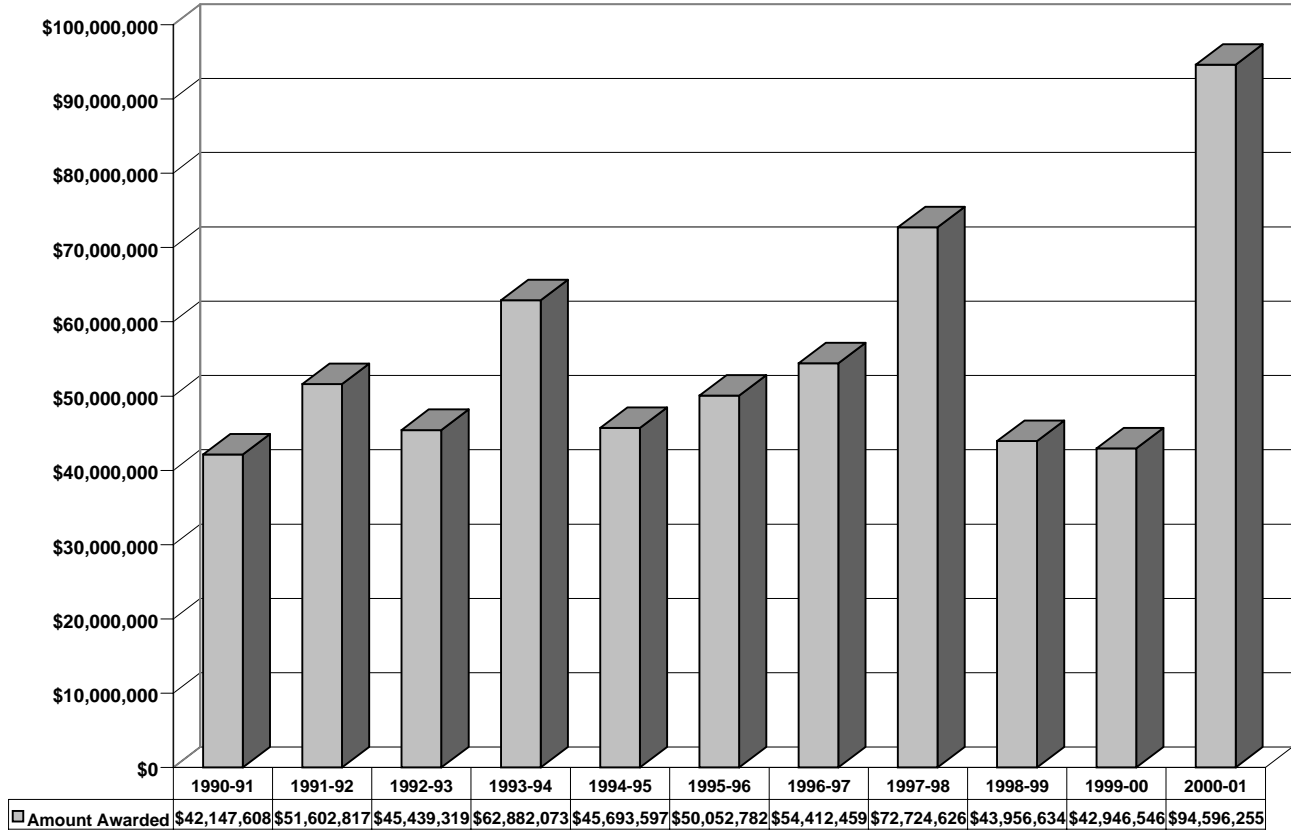

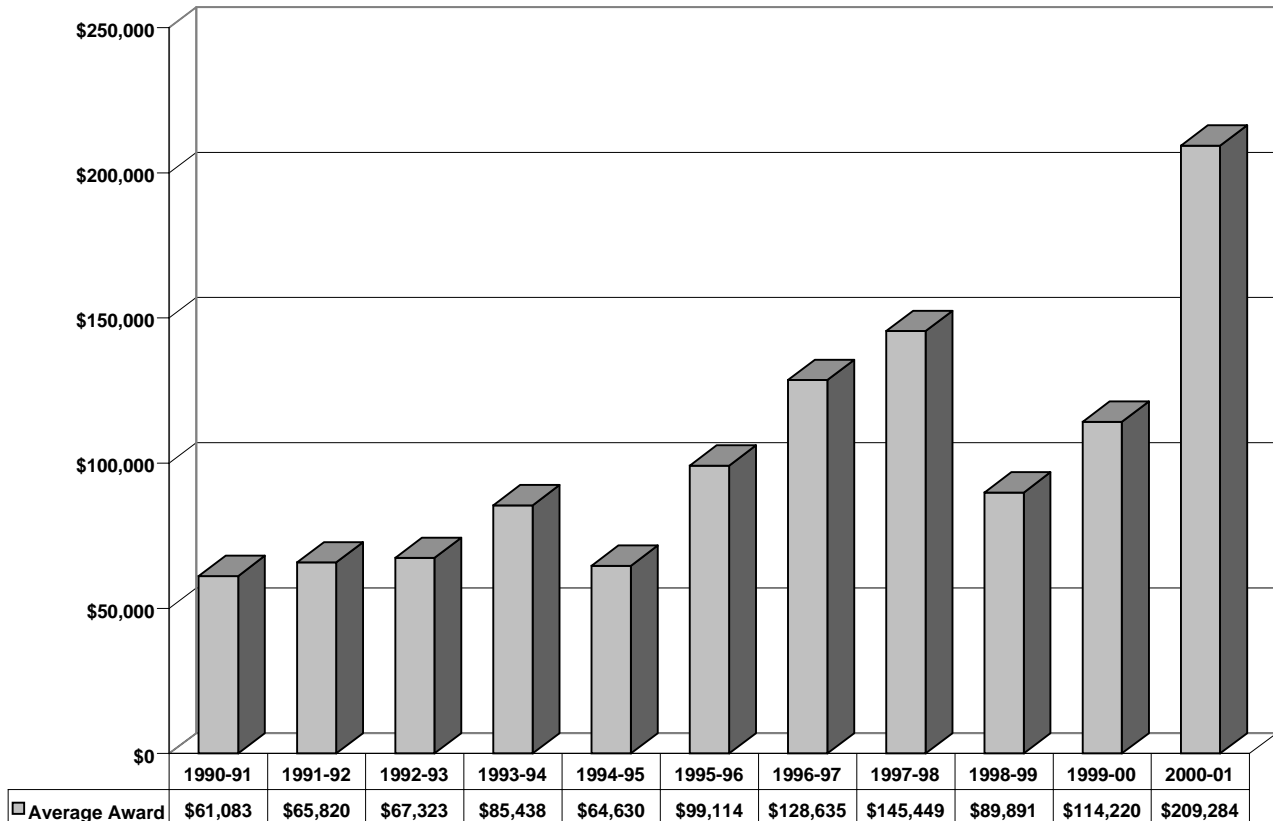
Damages and Torts Cases Disposed Statewide Fiscal Years 1990-91 Through 2000-01
