



Total = 270





Total number of individual children for ALL referrals disposed by juvenile courts during CY 2008 equals 217

Children can have referrals in multiple categories. The drawing above shows that in the year 2008 there were 199 referrals to Coffee County Juvenile Court for children with only delinquent offenses, 47 for those with only status/unruly behavior, and 0 for children with neglect, dependent or abuse referrals during the calendar year. There were 24 referrals for children that had a delinquent AND a status/unruly referral. There were 0 referrals for children with both delinquent behavior AND a neglect, dependent or abuse allegation. There were 0 referrals for children that had both a status/unruly referral AND a neglect, dependent or abuse allegation. Also, there were 0 referrals for children that had a delinquent referral, a status/unruly referral AND a neglect, dependent or abuse allegation.

Referrals by Type of Offense in CY 2008

















Children Referred for Carrying Weapons on School Property for CY 2008 Total Children = 217






