





Children can have referrals in multiple categories. The drawing above shows that in the year 2008 there were 1,294 referrals to Johnson City Juvenile Court for children with only delinquent offenses, 52 for those with only status/unruly behavior, and 123 for children with neglect, dependent or abuse referrals during the calendar year. There were 35 referrals for children that had a delinquent AND a status/unruly referral. There were 3 referrals for children with both delinquent behavior AND a neglect, dependent or abuse allegation. There were 1 referrals for children that had a delinquent referral for children that had both a status/unruly referral AND a neglect, dependent or abuse allegation. Also, there were 1 referrals for children that had a delinquent referral, a status/unruly referral AND a neglect, dependent or abuse allegation.

Referrals by Type of Offense in CY 2008










Children Referred by Age Group, Race and Sex for CY 2008






Total Children Referred for Unlawfully Carrying/Possessing Weapons






