Children can have referrals in multiple categories. The drawing above shows that in the year 2008 there were 125 referrals to Lewis County Juvenile Court for children with only delinquent offenses, 45 for those with only status/unruly behavior, and 26 for children with neglect, dependent or abuse referrals during the calendar year. There were 14 referrals for children that had a delinquent AND a status/unruly referral. There were 6 referrals for children with both delinquent behavior AND a neglect, dependent or abuse allegation. There were 0 referrals for children that had both a status/unruly referral AND a neglect, dependent or abuse allegation. Also, there were 2 referrals for children that had a delinquent referral, a status/unruly referral AND a neglect, dependent or abuse allegation.
