



Total = 455





Total number of individual children for ALL referrals disposed by juvenile courts during CY 2008 equals 360

Children can have referrals in multiple categories. The drawing above shows that in the year 2008 there were 164 referrals to Roane County Juvenile Court for children with only delinquent offenses, 231 for those with only status/unruly behavior, and 3 for children with neglect, dependent or abuse referrals during the calendar year. There were 56 referrals for children that had a delinquent AND a status/unruly referral. There were 1 referrals for children with both delinquent behavior AND a neglect, dependent or abuse allegation. There were 0 referrals for children that had both a status/unruly referral AND a neglect, dependent or abuse allegation. Also, there were 0 referrals for children that had a delinquent referral, a status/unruly referral AND a neglect, dependent or abuse allegation.

### Referrals by Type of Offense in CY 2008
















#### **Total Children Referred for Unlawfully Carrying/Possessing Weapons**







#### **Total Children Transferred to Adult Court**




