6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

As an Administrative Judge, I do not currently practice law. While not exhaustive, the following information explains the types of cases and legal issues that I preside over in a given year.

As a central panel of Administrative Judges, we hear approximately 300 different case types for more than 70 State of Tennessee governmental agencies, as well as approximately 5-10 local municipalities and state universities. Case types over which I preside include, but are not limited to, the following:

Health Law, Quasi-Criminal (Asset Forfeiture), Labor/Employment, Abuse Registry, Property, Environmental, Education, Financial Institutions, Elections, Benefits/Retirement, Licensing Actions for all Professional Licenses in the State of TN (e.g., Health-Related Boards, Boards and Commissions of Commerce and Insurance, and Board of Appeals for Tennessee state preferred service employees).

Of these case types, if they proceed to trial, approximately 80% are bench trials and 20% are cases in which I sit with a Board, Commission, or Agency, very similar to the way in which a trial court judge sits with a jury.

I author written dispositive opinions in approximately 80% of all case types. I also issue written decisions on all types of motions including but not limited to the following:

- Motion for Protective Order
- Motion to Compel Depositions, Expert Disclosures, Responses to Interrogatories and Productions of Documents
- Motion to Deem Facts Admitted
- Motion to Approve Service of Process
- Motion to Dismiss based on standing, summary judgement, failure to state a claim, and mootness
- Motion to Quash
- Motion in Limine
- Petition for Reconsideration or Motion to Alter or Amend
- Motion for Interlocutory Appeal

Approximately 65% of the cases over which I preside are civil and 35% are quasi-criminal.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

My decisions are appealable to many different forums, including the following:

Directly to United States Federal District Court; Tennessee Trial Courts; or State Boards and Commissions, Commissioners, or Agency Designees.

As a practicing attorney, I appeared in trial courts throughout the State. I worked alongside the Tennessee Attorney General's Office on any cases that were appealed to the Tennessee Court of Appeals. I also practiced in front of numerous administrative bodies and tribunals, including State Administrative Judges, The Tennessee Board of Appeals, and Federal District Court. During my years as a practicing attorney, I primarily practiced in the following areas: Employment Law, Property Law, Health Law, Fraud and Abuse, and Administrative Law. My years of practice included drafting and arguing all types of motions and pleadings (see general list at paragraph 6) from the inception of the hearing process through any potential appeal.

As listed below, I am a certified Rule 31 Mediator. While many case types can be referred to mediation, I most often conduct mediations in the areas of education, employment discrimination, and human rights.

I regularly sit as an Administrative Judge with various Boards, Commissions, or Agencies. In this role, I charge the decision-making entity (primarily through pattern instructions), hold prehearing conferences regarding special instructions, and address matters of confidentiality via protective orders or filings ordered to be placed under seal. Such experience mirrors my would-be responsibilities as it relates to jury trials.

I am required to have knowledge of an extensive array of procedural rules and requirements. In addition to the Tennessee Rules of Civil Procedure and Evidence, many of my hearings are also conducted under the Uniform Administrative Procedures Act, and its implementing regulations - the Uniform Rules of Procedure for Hearing Contested Cases Before State Administrative Agencies.

In addition, each Agency or municipality may have its own set of rules. Therefore, I often must adapt and adjust to numerous, differing rules/requirements on a daily basis.

ESSAYS/PERSONAL STATEMENTS

28. What are your reasons for seeking this position? (150 words or less)

Judges are asked to do far more than simply decide the outcome of a case. Every litigant stands before a judge because a wrong has allegedly occurred that cannot otherwise be resolved. For some, especially those who represent themselves, a judge may be the only person the litigant feels "heard" them in a system that can sometimes leave more questions than answers at the close of legal proceedings. I seek this position to ensure that the laws enacted by the legislature are followed. I have a decade of experience with litigants, attorneys, families, and court staff. In a system that is adversarial by its nature, my experience has helped me develop a temperament that treats each person with equal value, regardless of the outcome of their case. I want to serve the citizens of Sumner County as a judge that follows the law while treating people with dignity and respect.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

The substantial growth in Sumner County has necessitated the creation of this judgeship. If appointed, I will become one of three Circuit Court judges in Sumner County. Since it is a court of general jurisdiction, I will hear both civil and criminal matters. This also includes appeals from Juvenile and General Sessions courts. My selection would provide an immediate benefit to the other two circuit court dockets because I am already prepared to begin presiding over hearings of all types. There are very few case types, including certain cases involving criminal law, with which I have not had some level of experience from having presided over trials involving a wide array of legal issues and situations over the last decade. I also desire to be a welcome addition to the other courts and staff by being someone who is technologically savvy, humble, agreeable, and kind.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Without public trust in the law and its enforcement, societies do not persevere. One of the main reasons our country has been able to thrive has been the separation of powers between the three branches of government. A judge's responsibility is to maintain a position of impartiality and to enforce the law as written. My primary goal will be to follow the laws as written by the legislature, regardless of the outcome. There have been numerous occasions over my ten years of judicial experience that I have had to impact someone's livelihood, property, professional license, or benefits. At times, a litigant is genuinely apologetic and desires to make amends for a particular wrong. Some of the litigants that come before me were placed in difficult situations and reacted in ways that many people would find understandable. However, I often must rule against these litigants because they did not follow a law, rule, or procedure.

I have also presided over matters garnering media attention. In one instance, I presided over an election finance matter in which following the law meant that I would rule and impose significant attorneys' fees against a state commission. My chief responsibility as a judge is to ensure the laws or rules are followed, not to interpret those laws in such a way that would allow for a different outcome. I trust that the legislature will change laws as needed. I will impartially apply and enforce the law as written.
