6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

I am an Assistant District Attorney for the 22nd Judicial District. I was hired for this position in 2018. At that time, I was assigned to Giles County, Tennessee. In Giles County, I worked in Circuit Court, General Sessions Court, and Juvenile Court. In 2022, I moved from Giles County to Lawrence County, my home county. While I primarily work in one county, I cover court for other prosecutors when they are off work or need a *pro tem* prosecutor.

I am currently assigned to Circuit Court and General Sessions Court. I am responsible for prosecuting Circuit Court cases, which includes primarily felonies and some misdemeanors, from indictment through plea or trial. I also handle all types of criminal cases in General Sessions Court. On any given day, I could handle anything from a speeding ticket to a first degree murder. My responsibilities include meeting with victims to determine their wants and needs and to explain the legal process and potential outcomes for their case. I also meet with pro se defendants to convey offers, explain their rights to them, and if they choose, hear their side of the case. In each situation, I analyze the facts of the case and determine whether they fit the applicable statute and how the sentencing statutes will apply.

I am also a member of the Child Protective Investigation Team and the Vulnerable Adult Protective Investigation Team. I also regularly meet with law enforcement to discuss investigations and to review search warrants to determine whether probable cause has been established.

The vast majority of my current practice is criminal; however, there are civil issues that affect my practice such as orders of protection, HMVO, implied consent, and restitution.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

During law school, I was an extern for Justice Janice Holder. During that time, I was responsible for reviewing, editing, and bluebooking opinions of the Tennessee Supreme Court, including worker's compensation cases. I also received permission for supervised practice in the summer of 2012 as a 3L. That summer I interned at the 22nd Judicial District Attorney's Office. I worked primarily in General Sessions Court handling misdemeanors.

Upon graduating from law school in 2013, I clerked for Justice Roger A. Page. At that time, Justice Page was on the Tennessee Court of Criminal Appeals. I was responsible for drafting opinions, editing other clerk's opinions, and checking for bluebooking accuracy. I also attended numerous appellate arguments. While I was clerking for Justice Page, he moved from the Court of Criminal Appeals to the Tennessee Supreme Court. At the Supreme Court level, I drafted opinions, edited opinions, drafted bluebooking memorandums, and organized Rule 11 petitions

and memorandums. I also assisted Justice Page in preparing for public speaking engagements.

In 2017, I went into private practice at Pentecost, Glenn, Mauldin, and York. In private practice, I worked predominately in Federal Court in the Middle and Western Districts doing civil rights defense pursuant to 42 U.S.C. § 1983 and in State Court in numerous counties in West Tennessee doing tort law defense under the Government Tort Liability Act, see Tennessee Code Annotated section 29-20-101 et. seq. I also represented businesses in eviction proceedings and individuals in land disputes. In addition, I did research and document review for a Federal criminal defense case and drafted an amicus curiae brief to the United States Supreme Court. I also represented an individual in the Tennessee Claims Commission and filed responses to the Equal Employment Opportunity Commission in response to charges against clients.

Since becoming a prosecutor in 2018, I have tried multiple jury trials; argued numerous motions, including motions to dismiss and motions to suppress; participated in an abundant number of preliminary hearings; and handled several juvenile transfer hearings, detention hearings, and a juvenile appeal.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

State v. Kilburn, No. 50CC1-2020-CR-36288 (2023). I was one of two prosecutors on this first-degree murder case. The Defendant was convicted as charged at trial and sentenced to life in prison.

State v. Wise, No. 50CC1-2022-CR-37106 (2023). I was one of two prosecutors on this second-degree murder case. The Defendant was convicted as charged at trial and sentenced to eighteen years to serve at a sentencing hearing.

Brief Amicus Curiae on Behalf of C. Ferguson, W.D. Massey and J. Ozment in Support of Petitioner, *John R. Turner v. United States*, 2018 WL 4043315 (2018) (No. 18-106). Jon York and I drafted this amicus curiae brief to the United States Supreme Court while I was in private practice at Pentecost, Glenn, Mauldin, and York.

The traits of knowledge, fairness, stability, hard work, and kindness are things that I have found very important as a lawyer. These are things that I try to portray in my daily practice as a prosecutor. These same traits are important in our judiciary. I love to learn and research the law. My duty as a prosecutor is to look at the law and the facts and make my choices fairly based on those two things. I also try to be even tempered and kind as I interact with victims, defendants, other lawyers, and judges. I believe that the love of knowledge, the ability to decide things fairly and impartially, and a calm disposition would assist me if I were selected to serve our district as a Circuit Court Judge.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

I am seeking appointment to a judicial vacancy in the 22nd Judicial District. It is comprised of Maury, Lawrence, Giles, and Wayne Counties. This district currently has five circuit court judges. In this district, I have practiced in front of Hon. David Allen, Hon. Caleb Bayless, Hon. Stella L. Hargrove, Hon. Julie C. Heffington, Hon. Robert L. Jones, Hon. J. Russell Parkes, and Hon. Christopher V. Sockwell. Because there is not a designated Chancellor, the Circuit Court Judges in this district decide both civil and criminal matters. However, the majority of their case load is criminal. If I am selected, I would impact the court by having a strong criminal background from my experience at the Tennessee Court of Criminal Appeals and at the District Attorney's Office. I also have experience in many varied civil areas from working at the Tennessee Supreme Court and at Pentecost, Glenn, Mauldin, and York.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Yes. I believe that this is one of the most fundamental roles of a Judge. As an Assistant District Attorney, I am often called upon to analyze the law and facts and make charging decisions. Frequently I am required to tell officers or victims that I cannot proceed with charges or cannot give them what they are asking for regarding sentencing. For example, a couple of times while I have been a prosecutor, I have been faced with traffic accidents in which there were catastrophic injuries to an innocent party. While I personally felt like there should be charges that would allow for harsher punishment in those circumstances, an analysis of the law did not support more than misdemeanor traffic charges. These are the types of decisions that I am

required to make daily as a prosecutor.
