

INTRODUCTION

Tennessee Code Annotated section 17-4-301 et seq. charges the Trial Court Vacancy Commission with assisting the Governor and the People of Tennessee in finding and appointing the best qualified candidates for judicial offices in this State. Please consider the Commission's responsibility in answering the questions in this application questionnaire. For example, when a question asks you to "describe" certain things, please provide a description that contains relevant information about the subject of the question and, especially, that contains detailed information that demonstrates that you are qualified for the judicial office you seek. In order to properly evaluate your application, the Commission needs information about the range of your experience, the depth and breadth of your legal knowledge, and your personal traits such as integrity, fairness, and work habits.

Upon graduation from law school, I started as a solo practitioner with Johnson and Noe in Ashland City in 1994 until the death of James Johnson. I then joined what is now the Law offices of Balthrop, Perry, and Noe, PLLC in Ashland City in 1997. I am a partner in the firm along with two other attorneys. Being in a small town, I have practiced numerous types of law, including personal injury, probate, domestic, juvenile, criminal, bankruptcy, municipal, civil, employment, appellate, some corporate and real estate. I am a title insurance agent as well with Old Republic National Title Insurance Company, in which capacity I issue title insurance policies and perform real estate closings. I obtained a mediator's license for domestic cases in 2012. Since 1997, I have been the city attorney for the Town of Ashland City. I additionally represent the Town of Pleasant View. I previously represented the Town of Kingston Springs. In practicing municipal work, I have gained experience of the law, including, but not limited to, employment law, contract law, and environmental law. Through such work, I have proficiency in dealing with state agencies and in representation of a governing board versus an individual client.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

Currently, my practice is comprised of the following practice areas: probate, domestic, municipal, real estate, general civil, and criminal. The percentages are generally: municipal – 35%; domestic – 30%; probate – 15%; real estate – 10%; general civil – 5%; criminal – 5%.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

My practice has been primarily in the courts in the 23rd Judicial District including Chancery, Circuit, General Sessions, and Juvenile Court. I have also practiced in Robertson County, Montgomery County and Davidson County. I have done appellate work in the Middle District Court of Tennessee. Early in my legal career, I practiced in the Bankruptcy Court, Middle TN District. I have some limited experience in Federal Court. I have also worked with the regulatory offices with Tennessee Department of Transportation and Tennessee Department of Environment Conservation. With representing municipalities, I have experience advising with the Boards of Mayor and Councilmen, Planning Commissions and Board of Zoning Appeals.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

I just had a ruling from the Court of Appeals in the case of Hidden Lakes Resorts Homeowners Association v. Charles Moore et al, Docket 2022-01323-COA-R3-CV, which was a very interesting case with a multitude of complex legal issues from planning and zoning, building

permits, bonds, homeowners' association, real estate law issues, including foreclosure, and developers' responsibilities. This matter took 8 days to try in which the trial record and exhibits consisted of numerous volumes. I represented the Town of Ashland City which was brought in as a third-party defendant. The case had some issues of first impression for the Court to review.

Of other interest, I have had the experience as the City Attorney and Ethics Officer of the Town of Ashland City handling the criminal indictment of the Mayor for the Town of Ashland City after an investigation by the State. I also worked with our District Attorney on a possible ouster suit. This presented issues similar to representing a corporate board in which one member was accused of criminal behavior and the ethical dilemmas that went with the representation of an entire board.

9. Describe any other legal experience, not stated above, that you would like to bring to the attention of the Commission.

Although it is not legal experience, I did work for the State of Tennessee Department of Children Services for four years while in law school, investigating child abuse cases. This experience was enlightening, giving me a different perspective and insight for both criminal trials for child abuse cases as well as identifying and addressing abuse issues in domestic cases.

I have not submitted any applications.

I majored in Criminal Justice and Psychology with a minor in Political Science. Middle Tennessee State University offered a program in which you were able to start taking graduate courses prior to actually graduating with an undergraduate degree. I did this program my last year from 1989 to 1990. The masters program was in criminal justice. I did not complete my masters degree due to starting at Nashville School of Law in August of 1990. I graduated from Nashville School of Law in 1994 with a Doctor of Jurisprudence. I passed the bar exam in 1994.

I am a member of the Tennessee Bar Association, where I have served on the House of Delegates for the 23rd Judicial District since 2015. I am also on the Local Government Practice Section Committee with the Tennessee Bar Association previously having served as chair of the Committee. The Committee is responsible for planning our yearly continuing legal education. I am a member of the Cheatham County Bar Association where I served as president for many years. I am a member of Tennessee Municipal Attorney's Association, in which I have held various leadership roles throughout the last twenty- five years, including president.

My law firm has received recognition and been voted locally as the Best Law Firm and or as the Finalist since 2018 including 2024 in the Main Street Awards of the Cheatham County Exchange newspaper. My firm has also received recognition and voted as the Best Real Estate Title Company and or as the Finalist since 2018 including 2024 in the Main Street Awards of the Cheatham County Exchange newspaper.

I have been appointed as the City Attorney for the Town of Ashland City since 1997 and since 2019 for the Town of Pleasant View. I was also appointed by the Town of Kingston Springs as Co-City Attorney with my law partner from 2015 to 2023.

ESSAYS/PERSONAL STATEMENTS

28. What are your reasons for seeking this position? (150 words or less)

I am seeking this position because I feel that I have a diversified legal background that is essential to this position. This experience of thirty years allows me to bring to the bench the knowledge of the law along with the desire to serve the judicial district and its residents by applying that experience and knowledge to fairly and efficiently discern facts and make rulings in cases before me.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

The addition of this new fourth judicial position will help alleviate the current backlog of cases for the five-county district and bring prompt justice to litigants. Currently, we do not have a Judge that resides in Cheatham County. As a lifelong Cheatham County resident, I believe my appointment would provide a better balance of judicial representation for the district. Further, as my practice has been primarily in our judicial district for thirty years practicing domestic, criminal, civil, probate, municipal, and real estate cases, I am uniquely qualified to hear the myriad of case types that our judicial district has and am familiar with the structure of the courts and clerk systems in each county.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

I will uphold the law even if I do not personally agree with a statute or rule. As an example related to this, pursuant to TCA 36-6-106 (a)(13), is the Court's discretion to give the reasonable preference of a child if twelve years of age or older in custody matters. I have experienced numerous cases where the child has been pressured by one or both parents and promised material items for their testimony. I do not always believe that a thirteen-year-old is mature enough to handle the magnitude of this decision as they do not always understand persuasion, influence, or intimidation by their parent. It can also put a tremendous amount of stress on a child and the family unit. However, I have had cases where the child was mature and able to articulate a sound and valid reason why they had a preference for one parent versus the other parent. I have

accepted the statutory provision that allows for the testimony to occur.


