2010–2016, Guardian Ad Litem for the Probate Court under Judge Randy Kennedy – I handled dozens of cases in which I represented individuals facing conservatorships. I noticed there was an unserved need for those services at the time. I met with the individuals to ascertain what their wishes were, investigated the propriety of the conservatorship, interviewed physicians to determine their evaluations and recommendations, and then prepared a report with my findings and recommendations for the Court.

1994-present (minus 1998-99), Indigent defense throughout the years – As part of my commitment to offering pro bono services, I have continued to accept indigent appointments throughout my career. This work has been some of the most challenging, but I have felt this representation was important for the facilitation of justice in Tennessee.

1994-present, I have represented doctors, dentists, nurses, and other healthcare providers who suffer from mental health issues and/or substance use disorders. This representation is often comprehensive due to their diagnoses and ranges from criminal work to health care licensing boards (such as TNPAP, the Tennessee Professional Assistance Program, Tennessee Medical Foundation Caduceus Program, and Tennessee Dentistry Peer Assistance Program) for licensing issues and proceedings through civil litigation, including malpractice and divorce proceedings. I often offer discounts if the client maintains mental health protocols and sobriety.

1996-1998, Proctor for the Tennessee Bar Exam I was employed by the Tennessee Board of Law Examiners to conduct the Tennessee Bar Exam.

2010-2011, I was contracted as an attorney by Tennessee Department of Health for the pending TennCare litigation regarding TennCare termination of benefits and the appeal process instituted. As part of my contract, I was on the panel to draft the policies and procedures for appeal acceptance and to review the ongoing appeals for conformity with the polices and procedures we established ensuring compliance the Orders of the United States District Court for the Middle District of Tennessee.

Since moving to Cheatham County, my practice has evolved into a general practice. Conveniently located right across the street from the courthouse, my office often receives visits from individuals looking to discuss ongoing difficulties and plan accordingly. As such, I've recently had the privilege to assist clients with a myriad of legal issues, including estate planning, probate, real estate transactions, criminal matters, domestic issues, and business litigation/creditors' rights cases. Currently, my practice is evenly divided with estate work (from planning, through probate conclusion), criminal defense work (including cases ranging from driving violations to first degree murder), and civil litigation (including domestic in this category) each taking up about a third of my practice and time.

The biggest privilege of my career has been my practice in Cheatham County. The small-town atmosphere has allowed me to provide not only immediate legal assistance at the time of an impending problem, but to help prepare individuals for legal issues which may affect their lives and then ultimately guide them through those events.

 Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

I was admitted to practice law in the United States District Court for Middle Tennessee in 1994, the same year I was licensed in Tennessee. Since that time, I have represented plaintiffs and defendants before that court in both civil matters and as a second panel attorney in criminal matters.

I have also appeared in the United States Bankruptcy Court for the Middle District of Tennessee – representing both creditors and debtors.

I have appeared in several Circuit Courts throughout Tennessee, representing both plaintiffs and defendants in civil cases and serving as both prosecutor and defense counsel in criminal cases. Recently, I began focusing my practice on Cheatham County and the surrounding areas. For instance, I take appointments in criminal cases in Dickson County due to a severe shortage of criminal defense attorneys there. Currently, I have open civil cases in Humphreys, Dickson, and Cheatham County.

My Chancery Court experience has primarily been in Davidson County and Cheatham County. In Davidson County, I historically appeared as guardian ad litem and handled probate work. In Cheatham County, I currently maintain a general practice in Chancery Court with cases covering divorces, civil litigation, and conservatorship.

I have appeared in General Sessions Courts in almost every Tennessee county from Savannah

to Tazewell and everywhere in between for plaintiffs and defendants in both Civil and Criminal Courts. I have also handled cases in juvenile courts in several counties, including, Davidson, Cheatham, Montgomery, and Sumner County, to list just a few.

Further, I have appeared before the Social Security Board, the Internal Revenue Service Tax Appeal Board, the Victim Impact Fund (now known as the Criminal Injures Compensation Fund), numerous Professional Boards, the Tennessee Court of Criminal Appeals, the Board of Education for Metro Nashville, the Nashville Board of Human Resources for Employees, and various Administrative Courts.

 Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

One of my most impactful representations was assisting clients after the Nashville flood in 2010. One aspect of this representation revolved around the United States Internal Revenue Service Tax Appeal process. I represented property owners impacted by the 2010 flood. The flooding happened right after a new property assessment was conducted by the Property Assessor of Nashville and Davidson County. The damages and new property values affected the tax basis for the property owners. We were successful with the Internal Revenue Service appeal providing significant relief for the property owners. I also collaborated with the Davidson County Codes Commission as well as the Nashville Fire Marshal's Office to modify rebuilding provisions and procedures, thus positively impacting property values and providing broader assistance to flood victims in the Bellevue area.

Another significant issue I addressed due to the Nashville Flood pf 2010 was applying for and securing federal relief and resolving structural issues within several Homeowners Associations in River Plantation to qualify for federal funding. We successfully obtained Federal Emergency Management Agency (FEMA) relief for the affected properties and restructured the legal entities to prevent future challenges.

Recently in Dickson County Criminal Court I was appointed to represent a woman who was charged to compel her to testify against her husband for child abuse. This case had been pending for 6 years before I became involved, and the series of events led one of the children to commit suicide. I was able to get the case dismissed against my client, the abuser to face his consequences and since that time, I have been working to help the mother and children heal and move forward. This case is a strong motivator to apply for this Judicial position. The consequences of an overburdened court system with lengthy delays and other legal issues vividly point out the need for timely court rulings.

Recent representations of special note involve local businesses and their challenges conform with changing marketplace and legislation in the 23<sup>rd</sup> Judicial District.

A local towing company was challenged for compliance with Tennessee Statutes. This business

had operated with standard procedures wherein the fees, while not disputed, were challenged on technicalities of Tennessee Statute. I was able to recover the amounts due and updated their policies and procedures to strictly comply with the statute.

Another case involved a local car repair shop and a new entity in Tennessee that facilitates peerto-peer car rentals. When a rented car was wrecked, the repair shop bill was disputed due to the complexities of this new legal arrangement, particularly when the car was financed by the first individual and insured under the rental plan, which rental was in violation of the original financing and insurance. The statutes governing repair bill payments were unclear. I successfully recovered the repair bill for my client and investigated this new entity's operational quirks, helping the company avoid similar difficulties in the future.

Recently, upon the formation I was called upon by the Art League of Cheatham County to structure our program to supply for the needs of the Foster Children in Department of Children's Services custody while maintaining our bylaws to comply with our 501(c)(3) status and legally conform to our mission.

These cases highlight the need of local, established businesses needing assistance in navigating the changing landscape of the law. The businesses are second and third generation owners that previously dealt with local, known individuals, but now have a broader marketplace with new customers which opens the door to more complex legal requirements to operate.

 Describe any other legal experience, not stated above, that you would like to bring to the attention of the Commission.

Throughout the years, I have provided much legal assistance for recovery homes such as YANA (you are never alone), Renewal House, and the individuals therein to get back on track – this work has been mostly pro bono.

I have collaborated with TLAP (Tennessee Lawyers Assistance Program) on several programs, as well as being a mentor for persons under contract with them. We established the "Healthy Bar" to provide the first Continuing Legal Education Credits for mental health and well-being courses.

I provided legal advice and services in the start of the Bell Garden (a 501(c)(3). served as Board Member for the initial start. Bell Garden is a hands-on classroom in the garden located behind Bellevue Middle School. The Bell Garden was the dream of former Councilman Charlie Tygard. The idea was to incorporate learning through the garden (from science, math, etc.) The program is still ongoing, and I was privileged to assist in its formation which was done in conjunction

I have been reported several times to the Tennessee Board of Professional Responsibility over my thirty-year career, all without merit, and all were dismissed. My disciplinary history is unblemished.

I was reported to the TNBPR in 2012, but it was dismissed. A disgruntled opposing party in a custody dispute wherein I was a party, reported me for failing to report my attorney for saying something about him he did not like in a deposition. His report of both me and my attorney were dismissed.

In 2003 to the TNBPR a report was dismissed. This was a criminal defense case.

In 2001, to the TNBPR a report was dismissed regarding someone I never represented.

I was reported to the TNBPR three times in 2000 – all were dismissed and stemmed from my work with indigent parties and/or my work at the District Attorney's Office– I was reported for not continuing representation of an indigent person in a related civil matter as she was requesting me to present what I knew to be perjured testimony. Another report was filed by a client stating I was a "good lawyer", but I did not return documents; however, he had signed a release when he picked them up from my office. Throughout the case I had to compartmentalize my feelings. Your mind wants to go to the ramifications of any result, but I understood that these notions were inappropriate for the appointed counsel position I had accepted. I had to trust the process and legal system and zealously defend my client.

While I believe that it is our profession's calling to help those in need, the judiciary's goal should always be to follow the law as written.

I will uphold the law even if I disagree with the substance of the law at issue. As a judge, my primary responsibility would be to apply the law impartially, based on established legal principles and precedents. Personal opinions or disagreements with the substance of the law must not influence judicial decisions. Upholding the rule of law and maintaining judicial integrity are paramount to ensuring a fair and just legal system.
